We are making progress toward completion of the KAHZ(AM), KAZN(AM) and KMRB(AM) renewal of license applications and EEO Program Report. Now it is time to prepare to broadcast the renewal **post-filing** announcements. Beginning **August 1, 2013**, the text of the announcement that each Station referred to above has been airing concerning its renewal of license application will change.

Attached to this message are Certifications that include the post-filing announcement for each Station. **You must broadcast these post-filing announcements *once a day* as follows:**

Thursday, August 1st - between 7:00 a.m. and 9:00 a.m.;

Friday, August 16th - between 7:00 a.m. and 9:00 a.m.;

Sunday, September 1st - between 7:00 a.m. and 9:00 a.m.;

Monday, September 16th - between Noon and 4:00 p.m.;

Tuesday, October 1st - between 9:00 a.m. and Noon;

Wednesday, October 16th - between 7:00 p.m. and Midnight.

Kindly record the times that the post-filing announcements were broadcast on the attached Certifications and sign and date the Certifications. The Rules also require that you place a statement in each public inspection file **by Wednesday, October 23rd**, certifying compliance with the public announcement requirement. Again, the signed and dated Certification is proof of compliance. Remember to forward a copy of each completed Certification to us and place each original in the appropriate public file.
