("GBI"), Broadcast Technical Consultants, has been retained by Perry Broadcasting of Augusta, licensee of AM radio station WTHB, 1550 kHz, Augusta, Georgia, to determine WTHB's compliance with the §73.44 of the Federal Communications Commission's rules regarding bandwidth occupation measurements. The measurements were conducted on WTHB by GBI on October 3, 2015.


In performing these measurements a Hewlett Packard E4401B swept-frequency RF spectrum analyzer (Serial #US39240250) was employed. A special use shielded loop antenna was used to sample the station signal. A site reasonably clear of interfering signals was selected for the measurements. The measurements were made over a 10 minute period, at 20 kHz/division bandwidth spans, 300 Hz resolution bandwidth, no video filtering, at 1550 kHz center frequency. The spectrum analyzer was operated in the peak hold mode during these measurements. The results of the measurements were plotted and are included with this report. It is felt that WTHB complies with the provisions of §73.44 as demonstrated herein.
