Dear KRI staff:

This is in reference to the request filed on January 27, 2020. KRI requests a further extension of the STA granted on October 6, 2003, to operate with parameters at variance pending the filing of an FCC Form 302 application due to pattern distortion caused by frequent detuning equipment changes on nearby towers.¹ In support of the request, KRI states that additional time is needed to develop an agreement with all nearby tower owners to address any future modifications.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of the STA IS HEREBY GRANTED, and KRI may continue to operate with DA parameters at variance from licensed values (and/or reduced

power if needed) to maintain monitor points within licensed limits. KRI must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. KRI must submit an e-mail to my attention to certify the date the station resume licensed operations per BZ-20051012ADK with negligible change (or to note the date an FCC Form 302 application was Filed to update all operating parameters).

This authority expires on **August 17, 2020**.
