#### BATTLING CANCER

Cancer has become so prevalent that most people are impacted by the disease whether they are a direct victim or suffer indirectly. Oftentimes, the best support personnel and advisors are people who have experienced the disease or have acted as caregivers.

In her book, <u>Cancer Mom</u>, Susan Parris chronicles her amazing journey through an incredibly tough battle with a very aggressive type of cancer. In the interview, Susan told of her experiences that could be likened to a rollercoaster ride with great victories and discouraging setbacks including several costly misdiagnoses. Various types of cancer and treatments were mentioned.

The account was very personal. Susan is the mother of two boys. Briggs and Glenn were only five and three when the ordeal began. They are sixteen and fourteen today. The book was written, largely, as a means to document all the difficulties the family went through and, yet, show how blessed they were in spite of the trials. Many aspects of the journey in the book are printed pages from a journal she kept as she was suffering through her cancer treatments.

Susan is, also, a pastor's wife and works as a vice president and director of marketing for a local bank with numerous branches. The encouragement and interactions she had with her church family at Vansant Baptist and the support she received from her coworkers at TruPoint Bank were a very touching part of her story. This occurred though neither Susan nor her husband, Stan, are from the area.

Some important advice about the need for patient advocacy and some specific things to note and to avoid were included. Susan's husband, Stan Parris, wrote a short but very useful chapter in the book regarding the role of the caregiver and what is and is not helpful to the patient. The key points from this chapter were discussed in the interview.

Intertwined throughout Susan's account of her journey were the "utterly amazing" ways in which the Lord directed Susan in her decision-making and the many evidences of His Sovereignty. Oddly but effectively, Susan was continuously blessed by a rather remote book of the Bible – Habakkuk. Both Susan's book and her interview were inspiring and could serve as encouraging devotionals.

### PROMOTION OF LOCAL EVENTS

The promotion of local events is a primary responsibility of a local radio station. Dispersing facts about date, time, location, etc., is very helpful to both the organizers and the people wanting to attend. Generating interest and motivation for attendance is an added bonus. #### **DUAL PRIMARY ELECTION PROCEDURES & RESULTS**

There was a lot of confusion regarding the procedures for the Dual Presidential Primary that was held in Virginia on March 1, 2016. Even well-educated and current events enthusiasts were uncertain about how this election would work. Further confusion may have come from viewing caucuses in other states that met in unusual places and did not use regular election precincts. Although the idea was scrapped, some people may have been aware that our local electoral board had considered having fewer but centralized locations for voting and not opening all the normal precincts.

Additionally, the majority of people voting are interested in knowing the returns as soon as possible. Radio listeners know the returns will be reported swiftly and the local, state, and any other nationwide election news will be reported succinctly.

Using prerecorded segments from an interview with Brian Earls, Director of Elections and General Registrar for Tazewell County, the procedures for the Dual Presidential Primary were made clear to listeners. Voters had been asking questions of the Registrar's office, election officials, and the radio station regarding several aspects of the primary that they found confusing. For example, they wanted to know if the traditional precincts would be used or if they could vote anywhere countywide. Others were curious about whether or not they had to declare party affiliation. These and other questions were answered in Brian's comments, and he reminded listeners of the photo ID requirement.
