9/5/18-EVERY WATER WELL IN THE STATE WILL HAVE TO BE TESTED FOR WATER QUALITY AND POTENTIAL CONTAMINATION. THAT'S ACCORDING TO A NEW LAW BEING FLOATED BY GOVERNOR CUOMO IN ALBANY. 9/7/18-THE STATE ATTORNEY GENERAL HAS LAUNCHED AN OFFICIAL INVESTIGATION INTO SEXUAL ABUSE BY MEMBERS OF CATHOLIC CHURCH. OFFICIALS ISSUED SUBPOENAS TO EVERY DIOCESE IN THE STATE. THE INVESTIGATION IS LIKELY TO INCLUDE AT LEAST TEN CATHOLIC PRIESTS WHO SERVED IN THE UTICA AREA. THEY WERE PREVIOUSLY NAMED IN A LAWSUIT AGAINST THE SYRACUSE DIOCESE COVERING ABUSE CASES FROM THE 1950S RIGHT UP UNTIL 2014. THE ATTORNEY GENERAL'S OFFICE ALSO ESTABLISHED A HOTLINE TO REPORT ALLEGATIONS OF ABUSE AT 800-771-7755.

9/7/18-NEW YORK'S PRIMARY ELECTION IS JUST DAYS AWAY, BUT WE WON'T KNOW UNTIL THIS AFTERNOON IF THERE WILL BE A DEMOCRATIC PRIMARY FOR THE 119TH ASSEMBLY DISTRICT. ONEIDA COUNTY HAS ONE OF THE HIGHEST PROPORTIONS OF LEVEL 3 SEX OFFENDERS IN THE STATE THANKS TO THE MARCY PSYCHIATRIC CENTER.
