It also includes up-to-the minute video streaming of news stories, weather forecasts and includes special features such as Six Online Live Chat or watching live press conferences through web streaming. While stories are continually posted and eventually drop off of the top 30 or so visually displayed, they never actually leave the Web Channel Feature server making these accessible for viewers to conduct a search to retrieve each of these in the future. Video segments stay within the server approximately 1-2 weeks, as space is available.

A local animal non-profit is taking steps toward an all-inclusive environment Roice-Hurst Humane Society wants to make it easier for people to adopt pets, so they've made some changes to their system. The organization has taken a dive in their policies for pet adopters and has even looked at their hierarchy to determine where underlying bias may lie. Take a look."With everything that's going on in the world right now and sort of a louder conversation that's taking place nationwide right now about equity, inclusivity, and diversity, and race. And an organization ready to dig deeper in its policies "We—one of our values is leadership and we thought that it was really important to make a statement about what we see in the animal welfare world and what we're doing here in our own organization and locally." Roice-Hurst Humane Society is looking at ways they can remove barriers for pet owners "We had an application that at the end of the day favored affluent adopters over perfectly good homes, but that were being cast aside because of things like type of housing or the size of the yard, or whether a person worked long hours or not." Guidelines they now feel ultimately led to discrimination "Dismantling systems that were built with implicit bias and now have turned into systemic bias is a process, it's definitely not something that happens overnight and it just takes that that really critical self-reflection as an organization." Now, they provide education and resources "Our adoption process is conversationbased meaning we really get to know them as a person" for people surrendering a pet "we try to get to know them on a level where we would be comfortable with letting them adopt out one of our animals." Their goal..."We want to make sure that anybody who wants to be a pet owner can be a pet owner if they are a good, responsible, loving owner." To remove subconscious bias. The organization says they started looking at these changes five years ago. Ultimately, their hope is of course to have all their animals in loving homes.

THE VICTIM HAS BEEN FLOWN TO A GRAND JUNCTION HOSPITAL FOR SURGERY... BUT IS EXPECTED TO SURVIVE. "Colorado Parks and Wildlife used dogs to track the bear, locate it, and euthanize it this morning. They say they are as confident as they can be if was in fact, the attacking bear. DNA tests will confirm that." "You don't know if it would happen again. I think as a society we'd be remiss if we let that bear off the hook." THIS RUNNER LIVES NEARBY "I don't believe that wild animals are malicious at all. I think that they're purely looking for food. THIS IS THE FIRST BEAR ATTACK HERE THIS YEAR ... THERE WERE THREE REPORTED ATTACKS IN THIS MOUNTAIN TOWN LAST YEAR.

Colorado Parks and Wildlife and hunters alike are preparing for the upcoming hunting season.

but questions do remain in the wake of wildfires and covid-19. Parks and wildlife has seen some public land closures due to the multiple wildfires blazing across Colorado, but their biggest concern is still covid-19. "we have seen a few animals, we saw a bear on the horizon drive area that may have come in out of the fire." The Pine Gulch Fire has brought a few animals into the valley, but..."because of the nature of the way that it kind of moved north at first and has now moved west, that's tended to push animals into more remote areas which is good." the majority of animals have moved elsewhere. "for the most part, wildlife evolved in this, you know, fire-prone system here in the Western United States so the animals are a lot more used to it than we are." The fires are less devastating to wildlife than some may think, but Colorado Parks and Wildlife has experienced closures that have resulted in less land for hunters in the upcoming season. "and the Pine Gulch Fire is not only burning on about 130-thousand acres, one of the challenges that we face is that the administrative closures right now measure about 650-thousand acres, so they've closed areas to keep people out of harm's way." This will mostly affect hunters with less-populated tags for animals like big horn sheep and bears. "Really, for deer and elk hunters most of the deer and elk hunters have an option, you know, they have options for other units to hunt in, we have 23 point 5 million acres of public land in Colorado." Covid-19 has the biggest impact on the season with travel restrictions to Colorado from other states, prompting them to allow license returns. "we're continuing to be very hopeful that it will be a good hunting season economically and everybody will be able to travel and do what they need to do." Colorado Parks and Wildlife will allow returns for those who are unable to use their tags up to 15 days before the hunting season begins. They will be talking about the available land for the season with Federal Land Managers next week. Archery, muzzle loader, and bear hunting season all begin in September.

AS THE SMOKE BEGINS TO CLEAR, TAMMY TORUVILLE CAN FINALLY CATCH HER BREATH. "Oh, I just want to get them home so bad." SHE'S BEEN IN SURVIVAL MODE FOR MORE THAN A WEEK... AFTER BEING EVACUATED FROM HER SMALL FARM IN DRAKE'S CROSSING. "I grabbed my dad, our medications, and the clothes on our back and left." LUCKILY - SHE COULD GO BACK FOR THE REST OF HER FAMILY, HER ANIMALS. "You want to play with mama, you want to play?" "I didn't know if my animals would still be alive. It was horrifying." OATY AND LILLY -ALONG WITH HUNDREDS OF OTHER ANIMALS -- FOUND REFUGE HERE AT THE OREGON STATE FAIR GROUNDS - TAKEN IN WHEN THE WILDFIRES ROARED INTO THEIR PASTURES. "We just pull together." AND NOW... THEY'RE FINALLY ABLE TO GO HOME. "I mean, it hits home harder than most people know." BUT THE KINDNESS OF COMMUNITY COMES IS ALL SIZES ... WITH A LITTLE BIT OF GRIT ... IT ALSO MEANS STUDENTS LIKE CASSIDY JAGERS AND HER BROTHER CORBIN...This is my goat. His name's spot. ...WON'T GET TO SHOW OFF THEIR HARD WORK. He's a pain in the butt sometimes I was pretty sad about it, but now looking back I completely understand what they're trying to do. MAIL THEFT IS USUALLY AN ISSUE AROUND THE HOLIDAYS, BUT THIS WEEKEND, A LOCAL WOMAN SAYS HER PACKAGES WERE STOLEN...AND THE THIEVES MIGHT HAVE TAKEN MORE THAN THEY BARGAINED FOR. WE GOT A TIP THIS MORING OF A WOMAN WHO SAYS HER PACKAGES WERE STOLEN FROM HER FRONT PORCH. SHE SAYS IT'S NOT THE PACKAGES SHE'S WORRIED ABOUT, IT'S HER DAUGHTERS PASSPORT THAT MAY BE IN THERE. A PORCH PIRATE STRIKES AGAIN. THIS TIME OF THE HOME OF YESENIA ARBALLO OFF OF D & 29 1/2 ROAD "We were upstairs and I head the deter tone go off but I paid it no mind because it'll go off because of these plants moving. I was like oh! The packages. I checked the camera and see the video of the guy coming up. He knew what he was doing, picked them up and he left. I told my husband, I think someone just stole the packages off the camera. I was pretty mad and that's when I posted it on Facebook." TAKE A LOOK, THE PERPATRATOR IS COVERED HEAD TO TOE WITH GLOVES, A HAT AND A FACE MASK. IT ONLY TOOK HIM LESS THAN 20 SECONDS TO RIDE AWAY ON HIS BLUE BIKE (YESENIA) "I'm not worried about the material stuff, but I'm 99% sure one of them was my daughter's passport. SHE SAYS AFTER LOOKING AT HER PHONE, SHE REACTED QUICKLY (YESENIA) "I got in my truck and I kind of followed the way that he went but he was nowhere to be seen within two, three minutes, YESENIA CALLED THE AUTHORITIES, HER BIGGEST WORRY... HER DAUGHTER'S PRIVATE INFORMATION GETTING OUT. (YESENIA) "They sent over a few cops 15 minutes later. What can you do? They're already doing what they can. It's scary, because people use identifications to kidnap kids. Why would you want to keep someone's passport unless you're doing something else."

YESENIA AND HER FAMILY JUST MOVED FROM DALLAS TEXAS IN DECEMBER (YESENIA) "Here, we haven't had any problems. We just had to be lucky chosen ones." AND YESENIA IS TAKING ACTION (YESENIA) "When things like this happen, you have to get some sort of protection. Stop stealing. People work hard for their things." YESENIA SAYS SHE WILL FOLLOW UP WITH THE US POSTAL SERVICE TOMORROW IN HOPES TO REPLACE THE PASSPORT AND KEEP HER DAUGHTERS INFORMATION CONFIDENTIAL. YESENIA HOPES THE PERPETRATOR WILL RETURN HER DAUGHTER'S PASSPORT, IF NOT TO HER HOME, THEN TO HER PLACE OF BUSINESS.

"I didn't know it was growing, but I'm very glad the county discovered it." STILL LOTS OF QUESTIONS TONIGHT WITH A MULTI-AGENCY INVESTIGATION INTO AN ILLEGAL MARIJUANA GROW. "I don't think it was an operation that was too rampant, as far as this part of our community." M-C-S-O TOLD US THIS MORNING LOCAL AND FEDERAL LAW ENFORCEMENT OFFICIALS WOULD BE WORKING IN THE AREA OF KANNAH CREEK IN WHITEWATER...NEIGHBORS IN THAT AREA TELLING US THEY DIDN'T KNOW THERE WAS A PROBLEM TO BEGIN WITH. "I hope everyone is apprehended that needs to be, and the plants are removed to the best of their ability." WE WERE TOLD TO CONTACT THE U-S ATTORNEY'S OFFICE FOR ANY NEW INFORMATION, BUT ALL WE GOT WAS A STATEMENT, CONFIRMING WHAT THE SHERIFF'S OFFICE HAD SAID. WE WERE TOLD AN ARMY NATIONAL GUARD HELICOPTER WOULD HELP OUT TOO, BUT THE NEIGHBORS WE TALKED TO NEVER SAW ONE. "But I haven't been contacted by any of my neighbors or anything..." NO SPECIFIC LOCATION OF THE GROW HAS BEEN RELEASED. THE D-E-A AND U-S FOREST SERVICE GOT HELP FROM A NUMBER OF LOCAL, FEDERAL AND STATE AGENCIES. "For that to be that close here to us and around our home is a little unsettling." AND HOW THE WHOLE THING WAS DISCOVERED... ALSO... STILL UNKNOWN TONIGHT.... AND WE'RE ALSO TOLD THE COLORADO BUREAU OF INVESTIGATION IS INVOLVED, BUT SO FAR, NO SUSPECT INFORMATION HAS BEEN RELEASED. UNDER COLORADO LAW, RESIDENTS OVER AGE 21 CAN GROW UP TO 6 OF THEIR OWN MARIJUANA PLANTS, BUT WE'RE TOLD THIS GROW WAS MUCH LARGER. ...AND ONLY LICENSED GROWERS CAN SELL MARIJUANA PRODUCTS.

Denver Police have kept anarchist violence and damage to a minimum in recent weeks because - in all honesty there aren't that many of them. And until last Friday - DPD could focus its attention on that group. Now enter armed right wing militia members spoiling for a fight against the anarchists. After at first welcoming and thanking the militia for coming - DPD tells Steve Staeger - they don't want them around. Everybody is subject to the dispersal order that was given. But a Colorado Public Radio reporter had his audio recorder rolling near this group ...that appears to be a militia group. You can see what appear to be holstered weapons on some of them... even zip ties presumed to be used as handcuffs. Kevin's recorder caught audio of a Denver Police officer engaging them. Appreciate you coming here... and giving us support. "My reaction was right on Denver Police." Denver Public Safety Director Murphy Robinson says... there's nothing wrong with that tape. This officer was only de-escalating the situation. "He acknowledged their presence. He then asked them to demobilize and leave." And they did. "I can see how the optic can be inflaming but again I think it needs to be taken into context." Denver Police Division Chief Ron Thomas admits - there's a perception problem though - both to anti-police protesters and to the militia itself. "Do you worry though that this sends a message to that group that ... you know..."Thank you for coming out" and that they might take this as a sign that you're in support of what they were doing. Yeah. I do believe that's a problem and again that's why we would like them to stay home." They want them to stay home - because around the country - when these militias show up situations tend to become more violent. Three people across the country died last week after protesters clashed. "We don't need them to help us defend the city facilities. They're actually kind of in the way." The anarchist violence... while condemned... is relatively predictable for police. When you mix in other groups... Thomas says... that predictability goes out the window. Both Thomas and Robinson say the city's message to both sides is pretty simple. If you want to be peaceful come on down... but..."Anyone who wants to cause damage and anyone who wants to cause violence...you're not welcome here."

AND AN event THAT has caused some neighbors to be a little shaken up "I just moved here two months ago and for something to happen in my neighborhood, I'm a little worried but hopefully it will be the first and last time it happens for a while." Look Live: This is still an ongoing investigation but right now they believe it was an isolated incident and that there is no threat to the community. Fire crews are still battling a fire that started yesterday in Palisade. They still have the area blocked off, but the damage is right up the road behind me. A few what they're calling 'out buildings' and power poles were lost in the fire. 32 acres burnt "so at this time we've got about 75 percent containment on the fire" From a fire that came from I-70 and moved TO HOMES in Palisade. "there were some larger bushes and trees that were burned with this so when those smolder for a while, which can, when the wind picks up, reignite things." Among the damage is 4 outbuildings and 7 poles, so in this area we do have quite a bit of dry brush." Residents in the Rapid Creek Road area were evacuated around 5 P-M yesterday...and all but one man and his dog were able to return late last night. "So we're currently up maintaining the fire and maintaining our fire line so that is making a perimeter whether that's digging line or laying water down to protect structures." The fire shut down interstate 70 and U-S 6 for several hours. Around noon, about 35 firefighters were working at the scene. "So just be advised during this time, especially since it's getting hotter—we have less humidity—fires are very probable so please be smart. Check your chains before you go so that way they're not dragging on the interstate." Fire crews are still working to fully contain the fire. Little heat can start some big flames "putting out any spot fires so that's little areas that rekindle or ignite from embers in the area." Safety is there number one priority "It is unstable terrain up there so proceed with caution, we ask that the public do not come and access this road as we do have crews currently working." They hope to have power back up for residents by tonight. The cause of the fire is still under investigation.

"Essentially all of the peaches in Western Colorado are sold every single year for the most part." THIS YEAR, IT SEEMS LIKE THE PALISADE PEACH INDUSTRY JUST CAN'T CATCH A BREAK. THE BIG FREEZE THIS SPRING WIPED OUT HUGE AMOUNTS OF CROPS, AND THAT WAS AFTER COVID-19 GOT TO THE WESTERN SLOPE. "To have reduced supply by 80 percent...that's a big hole." JAMES SANDERS OWNS THE PALISADE PEACH SHACK, JUST OFF THE I-70 EXIT...AND SET UP THIS STAND TWO WEEKS AGO. "There's a demand that can't be met." HE'S GOT ALL THE KEYS TO SUCCESS, A GREAT LOCATION, LOTS OF CUSTOMERS, AND TASTY PEACHES, ...BUT HE'S NOT EXPECTING HUGE PROFITS. "I'm essentially guaranteed 50 percent of my volume." THAT'S BECAUSE HE HAS INSURANCE THAT COVERS UP TO HALF HIS CROPS...AND USUALLY HE CAN SELL A DECENT AMOUNT OF CHERRIES WITH THE EARLY SEASON PEACHES...BUT THIS YEAR.. "No, the cherries are a little more temperamental then the peaches in this area so they froze too." AND ANOTHER HIT TO THE PEACH BUSINESS, THE NEWS THAT THE PALISADE PEACH FESTIVAL WON'T HAPPEN THIS YEAR. "With the current mesa county guidelines, for outdoor events, it's just not feasible this year to put it on." TENS OF THOUSANDS OF PEOPLE..."It does bring in lot...around 15 to 16-thousand people a year." AND THEIR CASH, WON'T MAKE IT TO PALISADE. "The economic impact is between four and five million dollars here in Mesa County." BUT THIS DOES *NOT MEAN THE PEACHES THEMSELVES ARE GONE. "Despite the freeze this last spring, we still have peaches here in Palisade for locals that want them." AND DESPITE THE ADVERSITY, JAMES SAYS HE'S LOOKING TOWARD THE FUTURE. "We are actually standing on the foundation of the future building." The Pine Gulch Fire is significantly more contained than it has been, but people are still displaced from their homes. And the community's support for both evacuees and firefighters hasn't gone unnoticed. there have been a total of 25 households evacuated and one primary residence burned... But say they haven't seen any significant heat or activity on the eastern side of the fire for about 10 days or so, prompting the containment increase. At 1:30 in the morning "Garfield County Sheriff's office came and shown a spotlight at my house and windows." Bill knew he'd be forced to leave his home. "so I got up and there was a policeman outside my bedroom window and we talked about it and they announced that this was pre-evacuation." He was asked to be out by the next day, "winds changed and the fire moved very very fast." that's when he moved all his important belongings to an open field where he says they've been unbothered. "everything seems to be good—they did just a marvelous job of setting up a sprinkler system, they put in fire suppressant, fire retardant—flame retardant, they clean things up around the place that were fire danger." After announcing the fire's 44 percent containment, Bill is hoping to get home soon. "we know this has been a long-haul for them, we're closing in on almost a month since this fire's started." There have been 25 households evacuated, 1 primary structure burn, and 4 minor structure burns from the fire. "what we try to do is make sure that we can get boots on the ground, and do what we call cold trail, they go along the edge of the fire, make sure there are no remaining hot spots, nothing that should the wind pick up would flair up again." The fire crews check in detail to make sure an area is contained before marking it. "you know, I think it's great news, we've seen a huge jump—we've been waiting for that—we've been watching for that." Appreciation of the work done has been seen across the valley. "the firefighters really appreciate the signs they've seeing out in the community—the notes that people are being put out on Facebook. They see that and they appreciate that you appreciate what they're trying to do for you." The Mesa County Sheriff Posse has livestock space for evacuees in-need.

"If you are planning to recreate, go camping anywhere, in the state of Colorado, and you are towing a trailer, make sure that your tow chains are attached and are off the road so that they are not causing sparks," Although there are a lot of fire restrictions for safety, the lake is still expecting a very large turnout. "everything is opened, it's really our last big hoorah, we are expecting a busy weekend." The park manager told me that the state of Colorado has seen quite a few drownings this year, so making sure that everyone is safe and is wearing life jackets is a top priority, and we are also told that they will be keeping a close eye on everyone to make sure they are abiding by the fire restriction rules.

"you started hearing the stories, the deployments, boot camp stories, stuff like that and the interaction is great, they all have a common bond." Local businesses not-exempt even with Mesa County's variance. Some restaurants who didn't require people to wear masks, now having to jump on the bandwagon. But, owner of Bin 707 and Taco Party says his restaurants already required masks so this comes as no surprise. "The most important thing is the safety of our community and

our staff, if anybody in our staff gets sick it shuts us down, if it shuts us down, that's our business." Making sure people are wearing a mask until they are seated at a table, and if they don't have one, offering them one. "If it keeps people safe, then it's not a huge ask for people, and it's more important to stop the spread, so our economy can get back to normal." The Colorado Oil and gas conservation commissioners have proposed new rules that could impact the community. Yes, Colorado Oil and Gas Conservation Commissioners have proposed multiple new rules for the state of Colorado. I met with Rose Pugliese here at the courthouse to find out more about the 2000 foot setback which seems to be the most controversial rule so this morning the Colorado oil and gas conservation commission staff are making a presentation of draft rules relating to the siting of oil and gas facilities and how close they can be to where people live, work and play in the state of Colorado." 2,000 feet would be how far away the gas and oil facilities would have to be from any school, home or business. Some people are happy about it. We are supportive of the rules a we understand them to be written and we are thankful to the commissioners staff for listening to the stories and real life experiences who have lived with oil and gas development for so long." They say that having the facilities too close could have major consequences. "impacts from noise, and odors, and headaches, and noise bleeds, and folks who are more on the sensitive side of things might have medical conditions might have impacts to their breathing and respiratory systems." They believe your safety shouldn't depend on your location. "it doesn't matter if you live in rural Colorado or if you live in Broomfield. Everyone deserves the same level of protection." Not everyone is happy about this possible new rule. "Western Colorado, our access to the resource is different. Our resource is different than the front range. and because we are more of a rural area. We also don't have some of the conflicts you have in the more urban areas, and so this one size fits all doesn't work for us. " Pugliese says that it could be very bad for the city. "the access to the resource would be very different, if we can even access that resource. I mean a 2000-foot setback really is a large setback." But everyone is trying to keep the town as safe as they can. "Of course, we want clean air and clean water for our communities. I'm a mom raising my children here to, but we want to make sure we have a proper balance." The rules were proposed today at 10:30. They are not sure when they are going to hear back on them but are anticipating it will be around Tuesday of next week. both sides are very passionate, and have strong opinions about the new rules, and we will keep you updated on what is decided.

After many requests from patrons, THEY SAY they GOT a grant to help IMMIGRANTS GET A DRIVER'S LICENSE...as the library begins to get the ball rolling on their services again they are allowing people to make an appointment and go inside to receive that help. Here's what that looks like. "one thing that's great about the library" Immigrants to the United States "is that it's a safe place for anyone." And more specifically Mesa County, can now GET HELP GETTING a driver's license. "we're just really focused on getting them where they want to go." Mesa county libraries was given a three-thousand-dollar grant by the F-W-D dot U-S Education Fund, a GROUP that focuses on immigration and criminal justice reform. "we really rely on that intimate classroom environment to provide our services because it allows people to come in and make the connections they need to." The center can help with the documentation, the appointment, and translation services. "We need people that are advocates for our organizations to go out and tell their friends that maybe could use this service that we are here, that we're here to help them in any way they need." This has been a service often asked about by the people attending the center. "it's always fantastic to see when that financial barrier is removed, just how much that opens for them, being able to accomplish their goals." Senate bill 251 allows all Colorado citizens, no matter what their immigration status, eligible to apply for a state driver's license or I-D. "we never ask, that's something that doesn't qualify or disqualify them from our services." The literacy center has been helping people learn English for over 30 years. "it's always a very positive..." Last year they had 100 volunteers "and welcoming environment." and over 400 students. Some other services they offer are a G-E-D prep class and On July 14th they will have a representative offering free legal services at their citizenship clinic.

"so the reason for the screening test is not because we've had symptomatic employees or residents or that we're considered someone in our facilities are sick, the purpose of this screening is actually a safety measure" The testing will take place again THURSDAY and Friday "any of our volunteers or our third-party vendors or anyone who comes in contact with the patients inside our residential facilities are going to be offered a screening." At the willows and oaks long-term care facilities "It's really important that we do everything we can to keep those patients safe." The residential areas have been on lockdown since the pandemic hit the grand valley, "so we are allowing one care companion per patient, to help with-- especially if they have a disability." but their out-patient clinics are allowed

slightly more visitations. "a lot of us have been on this mission since March, some of us had joined in May. We've been at 60 plus sites so far." TUESDAY, Mesa County's positive cases rose by 5, totally 126 total. "we're hoping to screen over 700 people." The men and women conducting the testing, "I really appreciate my team," Aren't at it alone. "and I'm just thankful to be here." All staff at the Family Health West Facilities are required to get tested. Help in the effort also came from the Colorado Department of Public Health and the Mesa County Health Department. Though the long-term care facilities have been on lockdown, they do have special visiting areas for families. Today was an exciting day for a lot of young kids. it was the first day of school at Pomona Elementary School. I'm at Pomona Elementary School where today was their first day back in session. Students told me that they were extremely excited to be back in the classroom setting. Today was the first day of the school year for many young kids. "first day of school was amazing. we had a great kickoff to the school year. really enjoyed seeing students and having the back in the building. first time since mid-March." This year, the first day looked slightly different from years past. "We screen every student before they come into the building. We have screening stations for each grade level where we check their temperature, we do a couple of screening questions." They also had to make a few adjustments in the classrooms "<we had to make some changes with our scheduling. we worked really hard to have our students set up in cohorts." They even made changes to the lunch schedule in order to try to encourage social distancing. "we made it where we have a much longer lunch period so we have smaller groups of kids eating lunch together." The principal said that the students handled all of the new changes well. "they did a fantastic job. I think that's what is going to keep us in the building longer. if everyone is doing good mask wear." The school's theme for the year is the words, we are resilient. And the kids that are in fifth grade or above are required to wear masks every day, but fourth grade and below are just strongly encouraged to wear them.

WITH GROWING DEMAND FOR ONLINE CLASSES IN DISTRICT 51, SCHOOL BOARD MEMBERS ARE TALKING ABOUT MOVING TEACHERS AROUND TO MEET THE DEMAND. AFTER THE SCHOOL BOARD MEETING TONIGHT, D-51 TEACHERS NOW FACE THE REALITY OF HAVING TO MOVE TO A NEW SCHOOL OR ONLY TEACH ONLINE...BOARD MEMBERS SAY THERE'S A GREATER NEED FOR ONLINE LEARNING, AND TOUGH DECISIONS HAVE TO BE MADE. "We're having to shift things around because of the fewer students in an actual school" IT WAS ALREADY AN UNORTHODOX SCHOOL YEAR FOR DISTRICT 51, BUT NOW A NEW PROBLEM...AN UNPRECEDENTED DEMAND FOR ONLINE TEACHERS. (union rep) "When you do these moves, you're changing classes, and you're moving kids around as well." WITH 2700 STUDENTS ENROLLED IN ONLINE

CLASSES...DISTRICT 51 SAYS THEY NEED TO FIND AN ADDITIONAL 28 TO 30 TEACHERS TO HELP HANDLE ALL THOSE STUDENTS. "What's happening here is people are teaching different groups of kids, and they may be teaching different specialties, different courses." AT THE SCHOOL BOARD MEETING, BOARD MEMBERS SAID IT WOULD COST ABOUT 1.4 MILLION DOLLARS TO SIMPLY HIRE MORE TEACHERS TO MEET THAT NEED...MONEY THE DISTRIC T DOESN'T HAVE. THE NEXT OPTION IS TO MAKE TEACHERS MOVE TO OTHER SCHOOLS OR TEACH ONLINE. "Initial discussions will happen this week and we'll probably have the moves made very shortly after that." BUT RICK CONCEDES ITS SOMETHING THAT HAS TO HAPPEN. "A number of teachers that are completely overloaded right now with their online classes...those students aren't being served as well as they could be." D51 SAID THE RATIOS ARE SCEWED FOR MIDDLE AND HIGH SCHOOL ONLINE STUDENTS...JUST AT THE MIDDLE SCHOOL LEVEL, THERE'S ONLY 13 TEACHERS WORKING ONLINE CLASSES FOR ABOUT 750 STUDENTS. "The enrollment sizes are larger, but with the online, you can manage larger numbers because the students are doing most of the work, you are just a resource for them." ONE TEACHER ON THE SCHOOL BOARD SAYS IT MAY NOT BE AS BAD AS IT SEEMS. "Truthfully, there may only be a few teachers going from one building to another." D51 SAID THEY WILL FIRST ASK FOR VOLUNTEERS TO MOVE TO OTHER SCHOOLS OR TEACH ONLINE, BUT ITS STILL NOT CLEAR YET WHAT WILL HAPPEN IF A TEACHER IS ASKED TO MAKE A MOVE, AND THEY REFUSE. "You have a contract with the District, and the district has a need and you can fill that need, you owe them at least a solid look at it before you turn them down." THE DISTRICT ALSO SAID only about half the SCHOOLS WILL BE IMPACTED BY ALL THIS, BUT WE HAVEN'T BEEN TOLD WHICH ONES. REPORTING IN GRAND JUNCTION CURRENTLY, D51 STUDENTS CAN CHOOSE IF THEY WANT TO DO ONLINE CLASSES OR IN PERSON LEARNING...AND FOR NOW, THEY CAN CHOOSE TO SWITCH AT ANY TIME.

Grand Junction High School had some controversial posters put up in the hallways, and the school district and a local lawmaker are taking notice. Yes, controversial posters were put up around Grand Junction High School. They do not believe it was done by teachers, but District 51 and state representative Matthew Soper have both gotten involved. CONTROVERSY AT GRAND JUNCTION HIGH SCHOOL..."I hear some kids talking about it, but no faculty." SURROUNDING SOME POSTERS THAT WERE HUNG IN THE HALLS...ONE was a black lives matter poster, and THE SECOND said "the flag doesn't stand for everyone, and asked people to sit for the pledge of allegiance. " School district 51 has said that they are not sure who put up the posters but are pretty confident it was not a teacher. They were taken down within a day, telling us controversial posters like that can't be hung on school grounds. Although... District 51 does say they support freedom of speech and encourage respectful and productive discussions on controversial topics. Superintendent Diana Sirko released a statement that said, anything that is disruptive to the learning environment or sends a message of hate, regardless of the form it takes, will not be tolerated in a system that is responsible for the education of all students. State representative Matthew Soper heard that more political statements had been posted at other high schools in the district and wrote a letter to superintendent Sirko saying, by sanctioning the display of these messages on the school house wall, it possibly disparages, intimidates, and bullies students and parents who may believe differently. "I just don't really think school is the place for that. I think anybody can have their opinion but Yeah, I just don't think school is the place to share that." in his letter to Sirko... representative Soper says he's seeing similar trends in schools across the valley. Posters from ANTIFA and black panthers being just a couple he cited. SOME OF THE STUDENTS SAID THAT PICTURES OF THE POSTERS WERE ALL OVER THEIR SOCIAL MEDIA ACCOUNTS.
