While stories are continually posted and eventually drop off of the top 30 or so visually displayed, they never actually leave the Web Channel Feature server making these accessible for viewers to conduct a search to retrieve each of these in the future. Video segments stay within the server approximately 1-2 weeks, as space is available.

If you think your ballot is long... be grateful each question is summarized. Proposition 114 -- to reintroduce gray wolves in Colorado -- it's five lines long. Flip to the back of your Blue Book, you'll find the actual law that will go in the books... The wolf law is two full pages-- WITH BIG IMPACTS TO OUR SIDE OF THE STATE. Proposition 114 -- is the reintroduction and management of gray wolves in Colorado. The Gray Wolves proposal leaves some gray areas that need more explanation. A YES vote means you want the Colorado Parks and Wildlife Commission to develop a plan to reintroduce gray wolves into areas west of the Continental Divide by the end of 2023. It also means CPW would have to hold statewide hearings to develop the plan. And pay fair compensation to owners of livestock for any losses caused by gray wolves. Mary had to bug out of her home in Gold Hill over the weekend because of the Calwood Fire. But he remembered to get her ballot - and take it to the drop box at the South Boulder Rec Center. That is a seriously impressive level of dedication to democracy. A NO vote means CPW will not have to reintroduce gray wolves. Currently, the gray wolf is still considered endangered by the federal government, so any reintroduction would require federal approval...unless the animal is removed from the endangered list and then Colorado can move forward on its own. Just after this issue qualified for the ballot, video of two wolves in northwestern Colorado indicated there may be a pack of gray wolves living here already. One argument for bringing them back -- help reduce the elk and deer population, which in turn could restore grass and vegetation, which could then have other potentially positive effects on the environment. In 2016 - the CPW Commission voted against reintroducing gray wolves -- in part because of money. At the time, CPW wrote "without additional funding, or reductions in existing programs to compensate for the increased expense, efforts to actively release wolves into the state are not possible." Why do you need money? Part of Proposition 114 calls for fair compensation to livestock owners if their livestock are harmed by gray wolves. What is fair compensation? It's not explained in detail in the Blue Book... The text of the law directs you to state statute 33-3-107. Which essentially says the livestock owner must notify CPW within 10 days and start a claim process. The state of Montana has a livestock loss board and keeps statistics. So far this year - there have been claims for 167 livestock totaling 129-thousand dollars. Last year - 373 for 260-thousand dollars, and in 2018 - 294, totaling 230-thousand dollars.

Voters in Denver county showed the strongest support for prop 114 - but many along the western slope and eastern Colorado were strongly opposed. "I've been working on bringing wolves back to Colorado since late 1994." INSIDE ROB EDWARD'S HOME, THERE'S NO SUCH THING AS A LONE WOLF. "Not by a long shot! There's wolves all over this house." THE PRESIDENT OF ROCKY MOUNTAIN WOLF ACTION FUND HELPED GET PROP 114 ON THE BALLOT. "It's an up or down vote." THE VOTE TO HAVE COLORADO PARKS AND WILDLIFE REINTRODUCE GRAY WOLVES TO WESTERN COLORADO FEELS LIKE A LOSS TO JUBE BAKER. "How are we going to manage these animals if they do get dropped here?" DOWN IN IGNACIO, COLORADO, HE LIVES AND WORKS ON THE SOUTHERN UTE INDIAN RESERVATION. "I am cattle rancher and I'd rather be doing that than working in the office." LIKE HIS LITTLE BOY, HE'S BEEN RANCHING SINCE HE COULD BARELY WALK – AND HE BELIEVES WOLVES THREATEN HIS CATTLE AND HIS LIVELIHOOD. "Bears, coyotes and now I guess we're facing the wolf." "I see them killing a lot of livestock down here." THE VOTE IS NEARLY 50-50 – AND JUBE SEES A CLEAR DIVIDE – EVEN THOUGH THE 'YES' VOTES OUTNUMBER THE 'NO'S' IN HIS OWN COUNTY. "I see that the people in the big cities are most of the vote where they're not going to have to deal with the problems these wolves are going to cause." "There are ranchers who voted for this. I guarantee you." THE STATE IS SPLIT, BUT COLORADO LOOKS LIKE IT'S ON ITS WAY TO BRINGING WOLVES BACK. "We want to have all voices on the table talking about what a future with wolves looks like."

Hi goose, goose, goose." Joan Maxwell, Neighbor: I have known her (laughs) since she was hatched here on this lake this summer and I kept an eye on her and I kept talking to her and she would come up

towards the house. I had some cracked corn for the chipmunks and for the birds and she would eat that." THEY NAMED HER GOOSIFER - AND JOAN MAXWELL HAS BEEN CARING FOR HER FROM A DISTANCE SINCE SHE NOTICED HER WINGS WEREN'T FULL ENOUGH TO FLY VERY FAR. "She can get from here out to the middle of this lake, she can get from here over to the other lake, but she just can't get any further than that." WHEN GOOSIFER'S FAMILY ABANDONED HER TO HEAD SOUTH FOR THE WINTER - JOAN WASN'T THE ONLY NEIGHBOR CONCERNED. Brett Lamb, Neighbor: "In the middle of this frozen lake is this goose, just sitting there, which is the incarnation of hopelessness, and just loneliness." AFTER JOAN CALLED A LOCAL ANIMAL REHABILITATOR WHO LIVES IN THE NEIGHBORHOOD, AND GOT SOME ADVICE, BRETT LAMB - WHO ALSO LIVES NEARBY - PUT HIS WOODWORKING SKILLS TO THE TEST. Brett Lamb, Neighbor: "There's a sleeping bag in there and then there's a tub that Joan put in there so the goose can actually float and can keep its head lubricated." JOAN TOLD ME THIS IS ONLY TEMPORARY. Brett Lamb, Neighbor: "I do not intend to try to tame her in the least. She's a wild animal and I want her to stay wild, but I want her to stay safe until she can fly to migrate away next fall." STILL - SHE AND BRETT SAY THEIR TEAMWORK SERVES AS A REMINDER. SOMETIMES ALL IT TAKES IS A COUPLE NEIGHBORS, SOME PLYWOOD AND HAY TO MAKE A DIFFERENCE. Brett Lamb, Neighbor: "There's so many bad things going on right now that we really gotta embrace the good things, such as what happened here, you know, the community coming together and everybody working together."

WINTER IS AN ESPECIALLY DIFFICULT TIME FOR STRAY ANIMALS IN COLORADO. BUT THE GRAND RIVERS HUMANE SOCIETY HELPS MESA COUNTY'S ANIMAL RESCUE IN FINDING CATS AND DOGS A NEW HOME. Doing what they can to help cats and dogs find their home in the valley. "We are a small but mighty crew of volunteers with Grand Rivers Humane. We have a very committed foster program, adoption program, strong commitment from many, many volunteers. Couldn't do it without them." Grand Rivers Humane has one clear mission for the rescues. "All of our dogs and half of our cats come from Mesa County animal services. Our goal back in 2005, when Doctor Joe started Grand Rivers Humane, was to eliminate the euthanasia of adoptable dogs and cats." Potential adopters spend some time with the dogs beforehand to make sure they would be a good fit. "We've been checking some of the local websites looking for a dog. We had one who passed away recently, so we're trying to find a friend/mate for our current dog. They want you to walk around with the dogs a little bit especially if you have a dog to ensure that they get along, make sure that the dog responds to you and is friendly towards you as well." And to many in the community, it is important that rescues find a safe, loving home. "We've always been looking for rescues because we'd rather get a dog that's already had a rough life, or trying to find a good home, rather than trying to buy from breeders." Seven dogs were up for adoption today. "Grand Rivers Humane also pays for most of the extended medical costs for dogs and cats at Mesa County animal services. Then we try very hard to find loving homes for them, we try find a good fit for the dog and the family or individual adopting." THERE ARE ALSO TWO DAYCARE CENTERS AT THE HUMANE SOCIETY, FOR DOGS AND CATS.

OFFICER LEVI HUFFINE SAID HE DIDN'T KNOW WHAT HAD HAPPENED AS HE TRANSPORTED SHATAEAH KELLY AFTER ARRESTING HER ON MINOR CHARGES, HOBBLING HER AND PUTTING HER IN THE BACK OF HIS PATROL CAR. Levi Huffine/Fired Officer: "I'm sorry, it was a mistake, but I had no clue she was in an inverted position in the backseat of my car." UNDER CROSS EXAMINATION, THE FIRED OFFICER SAID HE HEARD KELLY'S PLEAS. Isabelle Evans/City Attorney: "And you heard all that for 21 minutes?" Levi Huffine/Fired Officer: "Correct. Yes ma'am." Isabelle Evans/City Attorney: "And you did not look behind you to check on her in spite of hearing all that? Levi Huffine/Fired Officer: "Correct." HUFFINE SAID HE COULDN'T SEE HER AND WAS FOCUSED ON GETTING HER TO JAIL, AND OUT OF THE HOBBLE. AURORA'S POLICE CHIEF FIRED HUFFINE

WITH HARSH WORDS...Chief Vanessa Wilson/Aurora Police Dept. "We are not judge, jury and executioner we are not to treat people inhumanely like they don't matter." Levi Huffine/Fired Officer: "I am not the person painted by the chief as an officer who inhumanely treats prisoners." HE SAID HE DID NOT INTENTIONALLY, OR MALICIOUSLY HURT KELLY. AURORA CITY ATTORNEYS ARGUED HUFFINE'S FIRING SHOULD STAND...Peter Morales/City Attorney: "Are we better than this? Are we better than this? Are we better than this?" THE MINOR CRIMINAL CHARGES FILED AGAINST KELLY WERE DISMISSED. HUFFINE WAS NOT CRIMINALLY CHARGED IN THE CASE. The shooting of a protestor by a private security guard is raising lots of questions about the licensing and requirements of private security-- not just in Denver-- but across the state. That shot – this image – private security guard Matthew Dolloff shooting and killing protestor Lee Keltner – raises questions about what training he had on when it's appropriate to resort to lethal force? It's a very long training session Grant Linhart, the President of ICS Professional Investigations is one of the approved trainers for security guards seeking a license in Denver. If it's what's called a high school fight – you can't use lethal force in that cause an open slapped hand is a high school fight – that's not a lethal force encounter. Pepper spray is not a lethal force encounter Grant says the training is you must be in fear of your life or grave bodily injury to you or the person you are protecting. It will be up to prosecutors to determine if that hi bar was met. But as we have learned, there is no record Matthew Dolloff ever received that training because he was not licensed to be a security guard in Denver. Eric Escudero is with Excise and Licenses, "the fact that he was not licensed means that he did not go the rigorous training that Denver requires all security guards to go through to prevent incidents like what happened this past weekend." Denver's requirements are unique. In Colorado – only 3 cities – Denver, Colorado Springs, and Glendale – have licensing requirements for private security guards. But to work in Denver – there is no wiggle room, you must be licensed and go through even more training to carry a gun. "Is that something every security guard should know?" Grant: In the city and county of Denver – yes. if you're going to operate in the city and county of Denver you have to the city says the security guard employer is responsible for ensuring their employee is licensed. Since 2017 – 3 security companies have lost their license to do business and or been fined for using unlicensed guards.

COLORADO POLICE ARE SEARCHING FOR A MAN WHO GOES BY THE NAME "PSYCHO." THEY SAY HE'S A KILLER AND HAS BEEN ON THEIR RADAR AFTER THREE SETS OF HUMAN REMAINS WERE FOUND. HIS LEGAL NAME IS ADRE JORDAN BAROZ, BUT LAW ENFORCEMENT OFFICERS SAID TODAY THAT MOST PEOPLE JUST CALL HIM "PSYCHO." Chief Ken Anderson/Alamosa Police: He is commonly called Psycho around these areas AND WHILE NO EXPLANATION WAS GIVEN FOR HIS NICKNAME, WE DO KNOW THE 26-YEAR-OLD BAROZ HAS A LENGTHY ARREST RECORD FOR VARIOUS VIOLENT CRIMES OVER THE PAST FEW YEARS. WE ALSO KNOW THAT HE'S NOW ON THE RUN, WANTED IN CONNECTION WITH THE DEATHS OF THREE UNIDENTIFIED PEOPLE WHOSE REMAINS WERE FOUND LAST WEEK ON TWO DIFFERENT PROPERTIES, NOT FAR FROM WHERE BAROZ IS FROM, IN THE REMOTE SAN LUIS VALLEY, ABOUT FOUR HOURS SOUTHWEST OF DENVER. Chief Ken Anderson/Alamosa Police: We currently have an active warrant for homicide for Mr. Baroz. AT TODAY'S VIRTUAL PRESS CONFERENCE ANNOUNCING THE MANHUNT FOR BAROZ, POLICE WOULD NOT SAY WHY OR AT WHAT POINT HE BECAME THE FOCUS OF THEIR INVESTIGATION. THEY DID REVEAL THAT THE ORIGINAL SEARCH WARRANTS AT THE PROPERTIES HAD TO DO WITH STOLEN EQUIPMENT AND STOLEN VEHICLES. Chief Ken Anderson/Alamosa Police: Obviously we don't see cases like this very often. "I about got blown off my feet once" ON FRIDAY NIGHT BATTALION CHIEF DAN BATTIN WAS FOCUSED ON STAYING UPRIGHT IN 70 MILE AN HOUR WINDS. BUT THE DAYS ON THE LINE ARE LONG – ENOUGH TIME TO WONDER WHAT IT WILL TAKE FOR THEM TO END. "You're out on the fire line and you just think man I just want to stop this thing – but I can't. You know mother nature's gonna have to stop it at some point" DAN WAS THERE WHEN THE CAMERON PEAK FIRE BECAME THE LARGEST IN COLORADO'S HISTORY LAST

WEEK. "I don't know that I could ever describe what it's actually like you know hearing a fire that sounds like a freight train but what I want to tell people if they're listening is that all of that can be started by a campfire that wasn't fully put out. Or not abiding by local fire restrictions" HE THINKS ABOUT THIS ON THE LINE TOO. "I think about it all the time" WHEN YOU'RE BATTLING SOMETHING THIS BIG – THE THOUGHTS CREEP IN AT ALL HOURS. "I wake up sometimes having dreams that the fire's coming through the camp or something – and they're vivid they're kind of weird- I wake up and I'm like oh – oh the fire's not burning everybody up – ok" DAN THINKS A LOT. BUT IT'S WHAT HE KNOWS THAT KEEPS HIM COMING BACK TO THE LINE. "Of course, I would much rather be fighting fire than doing a lot of things. The winds in the Cameron peak fire area are lighter now- but that just means the gusts have changed from 70 miles per hour to 20-30 miles an hour. The fire is still growing and tonight firefighters will be focused on stopping flames from spreading south and protecting buildings in the retreat, glen haven, and storm mountain areas. A silver lining though -- mandatory evacuations for an area south of the fire along highway 34 HAVE BEEN downgraded to voluntary.

It's the only place it crossed the street." WHILE OTHERS, LIKE TED ROCKWELL MADE IT OUT UNSCATHED. "my boat survived. Its over there. I've been trying to get this station built for a number of years and it just feels so good to finally get it done" and the construction team was happy to be a part of it "obviously what they do is unmatched by any other profession in my mind and just a great group of people that we are building for and that makes all these things so much more fun" having the hose ceremony was an exciting moment for them "the fire department tradition we use a hose uncoupling instead of a ribbon cutting so we open the hose up and get the station, and we start responding from there" and they are officially taking calls as of today and will be serving over 9500 people in the immediate area and will also be responding downtown, out east, and out west as backup for other stations. They have crews working throughout the day and night doing all they can with snowplows and salt, so drivers have a safe commute. Up to one and a half inches of snow covered the valley today... "we've been kind of monitoring it, it's one of these snows that's going to kind of hang around here through tomorrow." And the city of Grand Junction is well-prepared with crews working through the day and night to keep the roads safe. "Clearly the city has handled the real trouble spots here in town, it's mostly water out there. Here and town and even out in the Redlands the streets are mostly clear." A total of nine trucks have been out, but they can't reach every road..."You know, the public needs to remember too, we're not going to come into neighborhoods. Our goal is - you drive on one untreated street to get to a treated street." STANDUP: "At first glance, what you see behind me may just look like a big pile of dirt, but it's actually not dirt, it's salt—salt that helps break up the ice when it snows." "we hope it doesn't rain and then freeze back and make it really icy underneath the new snow that comes un cause it's really unpredictable at that point." Aside from salt, the city also has another preventative material. "so you know, we do have magnesium chloride, it's fairly expensive and it doesn't go a long ways for us so we kind of keep hold it back so if we have some real ice buildup underneath then we could use that product." Though the city prepares as best they can, there are things you can do to help too. "If you don't need to go somewhere stay off the roads because less traffic on there helps less chance of accidents." Some other safe driving tips are: Giving yourself plenty of time to get where you're going and leave a good amount of distance between yourself and the car in front of you. There are crews working all throughout the night and another crew will come in to help with the morning commute tomorrow. The city of Grand Junction also helps with ROADS THAT ARE NORMALLY COVERED BY CDOT in the area.

We are getting just enough snow lately to keep the drought from worsening. but the deficit in precipitation is so huge that we won't be able to make up the difference this winter, especially the way things are going so far. CORY REPPENHAGEN GIVES US a look at the KEY DROUGHT indicators. First the drought levels – the entire year of 2020 has been the driest since 2002, and the extreme and exceptional drought levels are also the worst since that year. Now the snowpack up to this point in the season which would be since October 1st. This shows the amount of water that is stored in the snow at the headwaters of our river systems. This is also the worst since 2002 with most areas almost 30% below average. That snow is higher up so let's check out the base area of Vail Resort. They are reporting just a 28-inch base so far. That is the lowest amount in 10 years.

A rare program, unique to Mesa County... the 5-star variance protection program... "this is a home-grown product of our variance protection plan, we actually came up with the idea in early July." Over 400 businesses are now participating in it, allowing them to stay open even in the 'level red' restrictions on Colorado's covid-19 dial. "these are the businesses doing their very best in exercising all of the things that we've learned are necessary in terms of cleaning, mask wearing, and socially distancing." Businesses are not required to pay or be a part of the grand junction area chamber of commerce in order to participate. Last week there was some concern on whether or not the program would continue or not, but things may now be headed in the opposite direction. "the governor's team does a periodic meeting with chambers across the state, just to keep us updated on what's going on and provide information and on this, our next call which is on Wednesday, I've been asked to present this program to my peers across the state as an example of a way to work with businesses." The intention is clear, keep people safe, while keeping Coloradans employed during the pandemic..."I mean, it's made a huge impact for us as far as our sales go and our income, you know, when the first wave of restrictions came out in the spring, our sales plummeted." But the goal can only be accomplished if everyone works together to make it happen. "we really want people to be healthy, and the only way our business will survive is if people in the community take this threat very seriously and take care of each other." Amanda Dimmick, a former mesa mall security guard was let go FROM her position and now works security for other stores in the mall. She has since started a petition, calling for the enforcement of the Mask Mandate at Mesa Mall. "I connected with everyone that I work with throughout the mall, every different store and the tenants, and a lot of them really don't like the fact that they can't feel safe while their working." Though she has received a lot of support on the petition, she now fears for her safety from those who oppose. "my life is being threatened, my kids are being threatened." Dimmick says the mall has never enforced mask wearing and even when individual stores do... it is always a struggle. "the reason why they aren't forcing the mandate is because customers were getting violent with them and it became something where people just knew that they couldn't talk about or have any kind of effect on because they might lose their job." But not everyone agrees with the petition..."I do wear a mask when I go in the stores, but when I'm in the open mall, I don't usually, and I would not want to if they made it mandatory." Robinson and her friends frequently walk the mall and prefer to do it without a mask. "I think there's plenty of room to distance, to social distance and I don't think it helps that much having a mask. I don't think that would make much difference in the open mall." Mesa Mall declined to comment with us. So far, the petition has garnered almost 400 signatures. Dimmick says the next steps she would like to take if asked is to bring show the petition to Mesa Mall Management, Mesa County Public Health, and Grand Junction City Council.

Businesses that rely on indoor service could soon get permission to have more customers. The state has finalized the requirements for a 5-star variance program...inspired by mesa county. For restaurants that qualify -- it would mean the ability to reopen dining rooms. Gyms and retail shops could be allowed increased capacity. This is the extensive checklist businesses must follow if they want to be considered for the new 5-star variance program. Essentially -- 5-star recognition means businesses -- restaurants, gyms, indoor event centers -- can operate under restrictions one color level looser. For example -- in counties that are level red -- restaurants have to close their dining rooms. But under the 5-star status -- the restaurant would be allowed to operate at level orange restrictions -- 25 percent capacity. If \*you\* want to be one of the 25 percent... you have to follow some rules as well. Customers have to be screened for symptoms, leave their name and contact info for contact tracing purposes... and the restaurant has to record where you sat. LORA THOMAS "Douglas County will be applying on Friday for the 5-star variance program." City and county leaders in Douglas County held a conference call to make sure they could be first to submit an application to the state tomorrow to be granted the 5-star variance. That's step one. Step two -- would be inspecting businesses to make sure they can follow the county's 5-star guidelines to qualify. TIM HALLMARK/DOUGLAS COUNTY FACILITIES DIRECTOR "Our main priority is going to be driven toward restaurants, and then after that event venues, and then after that other businesses...because those restaurants and event venues have had the most negative effects." Another part of the county's application to the state has to explain how it will conduct live inspections...And explain the protocol for enforcement. We reached out to Weld County Commissioners to see if they would put on paper enforcement procedures for restrictions they have previously said need to be enforced by the state. A spokeswoman for the commissioners said that Weld County has no plans to apply for a 5-star variance. In a bit of irony -- Douglas County needs its application signed off the by Tri-County Health Department. A major business boost served up by Nate Ormond. "People don't want to eat outside when its 20 degrees unfortunately." Ormond has spent the last week... buying lunches at the local restaurant in downtown Castle Rock for the dozens of people willing to join him outside of Tri-County Health. "The message for Tri County Health is let's just be reasonable. These people cannot survive. If they make it through the winter I'd be very very surprised a lot of these small mom and pop restaurants." A profitable protest Tri County Health doesn't blame anyone for organizing. "I understand their concerns and their feelings" But it's a restriction Dr. John Douglas says comes with a lot of context. "There's actually a pretty sizable body of evidence that restaurants or indoor dining do provide a place where transmission can readily occur. " And as long as these restrictions remain Ormond encourages you to shop local. And take inventory of the avenue of emotions on Main Street. protest organizers managed to raise nearly six thousand dollars for the Garlic and Spice restaurant and the owner's daughter, little Gabby.

"We definitely hear people make the assumption that because a person with a developmental disability has a guardian that they no longer have the right to vote. That's absolutely not true in this state." SHE SAYS COLORADO IS ONE OF 11 STATES WITH NO RESTRICTIONS ON A RIGHT TO VOTE DUE TO MENTAL CAPACITY. BUT SOME PEOPLE WITH DISABILITIES STILL FACE BARRIERS. "Another barrier that we will see are signature matching issues" IF SOMEONE CAN'T SIGN BUT THEY CAN CONVEY WHO OR WHAT THEY WANT TO VOTE FOR- A MARK ON A BALLOT WITH A WITNESS OR A STAMPED SIGNATURE IS ACCEPTED TOO. "You can just vote and if you need help voting you can get assistance" BUT LEGALLY THAT HELP CAN'T COME FROM AN EMPLOYER OR A UNION REPRESENTATIVE. THIS YEAR COLORADANS WITH ANY KIND OF DISABILITY CAN ALSO VOTE ELECTRONICALLY. LEVIN SAYS THIS ALLOWS PEOPLE TO USE THEIR OWN ASSISTIVE TECHNOLOGY ON THEIR COMPUTERS. " What's so nice to be able to vote this way is that you have the same access to voting in the comfort of your own home like people without disabilities do now " IF PEOPLE DO VOTE USING THEIR COMPUTER, THEY STILL NEED TO PRINT OFF THE BALLOT AND MAIL IT IN OR DROP IT OFF.

They are closely monitoring it and every student has a Chromebook which makes it easier for them to all go online if necessary, but that is not the plan at this point. we do believe and this has been backed up by research many times, it's the best interest for students to be in school as much as possible if their own safety and welfare allows that" School District 51 thinks it is safe to stay open "we just don't see right now a circumstance that is currently preset that would require us to close down all 47 schools" but they are keeping a close eye on it "we're obviously watching the case load go up. we've been very concerned about that" and making sure everything is safe can be challenging "between our staff and our students you have over 25,000 people. so just making sure you are trying to keep them all as safe as possible is a tall order." but right now, school is considered a necessary function "Wednesday the Colorado department of public health and environment did place k12 schools and higher ed on the list of necessary functions, so that buys us some latitude also in terms of how we might weather we would be required to shut down, or anything like that" And many people in the community are happy that the school is staying open "I know for my granddaughter who is 12 years old, she needs that social interaction" school district 51 said they are looking out for the wellbeing of everyone involved. "I guess the thing we want parents to know is we would never take chances with our students or our staff and many people are worried about sports. At this point the amount of people allowed to watch games has gotten smaller and the season was shorter than normal, but the superintendent said she is not sure about winter sports because they will be indoors, so sports is also on a case by cases basis because of COVID-19. "because of the pandemic we are seeing an exists of workforce from people close retirement age so there is a real effort to get the word out that we need nurses." The program has had to adapt both in the spring when COVID-19 first hit as well as adapting their summer and fall semesters. "a combination of direct clinical experience at our hospitals over the summer as well as the use of our high-fidelity simulation lab, we were able to get the students that needed clinical hours to allow them to progress to the next level." Students have also had to change their learning experience from working in hospitals and nursing homes to working with simulations within the university. "we didn't get that practice with human interaction which was kind of disappointing, but we were able to do simulation and online simulations" Regardless of the changes, they hope more people hop on board "to have more involvement from the younger generation saying gosh I want to make a difference and prevent this from every happening again." The program may be a popular one but there is still a need for nurses. "nurses are a huge corner stone in patient care and patient education and they can change the whole perspective of patient." Nursing students at CMU are still able to get a hands-on experience by working on COVID-19 testing sites and working in the local hospitals.

Before they were allowed to take their masks off when they were at their desks with their cohort. The school district based their decision on the rising number of positive covid-19 cases in the community. "with the additional spread within the community we are hoping to keep that down in the schools by having them wear masks at this time." But not all parents are happy about this description. "not good for the kids. In fact, my six-year-old asked me this morning why she's got to do that, it's really hard to explain to a kid. I feel like it distracts from their learning." USING FACEBOOK, SHE FOUND FOUR HOMESCHOOL STUDENTS IN EASTERN AND WESTERN COLORADO TO EXCHANGE LETTERS WITH. "A big part of it is using really good handwriting. Also, how to write a letter that's important. You'll need it for your entire life. You need to know how to write to other people. We're also doing it through email so we're learning how to do an appropriate email." SO FAR, ONE OF HER STUDENTS HAS RECIEVED A RESPONSE LETTER BACK. ALTHOUGH THEY'RE STILL GETTING TO KNOW THEIR PEN PALS THE STUDENTS ARE HOPING TO HAVE A MEET UP IN DENVER ONCE IT'S SAFE TO DUE SO.
