A disease contagious and ultimately fatal to animals is found in a deer near Montrose County. Today parks and wildlife officials are urging residents to be aware of their animal's behavior. They can pick it up from nose to nose social contact, possibly from soil, it's not like we have a large die off of animals, from this disease and it's concentrated in some areas more than others. Officials add that if residents encounter an animal that looks like this they should report it right away. Hunters in certain areas can have their harvested animals tested before they eat it for free. The disease is called chronic wasting disease. It can infect deer, elk and moose. A protein attacks the brain, causing animals to display strange behavior and become extremely thin. The animal eventually dies. A parks and wildlife spokesperson said that the disease has been in Colorado for over 30 years. This, however, is the first case found in the south west region of the state.

A Colorado horse owner says a transportation company is responsible for the death of her animal. The owner says the horrific conditions her horse endured over just a few days under the company's care... Was enough to end the animal's life? From show horse to sickly in just a few days. "It was honestly heart breaking. They are your best friend and they are your teammate. To see them in so much pain that they can't walk," says Lindsey Decker, horse's owner. Owner Lindsey Decker says nation-wide horse transportation is to blame. She hired the company to ship Elle from Ohio to her college in Virginia. The company told her it'd take one day, but it instead it took three. "She was very dehydrated. It was pretty clear she hadn't been given nearly enough water or probably taken off the trailer at all over three days, which you can't do that to an animal," says Lindsey Decker. These documents show Elle passed her check-up two days before the trip but in Virginia, a veterinarian diagnosed her with pneumonia, and the bones in her feet were swelling, and threatening to break through her hooves. Within three days... Elle had to be put down. Decker says more victims are contacting her and more than a dozen reviews online discuss similar experiences. "It seems like they have been getting away with it for a very long time. People told me that they had this experience as far back as 15 or 20 years ago, and so it's really mind blowing to me that they have been able to do this for so long," decker says.

A popular riverfront activity is being disrupted by our city's homeless population. The homeless are being cleared out, but the clean-up may cost tax payers thousands. The Watson island disc golf course spans 29 acres, but one portion of the course under the 5th street Bridge can no longer be played. The jurors have heard it all over the next few hours, maybe days they will deliberate. Jones is facing three charges including murder and kidnapping. Whether or not Lester Jones will spend the rest of his life in jail now lies in the hands of 12 jurors. Did Lester Jones murder Paige Birgfeld? That's the question 12 jurors are now deciding Lester Jones knew Paige Birgfeld for a year, we know this because he told us this. Prosecution urged jurors to look at the evidence. The phone records, Jones online porn addiction, the purchase of a burner phone, the location of Birgfeld's burned out car, and other events which according to the prosecution shows a clear correlation between Jones and the murder of Birgfeld "he has the drive to be looking for escorts to be specifically targeting Paige, his computer usage show his sexual frustration for his inability to get with her" says Rubenstein. Since the trial began in early August the defense has fought to convince the 12 jurors that this entire investigation is flawed. The deficiency in this investigation is breath taking. Defense believes there five other suspects in this case who law enforcement turned their backs on...putting a hyper focus, a bias, on Lester Jones. There is no question someone murder Paige Birgfeld, but now as the district attorney puts it.... The only dispute is if the defendant did this. The defense saying... "What is going on here??? why is this man all of the sudden deciding to murder a prostitute, that makes no sense and when you start saying that makes no sense you have a reasonable doubt " the question at hand here is whether or not Lester Jones is guilty beyond a reasonable doubt. The reasonable doubt factor played a significant role in both sides closing arguments. For the jury it's a matter of looking at the big picture or looking at all the small details. Whichever they chose to focus on may create two very different verdicts. The jury will take however much time they need to deliberate. When the verdict is in we will be live on KKCO, as well as on our website kkco11news.com

Twelve jurors tasked with deciding the fate of Lester Jones unable to reach a verdict the jury could not reach a unanimous decision...leaving a mistrial... This came after the judge ordered jurors back to deliberations late this morning, when they first told the judge they were deadlocked. Here is that exact moment in court where the mistrial was declared this afternoon... Raise your hands if you don't agree with this decision....ok for the record none of our jurors have raised a hand so I'm declaring a mistrial in this matter. The jury received the case on Friday, one week ago, and took the holiday weekend off. Now, after four full days of deliberation -- they were still undecided about whether Lester Jones was guilty or innocent and decided they could not come to that answer. That means a mistrial after six weeks of evidence, videos, questions and testimonies. Opening arguments beginning way back on July 29th have now become null and void. it would be my request to declare a mistrial based on the length of deliberation. and frankly judge that there will be a differing answer is that if they are just block on guilt versus non guilt, I don't think there is any point in going further, says Steve Colvin. We reached out to the Jones family and the defense team but they turned down our request for comments. Frank Birgfeld tells us the decision of this jury is one he has to accept. "I've never been on a jury, so I don't know what's going on but I do know this we miss page. It wasn't not guilty I'd rather have it guilty, but here is an opportunity to redo the whole thing," says Birgfeld. Nine years after his daughter first went missing; Frank Birgfeld says he just wants to go home. Another quiet courtroom....as the jury deliberates behind closed doors. They re-watched the entire 7 1/2 hour video of Lester Jones being interrogated and jurors also wanting to see the day planner that showed Paige Birgfeld's appointments in the days leading up to her disappearance. The 9 men and 3 women on the jury - ultimately could not decide if Lester Jones is the man responsible for the kidnapping and murdering Birgfeld. As with any mistrial it's up to the prosecution to either request a dismissal or try the case all over again. In the meantime, Lester Jones will wait behind bars. The next court appearance is scheduled for September 16th. Where they will decide when the next trial will begin.

Colorado is topping the charts in its cases of west Nile virus this year... particularly northern Colorado. Aimer County has seen 28 human cases this year, the most in the state. While Mesa County hasn't seen a human case yet this year-- we have confirmed the virus in area mosquitos. Folks at the health department say September is when they see the highest number of west Nile virus cases. We still encourage everyone to use EPA approved bug spray, to dispose of standing water in and around your home, and avoid times when mosquitoes are most active which is dusk and dawn. Initial human symptoms of west Nile virus can include fever, headache, nausea, vomiting, muscle aches, weakness and rash. The type of mosquitoes that carry the virus here in mesa county-- will likely die off during the first freeze in the valley.

According to Mesa County Health Dept. over 240 suicide attempts were in our country last year. Tonight we're looking into how college students fit into those numbers. September marks National Suicide Prevention Month. Colorado Mesa University is opening up about what just might be the toughest subject of them all. CMU recently began 2 suicide prevention services that educate and assist those in need. 11 hundred college students won't graduate, not because of bad grades, but because of suicide. According to activeminds.org; for some it a never ending struggle. "I personally deal with depression and anxiety and I have friends that have." The Mesa County Health Dept. says in 2015, over 240 suicide attempts were made. Many of them were college students. "It's pretty hard; I battle with it every single day. It gets better as it is." Colorado Mesa University is starting new services they hope will decrease the stigma that comes with mental illness. "Are you noticing drastic changes in your behavior, to much sleep?" College is the ages were people begin to notice changes. "Especially like the incredibly difficult ones like schizophrenia, 19 is usually the onset for diagnosis like that." 4 out of 10 students are impacted by a mental health issue. 3 out of 4 will report a mental health crisis each year. Definitely depression and anxiety are top of the list with mental health concerns students battle with." Knowing what resources are available can make the difference. "Never ask what's wrong, always just be there to do something fun with them. If you

really don't know what to do call the suicide prevention hotline." There is no direct correlation to why rates continue to grow in Mesa County but there is speculation. "People who like to take risk are up in the mountains, so there cut off from resources, generally they've moved away from their communities, their families, so there's lack of community some times." Some other factors may be the economy or being disconnected from big cities. "Don't treat somebody different if they are having a bad day because of their depression, be there and be that person that could make there day better, because one little move can take them off and make them do something they'll forever regret."

One of the easiest ways to take better care of yourself is to educate yourself on your health. if you pay attention, this mini med school as they're calling it will help you improve your own wellness, and help you speak more effectively to your healthcare providers. How well do you think you know your body? Sometimes even when you're feeling well there markers than you might not be as healthy as you think you are. For the next eight weeks the CU school of medicines teamed up with the Western Colorado Area Health Education Center to offer a mini med school program. "By bringing people together so they can listen to doctors on various topics, we're hoping they take charge in their health," says Nicole Heil. Modern day technology allows Doctors to broadcast live from the Front Range to 9 different western slopes communities each week, a different topic. a day in the life of a rumotology clinic, what is that? You hear the word thrown around, but unless you've had an experience with it you may not know goal of the class, to encourage kids to look at a future in medicine. they're going to see every week a different focus about what they might want to be when they grow-up But even if you're not looking to a doctor, Doctor Elizabeth Buisker with Marillac clinic says When it comes to YOUR HEALTH, there's a lot we can learn "a lot of people think you have to be sick to see a doctor, "Sometimes it nice to just hear about the true anatomy," says Elizabeth Buisker, D.O For many of her patients affordable healthcare is often out of reach, meaning education through something like the mini med school can help avoid a pricey doctors visit it's good to know what changes to can make the improve your health in small ways. The mini med class will be for 8 weeks. It is open to the public, and is completely free. Learning about your body also helps you understand, when may be the time to see a doctor. Doctor Bisker says regular check-ups can help avoid health problem from escalating to dangerous level later on. The class is offered at the mesa county health department, but it can also be found at the delta memorial hospital, and at several Western Colorado county websites.

The death of Angel Lenay place struck the hearts of thousands here in Grand Junction. The 11 month old was killed by Sydney White, her foster mother assigned by the mesa county department of human services. White IS now behind bars, serving a 31 year sentence. Last week members of angel's family filed a lawsuit in federal court asking for a jury trial and financial compensation. 18 pages detail the months of foster care that let up to the death of little Angel Lenay place. The families now fighting for the deceased child, saying her constitutional rights were violated. when you have a tragedy like this is it should be examined...it should be examined by the state, by the people with the facts and that's what we're really asking here" Putting the death of Angel Lenay place back in the spotlight, but this time under the microscope of a federal lawsuit. "We think this is a horrible tragedy the folks involved want to explore that further" Attorney Keith Killian filed the civil case on Monday, the plaintiffs being the estate of angel, represented by her grandfather Shane Place. The suits filed against four members of the mesa county department of human services, who placed angel in the care of the woman who murdered her, Sydney White. "it's not so much an attempt to insult these individuals, or make a case against them but we have no other choice in a civil lawsuit" Sentenced to 31 years behind bars for the murder of angel, the federal complaint says white had dropped angel on her head, and violently shook her, which ultimately led to her death. The department of human services issued a statement saying "We take all incidents of child abuse and neglect very seriously. Due to pending litigation we are unable to provide any specific response in regards to the Angel Place lawsuit." "The case workers and those involved in the care are human, and you can't really predict human behavior" Rowland says. Checks and home studies are done before placing a child in foster care. "It's not made in a vacuum it's made by a whole team of professionals really looking at what's best for the child" says Rowland. The complaint outlines *dozens of allegations of abuse, and neglect committed by white, many of which were allegedly reported by her initial foster mother. It goes on to claim those the department of human services employees willfully turned a "blind eye" to reports of suspected abuse. Those employees now face 4 charges, 2 of which claim angels constitutional rights were violated, and 2 that question whether the proper procedures were followed within DHS. Because the case is being filed in federal court, the case could take place in any federal courtroom around the state. Angel's attorney says it may be easiest to hold the case in Grand Junction because many of the witnesses are local. The location is ultimately up to the judge.

Live interviews are conducted on a regular basis by the mid-day anchor, Crispin Havener. He speaks with community Leaders, non-profit organizations, medical personnel, etc. to discuss topics of concern and information for the viewer. Interviews are also held with organizations regarding upcoming events to benefit their community programs and services.
