TIME AND PRESENTATION OF PRE- AND POST-FILING ANNOUNCEMENTS

Pre-Filing Announcements:

One announcement must be made on each of the following four (4) days:

February 1st and February 16th
March 1st and March 16th

At least two (2) of the total four (4) announcements must be broadcast between 7 am - 9 am and/or 4 pm - 6 pm.

For stations that do not operate between 7 am - 9 am and/or 4 pm - 6 pm, at least two (2) of the required announcements shall be made during the first two (2) hours of broadcast operation. The other two (2) announcements must be broadcast at any time on the scheduled days.

Post-Filing Announcements:

One announcement must be made on each of the following six (6) days:

April 1st and April 16th
May 1st and May 16th
June 1st and June 16th

At least three (3) of the required announcements must be broadcast between 7 am - 9 am and/or 4 pm - 6 pm, at least one (1) announcement between 9 am - noon, at least one (1) announcement between noon - 4 pm, and at least one (1) announcement between 7 pm and midnight.

For stations that do not operate between 7 am - 9 am and/or between 4 pm - 6 pm, at least three (3) of the required announcements shall be made during the first two (2) hours of broadcast operation.

TEXT OF PRE-FILING ANNOUNCEMENT FOR WRLT(FM), FRANKLIN, TN

On July 27, 2012, WRLT(FM) was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until August 1, 2020.

Our license will expire on August 1, 2020. We must file an application for renewal with the FCC on or before April 1, 2020. When filed, a copy of this application will be available for public inspection at www.fcc.gov. It contains information concerning this station's performance during the last 8 years.

Individuals who wish to advise the FCC of facts relating to our renewal application and to whether this station has operated in the public interest should file comments and petitions with the FCC by July 1, 2020.
