Date: January 8, 2023

Time: 6a

Issue: Community Focus

Duration of Discussion: 12 Minutes – No Guest: The Host discussed the 2022 year in review. She reviewed the significant political, medical, and cultural issues that dominated 2022 and discussed how we as a country excelled and how we fell to all-time lows. She encouraged the audience to seek to perpetuate what is best not just individually but collectively.

Issue: Legal Issues/Youth-Related

Duration of Discussion: 12 Minutes -No Guest: The Host discussed the topic of children and firearms, specifically discussing the story of the 6-year-old child who purposefully shot his teacher. The Host opined regarding the responsibility and liability of the parents allowing the child access to the firearm.

The Host explained the urgency surrounding the recall as the CDC has identified a total of 68 problematic cases across 16 states. There have been cases of vision loss, with several patients having their eyeballs surgically removed. She urged the audience to perform a due diligence of all eye drops from the referenced company.

However, the optics of such excessive spending in the light of poor school performance standards is not good.
