Issues and Programs

WSTQ/WIVQ covers a wide variety of subjects and issues that concern residents of the immediate and surrounding listening area. WSTQ/WIVQ lends a great deal of focus on issues that concern the rural landscape as well as urban areas, in hopes that there is not an alienation of a group or groups of people and their varying lifestyles.

Issue: Animal Welfare

"I am in favor of animal rights as well as human rights. That is the way of a whole human being." – Abraham Lincoln

Program: Pet of the Week. Broadcast several messages informing listeners about the Pet of the Week and encouraging listeners to adopt or to support local shelters. Aired 11/22 for one minute and fifteen seconds at 9:46am.

Program: Hunters in Illinois took a preliminary total of 76,232 deer during the seven-day 2023 Illinois firearm deer season that concluded Dec. 3, according to the Illinois Department of Natural Resources. That total is down from 76,854 in the previous firearm season. Bureau, La Salle, Putnam, Marshall and Livingston counties bucked the trend, each recording a harvest higher in 2023 than 2022. Statewide the preliminary totals for the second segment of the 2023 firearm season was 22,884, compared with 24,500 deer taken during the second part of the 2022 season. The preliminary totals for the first segment of this year's firearm season Nov. 17-19 was 53,348 deer. Remaining 2023-2024 deer hunting opportunities in Illinois include: Late-winter antlerless-only and chronic wasting disease season, in designated counties only, Dec. 28-31 and Jan. 12-14 and archery deer season continues through Jan. 14. Program: Country artist interview with a new Nashville band, BoomTown Saints promoting their music. Aired 11/7 at 9:06am for three minutes and fourty-six seconds.

Program: Community Coffee Convo segment where local people are interviewed to highlight things they do for their community. Interview with Jessica Kreissler of LaSalle's Lighted Way. Aired 1/5 at 9:11 am for three minutes and fifty seconds.

Issue: Charity

Charity is important in boosting up those who need help and improves the quality of life for the entire community.

Program: Talked about United Way in LaSalle's Labor of Love marking its 33rd year by providing free home repairs to 22 deserving homeowners in the community who cannot afford the needed work due to financial or physical issues. Broadcast story 10/4 at 8am. Length of fourty-two seconds.

Program: A rural tourism marketing workshop will be coming to IVCC. Pam Schallhorn, extension specialist in Community and Economic Development will be providing information from recent project completed by U of I and Illinois Extension called I-Rural Reimagining Illinois Rural Tourism through Community and Extension Collaboration. Program will be from 5:30pm – 6:30pm in room CTC124 at IVCC. Aired 10/9 at 7:32am for 36 seconds.

Issue: Community

Community organizations build a community bond and are an outlet for charitable giving in a town.

Program: Talked about United Way of Eastern La Salle County's Labor of Love will mark its 33rd year by providing free home repairs to 22 deserving homeowners in the community who cannot afford the needed work due to financial or physical limitations. Supported by Constellation Energy, Illinois Valley Building Trades, volunteers, and various organizations, Labor of Love continues its mission of community service on Saturday. Aired 10/4 at 6am, :30 seconds.

Program: SPRING VALLEY- Royalty was crowned at Hall High School as Gianni Guerrini and Cecilia Verucchi were named Homecoming King and Queen respectively. The crowning took place at Friday's football game with Luke Orlandi and Angela Garcia- Guerrero being named runners-up. Aired 10/5 at 5pm for 30 seconds.

Program: GRAND RIDGE - Lucille Alexander, a 13-year-old seventh-grader from Grand Ridge Grade School, discovered an 18-inch-by-6-inch, eight-pound fossil of a triceratops frill, estimated to be around 67 million years old, during a dig with her parents in the Badlands near Jordan, Montana. Alexander's passion for paleontology has been a lifelong pursuit. The fossil, named "Silver Dragon", was sent to the Grand Ridge school for use in science classes. Aired 11/6 at 7am for 30 seconds.

Program: LA SALLE - Hundreds participated in the inaugural Run Run Rudolph 5K Fun Run last night at Rotary Park in La Salle. La Salle Mayor Jeff Grove was excited about letting people from the community get a sneak peek at the display. The Celebration Of Lights is the area's largest drive-thru Christmas light display, stretching throughout Rotary Park on the east side of La Salle. It opens to vehicle traffic on Friday. Aired 11/6 at 5pm for 30 seconds.

Program: PRINCETON - The Light Up Princeton holiday display contest will be open to all residents and businesses with a Princeton address. There are seven categories, most of them with cash prizes. To enter, call the chamber by Monday, Dec. 11, at 815-875-2616. There is no cost to enter. Judging will take place on Dec. 18. Judging for People's Choice will take place on the Princeton chamber's Facebook page from Dec. 18 through Dec. 22. Aired 12/8 at 10am for 30 seconds.

Program: Contest Rules. Broadcast ninety-one thirty second messages reminding listeners of the contest rules. See Appendix G for broadcast times.

Issue: Economy

Program: Best Of North Central IL. Broadcast several messages informing listeners about the Best of North Central Illinois ballot and encouraging listeners to check out their favorite local business. Aired 9/12 for thirty seconds at 4:11pm, 10/22 for thirty seconds at 5:22pm, 11/21 for thirty seconds at 4:20pm, 12/31 for thirty seconds at 2:48pm.

Program: Marseilles City Council approved borrowing up to \$2.3 million to purchase and renovate the Illinois Valley Cellular building for a new City Hall and Police station. Aired 10/5 at 6am for 27 seconds.

Program: The Streator Onized Credit Union donated a check for \$1,500 Monday to the Woodland War Room Food Pantry. The Woodland War Room Food Pantry provides food, health care items and other essentials to families in need at Woodland. The War Room is funded by donations from the likes of SOCU, YMCA and several food drives throughout the year organized by Woodland's Junior High Student Council. Woodland officials extended a thank you to SOCU for the donation, which goes a long way in assisting the needs of students and families of Woodland. Aired 12/19 at 7:30am for 30 seconds.

Issue: Education

An Investment in Knowledge Pays The Best Interest – Benjamin Franklin

Program: OGLESBY - The Illinois Valley Community College's Jazz Ensemble and Wind Ensemble will kick off their fall seasons with separate concerts this week. The Jazz Ensemble's performance, featuring soloists, standards, and more, will be at 7 p.m. tomorrow, while the Wind Ensemble will take the stage at 7 p.m. on Thursday. Both concerts will be held at the Dr. Mary Margaret Weeg Cultural Centre and are free to attend. Aired 10/2 at 6:30am for 30 seconds.

Program: STREATOR - Streator High School's girls varsity soccer team will use the old baseball field at James Street Recreation Complex as their home ground this spring. The field has been prepared with an irrigation system, a new scoreboard, and turf maintenance. The school has entered into a 10-year agreement with the city to convert the unused football and baseball field into soccer fields, providing dedicated spaces for soccer programs and the potential for night games and full junior varsity matches. Aired 10/3 at 6am for 30 seconds.

Program: OTTAWA - Marquette Academy students will perform "Lily and the Magic Stones" on Friday and Saturday at Bader Gym in Ottawa. The story revolves around Lily's

adventures with magical stones and her battle against the evil Baron, offering important life lessons about facing problems and standing up for one's beliefs. Tickets are available at the door or the high school's main office, with reserved seats at \$8, general admission at \$7, and children and senior citizens at \$6. Aired 11/2 at 7:30am for 30 seconds.

Issue: Emergency Alert System

As a participating station in the EAS system, we receive and send tests and warnings.

Program: EAS tests. See attached document.

Issue: Employment

The current job market can be difficult to get into so knowing the fluctuations and changes regarding employment procedures can be an immense benefit.

Program: OGLESBY - The Oglesby City Council voted unanimously to task the Oglesby Ambulance Board with exploring solutions to staffing issues. They are considering hiring a consulting firm, such as McGrath Consulting in Indiana, to address the problem. Additionally, the Oglesby Police Department will implement e-ticketing to reduce officers' time on the roadside, and the council voted to update the ordinance concerning abandoned vehicles to reinforce the city's authority for towing such vehicles. Aired 11/7 at 6am for 30 seconds.

Program: The state awarded the Business Employment Skills Team \$452,000 for four projects in northwest central Illinois. The first project is placing computers and job search resources in area shelters and social service agencies for those unable to travel to BEST's workforce center or other facilities. The second project is a sprint youth career exploration event called "Work in the Real World." Participating companies will teach youths about occupations and related training across various industry sectors. A rural professional development conference is the third project. It will be centered on workforce professionals, educators and businesses with common needs to assist the current and future workforce. BEST also is dedicating \$200,000 of the funds to provide area residents – both youths and adults – who might not meet workforce development eligibility requirements with paid work experience. These opportunities will give participants up to 10 weeks paid work experience with the intent of providing an opportunity that leads to permanent paid employment. BEST locations in Oglesby, Mt. Carroll, Ottawa, Princeton, Sterling, Dixon and Oregon. Aired 12/19 at 8am for 30 seconds.

Program: Equal Employment Opportunity. Broadcast two thirty second messages informing listeners about equal employment opportunities at Shaw Local Radio. See Appendix A for broadcast times.

Program: Job Openings. Broadcast forty-eight, thirty second messages informing listeners about a job opening at Shaw Local Radio. See Appendix F for broadcast times.

Issue: Environmental Issues

With the importance of climate change, and with tourism dependent on 3 state parks in the area, environmental issues are important to local people.

Program: OTTAWA - La Salle County participates in FEMA's Community Rating System, an incentive program that rewards exceptional floodplain management practices. The county has a class 8 rating, resulting in approximately a 10% annual savings for homeowners with flood insurance in unincorporated areas. To maintain this rating, the county must annually review its flood mitigation strategies and provide public notice, with the 2023 strategies available for review at Lasalle County I.L. Dot GOV. Aired 11/7 at 8am for 20 seconds.

Program: An intense late-year storm barreled up the East Coast on Sunday with heavy rains and strong winds that shattered rainfall records, forced water rescues from flooded streets and washed-out holiday celebrations. Authorities rescued dozens of motorists stranded by floodwaters in South Carolina's waterfront community of Georgetown, Georgetown County spokesperson Jackie Broach said. More than 9 inches of rain fell in the area situated between Charleston and Myrtle Beach since late Saturday. Rising sea levels driven by human-caused climate change mean even relatively weak weather systems can now produce storm surges previously associated with hurricanes, said Meteorologist Jeff Masters, co-founder of the Weather Underground. In South Carolina that's worsened by natural subsidence along the coast. Aired 12/18 at 7am for 30 seconds.

Issue: Government

Government is important in society to prevent anarchy and it is beneficial to the population to be informed on what the government is doing.

Program: ANKARA - U.S. Secretary of State Antony Blinken traveled to Turkey yesterday to prevent the Israel-Gaza conflict from spreading to a regional battle. Blinken met with the Turkish Foreign Minister and both sides emphasized the importance of protecting civilians in Gaza and ensuring the flow of humanitarian assistance. The Turkish president did not meet with Blinken, but he condemned Israel's actions in Gaza and suspended planned talks with the Israeli Prime Minister. Aired 11/7 at 7am for 30 seconds.

Program: Former President Donald Trump returned to his [civil fraud trial](#) Thursday to spotlight his defense, renewing his complaints that the case is baseless and heaping praise on an accounting professor's testimony that backed him up. With testimony winding down after more than two months, the [Republican 2024 presidential front-runner](#) showed up to watch New York University accounting professor Eli Bartov. Even while campaigning to reclaim the presidency and fighting [four criminal cases](#), Trump is devoting a lot of attention to the New York trial. He's been a [frustrated onlooker](#), a [confrontational witness](#) and a heated commentator outside the courtroom door. Aired 12/8 at 6:30am for 30 seconds.

Program: President Biden, along with UAW President Shawn Fain and Governor Pritzker, celebrated the reopening of the Belvidere auto plant yesterday and the UAW contract that secured significant gains for auto workers. Biden spoke about his personal ties to the auto industry, his upbringing around automobiles, and his longstanding relationship with the UAW and acknowledging the challenges faced by communities when auto plants close down. Aired 11/10 at 8am for 30 seconds.

Issue: Health/Wellness

Health is very important – inarguably the most important issue to everyone individually.

Program: OSF St. Elizabeth Medical Center in Ottawa will host a community blood drive with ImpactLife tomorrow from 7:30 a.m. to noon and 1 to 5 p.m. at 1100 E. Norris Drive, inside Meeting Room 1. Donors must be at least 17 years old (16 with parental permission), weigh over 110 pounds, and provide a photo ID. All eligible donors, who last gave blood on or before Sept. 19, can participate, and they'll receive an ImpactLife promo voucher for an e-gift card or bonus points for an ImpactLife sweatshirt. Aired 11/13 at 7:30am for 30 seconds.

Program: Putnam County EMS has received a \$3,984 grant for radios thanks to Compeer Financial's Fund for Rural America, part of the Farm Credit cooperative's philanthropic initiative. Compeer has awarded 177 grants through its Emergency Response Equipment Program, including 15 collaboration grants for shared resources among various departments. These grants aim to ease the financial strain on essential equipment for rural emergency response departments, emphasizing the significance of teamwork among volunteer fire, rescue, and ambulance services when addressing emergencies in Compeer's territory. Aired 11/13 at 10am for 30 seconds.

Program: U.S. health officials recalled three more brands of whole and pre-cut cantaloupes Friday as the number of people sickened by salmonella more than doubled this week. Nearly 100 people in 32 states have gotten sick from the contaminated fruits. Arizona, Missouri, Minnesota, Wisconsin and Ohio have the highest number of cases. Two people have died of the infections in Minnesota, and 45 people are hospitalized nationwide. The U.S. Food and Drug Administration's original recall included Malichita brand whole cantaloupe, Vinyard brand pre-cut cantaloupe and ALDI whole cantaloupe and pre-cut fruit products. Rudy brand whole cantaloupes and Freshness Guaranteed brand and RaceTrac brand pre-cut cantaloupes joined the list Friday. Aired 11/28 at 7am for 30 seconds.

Program: Drive through flu clinic will be in Streator in partnership with the Livingston County and LaSalle County health departments. Offering regular flu shots for those under 65 years old and high-dose flu shots for those 65 and above. Aired 10/23 at 7am for 30 seconds.

Issue: Home and Lifestyle

Keeping one's home maintained in extreme Northern Illinois weather is an important priority, especially with our area's propensity to flood with such an undeveloped drainage system.

Program: The Streator City Council has approved the installation of a four-way stop sign at the intersection of 12th Street and Otter Creek Road to address concerns about speeding drivers along the newly-reconstructed road. The \$3.3 million project reconstructed a 1.22-mile stretch of 12th Street, with federal and state funds contributing to the funding. The decision to add the stop sign received unanimous approval from the council. Aired 10/23 at 7:30am for 30 seconds.

Program: The east side parking lot at Baker Lake in Peru will be closed for reconstruction from 7 a.m. to 3:30 p.m today. Visitors should utilize the west side parking lot during this time. The Peru City Council approved improvements to the east side lot, including adding 70 to 80 parking spots, paving, and striping, at a cost of around \$248,000. These enhancements will enhance safety by extending a sidewalk to connect to the park, eliminating the need for pedestrians to walk on Airport Road to access Baker Lake. Aired 10/25 at 8am for 30 seconds.

Issue: Taxes

Two things are inevitable – death and taxes. In this issue, we discuss the latter.

Issue: Tourism

Tourism is very important to the area for tourists coming in, as Starved Rock State Park is renowned as the “Crown Jewel” of the Illinois State Park System and draws many tourists on the weekends. And tourism from the area is important to our listeners because as Mark Twain once said, “Travel is fatal to prejudice, bigotry, and narrow-mindedness.”

Program: Ottawa's Heritage Harbor is a popular stop for boaters embarking on the Great Loop, a 6,000-mile journey through various waterways. This year, due to lock closures on the Illinois Waterway, more boaters are traveling in groups, making stops at the marina. The American Great Loop Cruisers Association and Heritage Harbor have coordinated efforts to ensure a smooth southward journey for these boaters, offering amenities and support along the way. Aired 10/26 at 8am for 30 seconds.

Program: The first ever 5K to be held at the Celebration of Lights in La Salle will be on Sunday, November 5th. Rotary Park will be filled with holiday light displays and joggers in the evening hours, as they kick off the Christmas season with a sneak peek of all the festive decorations. Shuttle buses will run from the Auditorium Ballroom in downtown La Salle for the free race. The 5K will step off at 5:30 p.m. under the lights, with walkers setting off shortly after. Aired 10/27 at 7am for 30 seconds.

Program: The Marshall-[Putnam](#) County Fair Board announced country musician Tracy Lawrence will be the headliner for the 2024 Marshall-Putnam Fair. Lawrence has sold

more than 13 million albums and charted 18 No. 1. hits. He recently performed to thousands of concert goers at Streator Fest last August. Lawrence has charted 40 singles and released two double platinum albums. Eight of his songs reached No. 1 on the country charts. Lawrence will be performing July 18 at the Marshall-Putnam County Fairgrounds in [Henry](#). Aired 12/6 at 6am for 30 seconds.

Issue: Traffic and Safety

Updating listeners on traffic, trouble spots, crime, and hazardous driving is an important function of our station.

Program: The east side parking lot at Baker Lake Park in Peru will be temporarily closed for maintenance today. From 7 a.m. to 3:30 p.m. paving and striping work is set to begin, along with a sidewalk extension from the south to help pedestrians get to Baker Lake. Aired 10/19 at 6:30am for 20 seconds.

Program: Fire officials are warning about the increased fire danger associated with Halloween and fall decorations, citing an annual average of 9,200 fires during the Halloween period from 2017 to 2019, resulting in 25 deaths, 100 injuries, and \$117 million in property loss. The National Fire Protection Association reports that decorations, often placed too close to heat sources like candles or equipment, are a common cause of these fires. To ensure a safe Halloween, experts recommend using battery-operated candles, avoiding long trailing costume fabrics, and teaching children to stay away from open flames, among other precautions. Aired 10/24 at 7am for 30 seconds.

Program: The [Peru](#) Police Department and the [La Salle County](#) Sheriff's Office are partnering with the Illinois Department of Transportation to spread the word about the dangers of impaired driving. Peru police and La Salle County Sheriff's Office announced Monday separately a Driver Sober or Get Pulled Over and "Drive High – Get a DUI enforcement campaign. From Dec. 15 through Jan. 2, law enforcement across Illinois will show zero tolerance for alcohol- and drug-impaired driving to keep our roads safe and help ensure a happy holiday season. According to the National Highway Traffic Safety Administration's Fatality Analysis Reporting System, in the United States in 2021, a total of 13,384 people were killed in motor vehicle crashes involving an alcohol-impaired driver. These fatalities are preventable, and drivers must remember that driving impaired – by alcohol, cannabis or any other substance, whether legal or not – is potentially deadly and illegal behavior. Aired 12/12 at 6am for 30 seconds.

Issue: Veterans

With the scandal about the treatment of the Veterans and VA facilities, and with multiple armed wars going on, treatment of servicemen and women is of importance to the community.

Program: For Veterans Day, the La Salle County Veterans Assistance Commission will spread awareness and support for our Veterans and Families by turning the lights green the week of November 6-11th. If you have an outside light, please change your light to green and leave it on for the week. The La Salle County VAC will have a limited amount of green light bulbs available for Veterans to come in and pick up for their personal use. If you would like to give green light bulbs to donate to our Veterans, please contact the La Salle County VAC. Aired 11/3 at 6:30am for 30 seconds.

Program: Veterans Day ceremonies are set to take place across La Salle, Bureau, and Putnam counties today through Sunday, officially marking the holiday on Saturday. The events commemorate the signing of the armistice ending World War I and honor all U.S. war veterans. Various towns, including Earlville, Ladd, La Salle, Oglesby, Leland, Ottawa, Marseilles, McNabb, Mendota, Peru, Princeton, Seneca, Sheridan, Spring Valley, and Streator, have planned ceremonies, parades, and programs to pay tribute to veterans. Aired 11/9 at 10am for 30 seconds.

Issue: Youth Issues

The education and well-being of the local population is ranked one of the most important issues of our population.

Program: The Princeton High School Drama Department will stage "12 Angry Jurors" on Friday at 7 p.m. and Sunday at 2 p.m. Tickets are \$7 for adults, \$5 for children, and free for PHS students with an ID. The play centers on the trial of a 19-year-old accused of fatally stabbing his father, with tensions rising as jurors re-examine testimonies and re-enact the murder, leading to an electrifying and suspenseful conclusion. Aired 11/19 at 7am for 30 seconds.

Program: [Illinois Valley Community College](#)'s Project Success led the way in collecting toys, food and supplies for animal shelters The Love of Pets in [Streator](#) and Safehouse Animal Rescue in [Dalzell](#) so that animals and staff could have an easier winter. The campaign, conducted throughout November, collected 166 items as well as monetary donations. Aired 12/5 at 6am for 30 seconds.

Program: The Seneca High School FFA is hosting an open house and calf sale at noon at the Seneca High School Land Lab in Marseilles on Saturday. An open house will begin at noon with the sales and auction beginning at 2 p.m. There will be around 25 steer and heifer calves up for auction. For more information, visit the Seneca FFA Facebook page. Aired 10/27 at 7:30 am for 30 seconds.
