ISSUES AND PROGRAMS REPORT

OVERVIEW

1. Job Market

The company "Yahoo" is set to lay off hundreds of workers in order to help boost the company's sagging stock, according to The New York Times. The exact amount of workers losing their jobs is unknown.

There are still some hurdles to clear, but a new clean energy plant in Gratiot County has taken a step forward tonight. Legislation to pave the way for the billion-dollar project has now been introduced. The new plant will create 200 permanent jobs, along with nearly a thousand temporary construction jobs.

Governor Granholm visited Flint today meeting with workers at the Powertrain South Plant, saying the engines made here will bring new jobs. The award-winning engines focus on fuel efficiency and alternative energy. The Governor is highlighting Flint to be an example for the State and the Nation.

Governor Granholm noted Dow Chemical Company's plans to re-furbish 8,600 square feet of unused industrial space at the Michigan Operations manufacturing site and also build 7,500 square feet of new space for the proposed facility. It would create 22 jobs.

A new study indicates Michigan is lagging behind other states in creating high-wage jobs that require a college degree. The study showed Michigan's per capita income dropped 10 places, to 26th in the nation in just 6 years.

The Bay County Sheriff's Department is looking for a few dozen good people to help keep peace on the Saginaw River and Bay in the summer.

A custodian's job is ranked as the fifth worst job in mid-Michigan. Business experts say pay is one of the problems, and the other deals with insurance. Ushering and working a

concession stand outrank custodian in the “worst job” list here in Michigan. Owning and operating a coffee shop is at the top of the list.

11PM LOC/NEWS 2/26/08 :20

Michigan is ranked number one in the country as the worst state in which to find work right now. The figures are based on unemployment rates, population and average wages for workers.

6PM LOC/NEWS 3/4/08 1:05

Dow AgroSciences announced it will move production of several current and future Dow AgroSciences products to Midland during the next two years. This project will result in approximately 20 news jobs at the Michigan operation.

6PM LOC/NEWS 3/7/08 1:35

Governor Granholm is in town talking about jobs. Her plans come as employers nationwide cut 63,000 jobs last month. That’s the most in 5 years is the starkest sign yet the country is heading dangerously toward recession, or is in one already. A new report from the Labor Department shows the nation’s unemployment is at 4.8 percent.

6PM LOC/NEWS 3/24/08 :20

A deal between the UAW and General Motors means some local workers will be laid off. A packaging company in Burton will lay off up to 60 workers next month as GM takes over some of the work done at the plant.

2. Economy/Business

5PM LOC/NEWS 1/9/08 1:17

This week there was little traffic and barren slopes at Apple Mountain, thanks to recent warm weather. Upcoming colder weather and snow in the forecast minimizes the impact the warm weather could have had on the local ski resort. The owner hopes the “big chill” will bring skiers and snow boarders out in droves.

6PM NAT/NEWS 1/18/08 1:30

President Bush is attempting to jumpstart the economy by giving consumers more money to spend. It’s a stimulus plan, highlighted by tax rebate checks. It will likely include an extension of unemployment benefits and temporary tax breaks for big business.

5PM NAT/NEWS 1/22/08 1:15

President Bush and Congress are racing to pass an economic package aimed at bringing the U.S. economy back to life. Both sides agree they need to move forward quickly, but there are many details to work out. A major challenge is to issue checks before May or June.

11PM LOC/NEWS 1/26/08 1:41
This weekend, Frankenmuth seems like the best place to spend some cash. People from all over mid-Michigan are here for Snowfest. Around this time of year, Rau's Old Country Store, in little Bavaria, is usually on the cold side of sales, but Snowfest has the habit of heating things up, bringing customers and dollars in to town.

6PM LOC/NEWS 2/14/08 :18
Bluewater Plastics, which has a facility in Caro, has filed for Chapter 11 bankruptcy. The company listed more than \$10 million in debt. This is the second Caro plastics company to file in the last couple of weeks.

WAKEUP LOC/NEWS 2/20/08 :22
Detroit Mayor Kwame Kilpatrick presented an economic stimulus plan to city council, which is his first appearance before them since the text message scandal involving him broke.

5PM LOC/NEWS 2/25/08 :12
A century-old business is closing its doors. Saginaw Photo confirmed to T5 it is going out of business. Its last day is March 1.

530PM NAT/NEWS 2/29/08 1:32
President Bush called on lawmakers to find a way to help homeowners struggling with their mortgages. The Federal Bank chairman indicated he is ready to lower interest rates again. But the president indicates he will veto a Democratic plan that would allow judges to reduce mortgage balances to what the home is actually worth.

5PM LOC/NEWS 3/11/08 1:12
More local UAW workers are sitting idle tonight as the American Axle strike continues. The two sides have been talking this week, but there is no movement toward settlement, says UAW President Ron Gettelfinger. The main sticking points are wages and benefit cuts.

NOON NAT/NEWS 3/13/08 1:30
Consumer spending is down, the dollar is at a record low, and gas prices are at a record high. Many economists now believe the country is already in recession. Many Americans struggle to pay home mortgages as those homes' value drops. Economists believe the wave of foreclosures triggered the current economic crunch.

5PM NAT/NEWS 3/16/08 1:37
Investors react to the demise of Bear Stearns. With the backing of the Federal Reserve, J.P. Morgan says it expects to cut half of Bear Stearns' 14,000 employees. In a surprise move over the weekend, the Federal Reserve also cut its lending rate to financial institutions by a quarter point. The repercussions of all of this negative financial news

extend far beyond Wall Street. It affects retirements, interest money ears and even future job prospects. The IRS has announced it will begin sending the first stimulus payments at the beginning of May.

530PM NAT/NEWS 3/27/08 1:21
A newly released Commerce Department report shows new home sales fell to a 13-year low in February. Factory orders for big ticket items are also down. President Bush says the economy will turn around after many Americans get tax rebate checks in May. Some analysts say it's better for consumers to invest or pay off debt.

3. Crime

5PM LOC/NEWS 1/2/08 1:27
Midland Police caught up with Jacquelyn King after her last alleged robbery of the Chemical Bank on M-20. The 60-year-old woman is accused of robbing three banks in less than month. She is accused of taking \$13,000 and being armed with a knife for one of the robberies. A million dollar bond has been set.

11PM LOC/NEWS 1/25/08 1:10
Flint police say security pictures show a suspect handing a note to a bank teller at the Citizens Bank on Saginaw Street, demanding money. Witnesses say the man was well-dressed and made little effort to hide his face. Police are not saying how much money was stolen, and are hoping someone may recognize the person.

5PM LOC/NEWS 1/28/08 1:27
Saginaw Police have yet to see a homicide within city limits since the new year started. Last year there were already two homicides, after a triple shooting on the East side. It is felt assistance from the State Police and more police presence with the implementation of 12-hour shifts may be part of the reason for the decreased crime.

6PM LOC/NEWS 1/29/08 1:25
A Flint boxer was pulled over and arrested for a bank robbery yesterday. Today he has been released from jail, pending further investigation. His grandfather claimed they pulled over the wrong man. His attorney says the boxer was on his way to the hospital for cancer treatment. For now police have no one in custody for the robbery and it remains under investigation.

WEEKEND WAKEUP LOC/NEWS 2/8/08 1:33
In Missouri, during a city council meeting, an upset citizen interrupted the meeting with gunfire, injuring several people. A current Saginaw city councilman remembered a Saginaw council meeting in 1989 where a belligerent citizen was removed from a meeting, and the proceeded to open fire at City Hall windows. No one was injured, but the incident served notice to future council members about what could happen.

11PM LOC/NEWS 2/25/08 1:02

Several recent bank robberies in Midland have residents guessing why this crime has been so popular lately. Recent research suggests an increase in the unemployment rate, increases the rate of bank robberies.

11PM LOC/NEWS 2/25/08 1:15

A bomb threat emptied out the Saginaw County building yesterday, even bringing some court cases to a halt. Nothing was found, but the Saginaw County Sheriff says these threats have to be treated as real, because you never know. Police say they're closing in on the person who made the phone call.

6PM LOC/NEWS 2/26/08 1:41

Police say it appears three people broke into a hardware/party store early this morning stealing candy, cigarettes and ammunition. It is believe the store was targeted because of its rural location. Less than 500 people live in the small local town of Ashley, in Gratiot County. A \$1,000 reward is being offered.

6PM LOC/NEWS 3/1/08 1:30

A drive-by shooting injured a 50-year-old Essexville man who was shot in the arm, near a local business. The owner of the store says he and his employees were gone when the shooting happened and feels it is unfortunate that this had to happen. Police do not have anyone in custody, and the victim is expected to be okay.

5PM LOC/NEWS 3/10/08 1:35

Bay County investigators say their suspected rapist-arsonist-attempted murderer is in custody in Charlevoix. He was on parole there for another crime. The suspect randomly stopped at The Green Spa in November, 2003 where he terrorized two workers, after robbing them of all their cash. He is now facing possible life sentencing.

11PM LOC/NEWS 3/10/08 1:10

A woman and her daughter are dead today—shot by the older woman's boyfriend. That man called the Sanilac County Sheriff's department and confessed to killing them. News of the murders spread quickly; police say the suspect had been in trouble with the law before, but nothing of this magnitude.

5PM LOC/NEWS 3/16/08 1:21

Over the weekend, thieves hit apartment complexes in Hampton Township, in Bay County removing catalytic converters from parked cars, which can bring up to \$100 per item from scrapyards. Police have increased patrols in the areas most likely targeted.

11PM LOC/NEWS 3/24/08 1:10
Motorists discovered a dead body by the side of a road. Neighbors say they heard gunshots in the early evening. Police are unclear if the incident happened at the location, or if the body was dumped there. This is the third homicide for the City of Saginaw.

4. Politics

530PM NAT/NEWS 1/9/08 1:30
Shaking off a loss Barack Obama's campaign pushes forward. Hillary used the day to Re-organize and savor her win—one that the pollsters said wasn't going to happen John Edwards has yet to taste victory. He was a distant third in New Hampshire. John McCain had a rousing New Hampshire win, and just finished campaigning in Michigan. The Republican race is wide open.

530PM NAT/NEWS 1/21/08 1:33
Barack Obama paid tribute to Dr. Martin Luther King in Columbia, South Carolina. At a rally honoring King, Obama was joined by fellow Democrats John Edwards and Hillary Clinton. Republican presidential hopefuls now focus on Florida.

NOON LOC/NEWS 1/24/08 :24
The Detroit Free Press reports the married Mayor of Detroit exchanged romantic and sexually-oriented text messages with a top aide. The Free Press says it examined about 14,000 text messages on pages and found many examples of a tie between the aid and mayor. There is no word yet of if or when a probe will happen.

11PM LOC/NEWS 1/24/08 1:25
Instead of facing several years in prison, former mayor, Wilmer Jones Ham McZee looks forward to a couple of years on probation. She declined to comment on the sentence, but her supporters shared their thoughts on the case, and, as they see it, a breach of justice. McZee's lawyer says they plan to appeal.

NOON NAT/NEWS 1/30/08 1:35
John Edwards is calling it quits. The former North Carolina senator failed to win any of this year's early nominating contests and is ending his bid for the White House. And so is Rudy Giuliani, after his disappointing third place finish in last night's Florida primary. John McCain now has the momentum heading into Super Tuesday.

11PM NAT/NEWS 2/2/08 1:46
The remaining candidates vying for the Republican and Democratic presidential nominations fanned out across the U.S. to make their well-worn stump speeches before crowds. With 21 Republican contests on Tuesday, there is still much work to be done on the campaign trail.

530PM NAT/NEWS 2/7/08 1:28
A disappointing Super Tuesday sealed Mitt Romney's fate. Senator McCain emerged on top and Mike Huckabee picked up more states than expected. With Romney out of the picture, McCain is reading out to staunch conservatives, many of who are skeptical of his voting record.

11PM LOC/NEWS 2/13/08 :28
The Toledo Mayor who turned away a squad of Michigan-based Marines is now taking fire from Veterans groups. The Grand Rapids-based group were headed to Toledo for training exercises. The mayor says he didn't know the Toledo Police had approved the Training exercise until shortly before the Marines arrived.

11PM NAT/NEWS 2/17/08 1:29
Barack Obama took a detour from the campaign trail today. He flew, in secret to North Carolina to talk with former opponent John Edwards. Both Obama and Hillary Clinton have been courting Edwards for his endorsement. So far he's been silent on the matter. The first President Bush is expected to endorse John McCain for the presidency soon.

11PM NAT/NEWS 2/28/08 1:36
Hillary Clinton may be trailing in the polls, but her financial supporters have not forgotten her. The New York Senator's campaign says she'll raise \$35 million in February. Barack Obama's campaign says his fundraising this past month will surpass Clinton's, but the Illinois senator gave no specifics.

NOON NAT/NEWS 3/4/08 1:25
Voters were out early in Texas, and analysts predict a record turnout, due to a combative Democratic race. Voters are also casting ballots in Ohio, Vermont and Rhode Island. A strong showing today by Senator John McCain could net him his party's nomination and end his cordial GOP race with Mike Huckabee.

530PM NAT/NEWS 3/10/08 1:30
The Democrats running for president know every delegate is worth fighting for. Obama is campaigning in Mississippi. Hillary Clinton is focusing on Pennsylvania, while her husband rallies the voters in Mississippi. Democrats are now raising money for a do-over in Florida and Michigan. Both states were stripped of their delegates for moving up their primaries.

11PM LOC/NEWS 3/24/08 1:45
The Detroit mayor and his former chief of staff turned themselves in to police today. Kilpatrick is charged in an 8-count indictment that says he lied about an affair with his top aide. On the witness stand both of them denied being intimate, but then text messages surfaced in a lawsuit filed by police. The mayor claims he looks forward to "complete exoneration" once all the facts have been brought forth.

530PM NAT/NEWS 3/25/08 1:35
Barack Obama is right heavy into campaigning, taking shots at his main rival. Democrats worry it could damage their party, come November. For his part, John McCain can sit back and watch the Democrats fight it out while he stays on task, talking about foreign policy and the war on terror.

5. Health

6PM LOC/NEWS 1/7/08 1:45
In 2006, the nurses at Healthsource joined the United Steelworkers, and have been negotiating a contract ever since. Now, after 15 months and nearly 40 meetings at the bargaining table, the nurses here decided the community need to become aware of their situation. President of Healthsource agrees with the workers, saying he wishes the issues had been resolved a long time ago. Bargaining continues in mid-January.

11PM LOC/NEWS 1/7/08 1:15
After the Christmas holidays, the blood supply needed re-stocking for area hospitals. Today begins the 19th annual blood drive at Fashion Square Mall in Saginaw. Many volunteers are frequent donors, giving as often as they can, but today's drive did bring out first time donors too.

11PM LOC/NEWS 1/9/08 1:16
Flint Mayor Don Williamson was rushed to a local hospital with breathing problems today. He is still in charge, however, doing business from his hospital bed. Should he be unable to manage city affairs, the city administrator would take over those duties until the mayor recovers.

5PM LOC/NEWS 1/28/08 1:26
Local emergency rooms are being crowded with people coming with the yearly cold or flu. Doctors are seeing people with respiratory illnesses, wheezing, coughing, and a lot of flu. A lot of these viruses typically come through in the winter months. Doctors recommend staying home if you are ill, do not share anything with other people and get plenty of rest.

TV5 is sponsoring a phone bank today to help raise heart health awareness. A panel of experts are here to answer phone calls. They include an LPN, cardiologist, and directors from the American Heart Association.

6PM NAT/NEWS 2/12/08 :28
New research indicates that even people who develop heart disease, or diabetes late in life, can reach 100 years old. Roughly two-thirds of those reach the century mark had avoided age-related ailments.

6PM LOC/NEWS 2/22/08 :24
The UAW and attorneys for several General Motors retirees sued GM to get court approval of a plan to shift billions in retiree health care costs to an independent trust fund. GM says the trust would make them more competitive.

TV5 is hosting a phone bank to give viewers the facts needed to fight one of the more common forms of cancer. March is Colo-Rectal Cancer Awareness month and the American Cancer Society has provided a panel of experts to answer viewer questions.

5PM NAT/NEWS 3/6/08 :19
The U.S. Army says depression numbers are up for troops in Afghanistan, because of increasing violence. The annual battlefield study shows soldiers on their third and fourth tours of duty have greater rates of mental health problems.

6PM LOC/NEWS 3/12/08 1:18
The powder sent by mail with a threatening letter to a Flint Citizens Bank this morning isn't anthrax. Nor is it ricin, or radioactive material, but something you'd use in custard, gravy or pudding. It's cornstarch. Hazmat crews say they guessed the powdery substance was probably benign, authorities still locked the bank up until the product could be positively identified. The cost involved in closing the bank and utilizing various emergency crews was estimated at \$10,000.

530PM LOC/NEWS 3/17/08 :29
Flint's Food Bank of Eastern Michigan received a gift of \$25,000 from A T & T for their work in the area. The contribution will help provide resources for education programs and job skills development in the Flint community.

6PM LOC/NEWS 3/28/08 :28
A severe blood shortage is forcing The Saginaw Red Cross into holding a blood drive. This is only the second time a blood drive has been held at that facility. Usually Michigan Community Blood centers hold the drives. The Red Cross supplies blood to Genesee County and the Saginaw Veterans Administration Hospital. They also supply a back-up in case the Michigan Community centers can't fill the local need.

6. War in Iraq

6PM LOC/NEWS 1/4/08 1:51
This memorial stands at the Flint National Guard Armory, in honor of members of the 125th killed, serving our country. Now, their battalion is getting ready to sacrifice time serving in combat again. There will be a special send-off ceremony at the Armory in honor of all leaving to serve.

11PM LOC/NEWS 1/5/08 1:18
A suburban Detroit family lost their loved one in Iraq, and now they have asked to adopt the dog their son worked with overseas. Having the dog will help keep their son's memory alive, say the parents, making the grieving process a little easier.

WEEKEND WAKEUP LOC/NEWS 1/12/08 1:30
A group of expectant loved ones waited at MBS Airport, all in gratitude of his service to the United States. The soldier spent 15 months in Iraq. The celebration continues back in Coleman at a local church where a reception was held. More friends and supporters gave words of encouragement and thanks to the soldier for his service in Iraq.

5PM LOC/NEWS 1/31/08 :17
After 15 months, nearly a dozen soldiers from the Bay City Armory are coming home. They are among the 170 Michigan National Guard soldiers returning to a base in Detroit.

530PM NAT/NEWS 2/4/08 1:20
Iraqi forces stepped up security south of Baghdad after the deadliest accidental attack on Iraqi civilians by the U.S. military in months. It happened when ground forces called in air support after a convoy came under fire. A U.S. fighter bombed two houses, killing two women and a child. The deadly incident sparked outrage among local residents.

11PM LOC/NEWS 2/11/08 :27
A local hero is honored today with the nation's fourth highest heroism award. The marine earned the Bronze Star medal when he left cover of his own vehicle, even though he too was wounded, to aid a fallen marine. Despite his efforts, the platoon sergeant died.

530PM LOC/NEWS 2/18/08 1:30
A local soldier was greeted today by family and friends at Flint Bishop Airport. The family is from the Burton area. The soldier has been in Iraq for 18 months, and is on leave for 18 days. This is his sixth overall combat tour.

WAKEUP NAT/NEWS 2/22/08 1:13
An elite Army unit rehearses the next mission for the surge—not the troop surge, however. The Army rock band called The Surge consists of one professional army musician, a satellite technician, a transportation expert, communications guy, and a mapping specialist. One of their biggest fans is a senior general who makes sure The Surge has their own choppers and work full time as military rock and rollers. The brass feels the band helps lift troop morale, and the soldiers agree. The Surge plays up to four shows a week around Iraq; and so far, their battlefield tour is open ended.

11PM LOC/NEWS 3/16/08 1:30
A little girl thought she had a new bike waiting for her inside this huge box; but instead there was someone much more valuable. Since last May, Glenn Johnson (Daddy) has been serving in Guantanamo Bay. His daughter, Amber's, only birthday wish was for him to make it home. After an abundance of paperwork between mom and the military, Amber was able to get her wish.

WAKEUP LOC/NEWS 3/18/08 :22
In Flint, a member of the State Police was honored for service in Iraq. Sgt. First Class Michael Troutt received 7 different awards, including the Army Achievement Medal. Troutt trained troops heading to Iraq.

6PM NAT/NEWS 3/19/08 1:29
It has been five years since the United States entered a, now widely unpopular, war. Protesters point out the war has cost nearly 4,000 troops their lives and taxpayers roughly half a trillion dollars. The President said he won't make any decisions on future troop levels until the top U.S. Commander in Iraq testifies before Congress in April.

WAKEUP LOC/NEWS 3/26/08 :33
A former Michigan Congressman is in trouble as Federal prosecutors say he was one of three men who went on a trip to Iraq, that was secretly paid for by Saddam Hussein. Right now there is no indication the lawmakers knew the trip was underwritten by Hussein; therefore, they are not named in the indictment.

7. Weather

530PM LOC/NEWS 1/3/08 1:23
Some students couldn't wait to get back to class after the long holiday break; some were ready for the cold weather with appropriate outer wear. The best way to stay out of cold weather trouble is to spot it before it happens, and enjoy what winter has to offer. Dress warmly, winterize your vehicles and check ice thickness before you walk out on it.

6PM LOC/NEWS 1/9/08 1:18
Sales for ice fishing products have definitely cooled down since the weather warmed up in mid-Michigan. Record high temperatures opened up bays and melted any chance for ice fishing. Folks at Frank's Great Outdoors are hoping for cold weather to bring the ice back on the bay.

11PM LOC/NEWS 1/19/08 1:12
Leaving your pet out in the cold, whether it's a dog or cat, is okay, if it's not out for too long. The rule of thumb is, if it's cold for you, it's cold for them too. Once temperatures drop into single digits, very few house pets can survive the bitter cold. The State of

Michigan requires that any dog that remains outside for a long period of time, must have adequate shelter.

5PM LOC/NEWS 1/24/08 1:17
This morning, Bay City firefighters were called to a house on Broadway to battle the flames. On days like this, working in the winter weather is as much of an ordeal as the fire. Firefighters say they don't think about the cold, and what helps, is that they layer underneath, which is key to dressing for frigid temperatures.

6PM LOC/NEWS 1/26/08 1:38
Tackling the cold weather to admire the sculptures at the annual Zehnder's Snowfest requires warm weather gear. Coupled with the proper clothing, many people stopped by the warming tent. One sculptor said he doesn't need a patio heater to keep warm—he just keeps moving. The weather is perfect for those competing, however, a nice hot cup of cocoa at the end of the day will chase away any lingering chills.

This collapsed carport in Flint Township was damaged by the high winds that roared into mid-Michigan overnight. Road crews are out laying down salt working around rolling garbage cans knocked over by those same high winds mentioned earlier. A Pittsburgh Steelers linebacker wants to help with funeral expenses for a 10-year-old boy who died after falling through ice on the Rouge River last week. The boy fell through the ice when he and two friends were playing behind a K-mart store.

Thirty rescuers from the Detroit Police and fire departments, as well as the Coast Guard, searched the scene, after the incident, with no luck. The football player wishes to help as he could relate to the story because he used to play on the frozen river too.

Sex offenders have one more day to verify their addresses, under the Michigan Sex Offender Registration Act. If offenders fail to register they'll likely go to jail. Addresses must be verified the first 15 days in April, July and October.

It took a jury 90 minutes to convict a Mt. Pleasant man for sexually abusing an 8-year-old girl. A 46-year-old man was found guilty on 5 counts of first degree CSC, and 5 counts of second degree CSC. He faces life in prison and is sentenced next month.

6PM LOC/NEWS 1/31/08 1:27
A Harrison middle school math teacher is facing charges of child abuse and lewd and lascivious conduct. Police say he made inappropriate comments to a 12-year-old female student while school was in session. He's also accused of dropping a pencil down her shirt. The School District told TV5 the teacher "no longer teaches here. The District won't tolerate misconduct in any way."

530PM LOC/NEWS 2/13/08 :17
A Milford area father is sentenced for pushing his daughter into prostitution. The father was sentenced to 60 years for first degree CSC. He was convicted of sexually abusing his teen-age daughter and pushing her to advertise as an escort on-line.

5PM LOC/NEWS 2/14/08 1:24
A Flint police inspector is accused of misconduct in office. Investigators say the inspector pulled a woman over at an intersection, took her away in his squad car, then had sex with her. The woman did not know the inspector before the encounter. The man has a clean record up to this point, and is a member of the Mayor's Citizen's Service Bureau. If convicted the man could face 5 years in prison and \$10,000 in fines.

11PM LOC/NEWS 2/25/08 :15
A 21-year-old Gratiot County man is sentenced today for molesting a 4-year-old girl. He fled to Maryland, but was tracked down and brought back to serve at least 23 months in prison for the incident.

530PM LOC/NEWS 2/27/08 :20
A Bay City man has been charged with sexually assaulting young boys. The 60-year-old man was charged with two counts of rape. The suspect claimed to police he had "helped over 69 young men in the past 30 years." He could face up to life in prison.

6PM LOC/NEWS 3/5/08 1:31
A woman heading to work at a local hospital took a wrong turn and ended up in a neighborhood where she was surrounded by 3 or 4 black men who sexually assaulted her. Hospital officials say the victim drove herself to work after the attack, notified security and was immediately taken to the emergency room. Hospital officials caution employees to be aware of their surroundings. Police are in the process of interviewing the victim.

630PM LOC/NEWS 3/9/08 :26
Three women are suing the Flint-based Food Bank of Eastern Michigan for sexual harassment by the group's president. The Vice-President says the organization is re-examining its sexual harassment policy in the wake of the allegations.

11PM LOC/NEWS 3/20/05 :15
A 23-year-old mid-Michigan man is behind bars after e-mails he sent were intercepted. Those e-mails contained material that showed sexual child abuse. The Gaines Township man's home was searched and his computer has been seized.

5PM NAT/NEWS 3/21/05 :28
A registered sex offender is running for mayor in the small town of Texas. The candidate was arrested four years ago when he was arrested for soliciting sex from a

minor. The current mayor is urging people to vote against his opponent, saying his election would cast a dark shadow on the town.

10. School/Campus – Improvements/Security

6PM LOC/NEWS 1/3/08 :30
The Saginaw High Marching Trojans played during half-time at the New Year's game in New Orleans, and got home late today. The band was invited to play after a representative from "The Bowl Games of America" saw the students perform last year.

Severe weather has the Saginaw City School District assessing whether or not to close school in the morning. According to administration there are about 10,000 kids in the Saginaw School District, and 8,000 of them walk to and from school every day. The "no school" procedure can get complicated and the District has not yet made a decision.

The main difference with tonight's game at Saginaw High was an increased police presence. Every other security measure was routine, like the metal detector at the main entrance. A psychiatrist who examined Priven said that the murder was committed during a psychotic episode and that he was no longer a threat to anyone. With that diagnosis, Priven was free and returned to Brooklyn. 48 HOURS MYSTERY: "Fight For The Truth" (10:00-11:00p) - a followup to "Prime Suspect" (OAD: 04/07/04, updated 03/12/05 and 07/15/06), a report on Marty Tankleff, who as a 17-year-old, was convicted of murdering his adoptive parents Seymour and Arlene Tankleff in their Bell Terre, Long Island home. Marty initially confessed, but quickly recanted. He has fought for years for his innocence, especially as new witnesses have surfaced who could potentially exonerate him. On December 19, 2007, 17 years after Marty went to prison, the Court overturned his conviction and he was released, pending a new trial. Just six days after his release, the Suffolk County D.A. announced he intended to drop all charges and it was announced the prosecution against Mary Tankleff was over. Marty's celebration is tempered by the fact that New York's governor has asked for a special prosecutor to investigate the case; in the meantime, he is a free man, about to start college. 48 HOURS MYSTERY: "Trigger Point" - In May 2004, Jenny Eisenman, an elementary school teacher and mother from Houston, Texas, shot and killed her estranged husband Drew in her apartment. She claimed that she had suffered abuse at the hands of her husband for years and that the shooting was in self-defense. However, based on her erratic behavior and her own confession just hours after the crime had occurred, prosecutors believed that Jenny was a woman scorned and had shot her husband out of anger. Prosecutors questioned why immediately after she had shot Drew, she went shopping at Wal-Mart, where she purchased several suspicious items; why she cleaned and made repairs to her apartment before police arrived; why Drew's body was placed in a storage bin and dragged outside; and why hours went by before she dialed 911. Based on testimony and the fact that her defense attorney never called an expert in domestic violence, Jenny was found guilty of murder and sentenced to 23 years in prison. After the trial, Correspondent Richard Schlesinger met with seven members of the jury, who stated that had they been permitted to hear testimony regarding her life with Drew, it may have affected the outcome. Two things helped police to crack the case: a call in 2002 from a woman who identified her uncle as the murderer and the use of forensic technology unavailable at the time of the crimes. Finally, investigators were able to track down the killer -- Gerald Mason -- an unsuspecting 69-year-old family man living in Columbia, S.C. Having pled guilty to murder, Mason was sentenced to prison and will be eligible for parole in 2017. Includes an interview with Darren R. Levine, Deputy District Attorney of Los Angeles County as well as other officers who were involved in the case. In St. Bernard Parish, just southeast of New Orleans, thousands had evacuated the region, but others had stayed behind to shelter in place, including the residents, staff, and operators of St. Rita's Nursing Home, Sal and Mabel Mangano. The Mangano's and their staff saved 24 of the residents and got them to safety, but the wall of water and its aftermath left 35 of the residents dead. But when the bodies were discovered at the nursing home, no one thought of the Manganos as heroes. Having been evacuated to Texas, Sal and Mabel returned to Louisiana, where they were each arrested and charged with 35 counts of negligent homicide and 24 counts of cruelty to the infirm. Prosecutors claimed that the Manganos had no intention of evacuating, based on the inadequate evacuation plan on file with the state; the fact that the other three nursing homes in the parish had made the decision to evacuate; that the parish government adequately stressed the importance of evacuation; that telephone calls made by parish officials to the Manganos went unheeded; and that the Manganos turned down an offer of buses to help evacuate their residents. At the trial, several family members of the deceased testified that the Manganos had told them they would evacuate the nursing home before Hurricane Katrina struck - something both Sal and Mabel deny. The defense strategy was to make the trial about the government failures that led to the flooding of St. Bernard Parish -- and it was successful: they were both found not guilty on 118 counts. Eventually, a pair of judges reviewed the case and the charges against the Aisenbergs were dropped. The couple still believe that Sabrina will be found alive and returned to them. Nona's boyfriend Kevin Jones said he had been trying to reach her numerous times by phone but that his calls and messages had gone unanswered. Eventually, he and his mother decided to stop by Nona's apartment, where they discovered Nona's body. Police determined that she had been murdered, beaten to death with the heavy metal base of a floor lamp and left in her blood-spattered living room. Investigators questioned Kevin and he agreed to take a polygraph, which he failed. That, along with Kevin's palm print in Nona's blood on the murder weapon, kept the investigation focused on Kevin. Police believed that he flew into a murderous rage when he discovered a condom wrapper on her kitchen counter. After police questioned and cleared Nona's other sexual partners, Kevin became their only suspect. At the trial, prosecutors based their case on the blood evidence found on the light bulb. However, the texture of the blood was crucial to the case and police described it as being tacky. That description supported the defense claim that the print was left when Nona's body was discovered and was still sticky when police arrived at the crime scene. The jury agreed and Kevin Jones was found not guilty. Recently, Kevin's defense team found a match to the DNA found on the condom wrapper and a special prosecutor has been appointed to look into the case. 48 HOURS MYSTERY: "Rage On The Run" (9:00-10:00p) - bodybuilder David Bieber of Ft. Myers, Florida starting using steroids in high school and as an adult began selling them to support his expensive career. He went into business with fellow bodybuilder Markus Mueller, a German who was able to smuggle the drugs into the U.S. from Europe. Bieber had an affair with Mueller's girlfriend, Danielle LaBelle, and subsequently married her. In February 1995, Bieber drove LaBelle to Mueller's home to retrieve her purse while he waited in the car. When LaBelle found Mueller dead in the doorway she suspected that Bieber had killed him. Two men admitted to police that Bieber had hired them to kill Mueller, but before he could be arrested, Bieber disappeared. He bought the birth certificate of a deceased child, Nathan Wayne Coleman, took on his identity and, in 1996, fled to Leeds, England where he was undiscovered for almost eight years. On December 26, 2003, Leeds police apprehended a stolen car; the driver was Bieber. In the process of being handcuffed, he opened fire on the three unarmed arresting officers and escaped. One officer died of his wounds and a nationwide manhunt was launched. Bieber was finally caught, was tried for the murder of the police officer, and sentenced to life in prison. Danielle LaBelle divorced Bieber in 2003. There are no plans to try him for the murder of Markus Mueller. 48 HOURS MYSTERY: "Addicted To Love" (10:00-11:00p) - When police arrived at the Franklin, Tennessee apartment of Lesa Buchanan on the Fourth of July weekend in 2005, they were surprised by what they found in her home: a cache of prescription drugs and sex toys. Lesa and her boyfriend, Dr. Christ Koulis, had spent most of that final weekend in her bedroom, having sex. Koulis, a plastic surgeon, had called 911 when she stopped breathing, and said he performed CPR, but that there was no pulse. When Lesa was rushed to the emergency room, the doctors trying to save her life said Dr. Koulis told them nothing about the drugs she had been using -- information that could have been crucial in saving her life. With Lesa dead, investigators quickly focused on drugs. At her apartment, detectives discovered used syringes with traces of oxycodone -- a powerful narcotic used to kill pain and available only from a prescribing physician. After a five month investigation, Dr. Koulis was arrested on four charges -- ranging from simple assault to second degree murder. At the trial, prosecutors alleged Dr. Koulis had injected Lesa with oxycodone during the course of the weekend, which eventually led to her death. But the defense claimed Lesa injected herself, and that she had a drug problem - a claim her family and investigators disputed. Ultimately, Dr. Koulis was found guilty of criminally negligent homicide. He will likely remain free until 2009, pending his appeal. (C: Troy Roberts - P: Ira Sutow, Taigi Smith)

Police suspect a serial killer but clues in the case have led to little information. As of now, no one has been arrested or charged in the homicides. A person of interest, Terry Oleson, a handyman who lived at the motel and worked odd jobs to pay the rent, has been arrested for an unrelated offense - videotaping a minor in the nude with a hidden camera. His house has been searched and he has now been asked to provide DNA samples. (C: Harold Dow - P: Miguel Sancho) (OAD: 05/19/07 - includes an update.)

02/23/08 **48 HOURS MYSTERY: "The McGuire Diaries" (10:00-11:00p)** - Melanie McGuire, on trial for the murder of her husband Bill, was provided by 48 HOURS MYSTERY with a video camera, so that she could record her intimate thoughts as she stood trial. Excerpts of her video diary are interspersed throughout the broadcast. In May of 2004, his dismembered body was found in three suitcases in Chesapeake Bay. He had been shot with a .38 caliber gun. Melanie claimed that Bill had vanished weeks before, after an argument. She had never filed a missing person's report and without having heard from Bill, she later filed for divorce. She claimed that he had been abusive and suggested that his disappearance and murder were the result of his gambling problem and that his frequent trips to Atlantic City had put him in contact with shady characters. However, a blanket wrapped around Bill's torso was the same kind of blanket used at the fertility clinic where Melanie worked as a nurse, making her a suspect. After extensive searches, police were unable to find a murder weapon or tool used to cut up Bill's body, and there was no evidence of a crime scene. Soon afterwards, police learned that Melanie had purchased a Taurus .38 special revolver just 48 hours before Bill had disappeared. Melanie, however, claimed that she had purchased that gun for Bill at his own request. She claimed he wanted it for his own protection, but couldn't buy it himself because of a felony conviction. Believing her to be guilty, Prosecutor Patti Prezioso intensified her investigation and had Melanie put under surveillance. This soon revealed two of Melanie's secrets -- she had been carrying on an affair for more than two years with her boss, Dr. Brad Miller, and she had been in Atlantic City the night after she claimed Bill had left her. She later stated that she had gone to Atlantic City in search of Bill, had found his car and moved it out of spite. Thirteen months after the suitcases were found, Melanie McGuire was arrested for the murder of her husband. Nine months after her arrest, the trial began. After seven weeks and more than seventy witnesses, Melanie McGuire was found guilty and sentenced to life in prison. She will be eligible for parole in 2073, when she would be 100 years old.
