ISSUES AND PROGRAMS REPORT

OVERVIEW

1. Job Market

In Michigan there are 11,000 fewer workers today than this time last year. Unemployment in the state is hovering right around 12.8 percent. Finding a job right now is just about impossible. Michigan Works! personnel say the job fields that are hiring are in solar, health care, truck driving and specialized construction..

Governor Granholm signed legislation extending unemployment insurance benefits. The legislation provides jobless workers with up to 7 additional weeks of benefits, for a total of 79 weeks.

General Motors announced approximately 1,600 autoworkers will lose their jobs by the end of the week. About 30 of those jobs lost come the Saginaw area. GM is living on a \$13.4 billion government loan and faces a June 1 deadline to cut costs.

More than 2 dozen white-collar workers at Saginaw's Metal Casting Operations wake up without a job today. Published reports indicate GM officials escorted the 25 employees out of their offices at the Powertrain Division on North Washington some time yesterday.

The Detroit News is reporting that GM will force between 1,000 and 1,200 under-performing dealerships nationwide to close, as part of its re-structuring plan. GM reportedly wants to close a total of 2,600 dealerships by the end of next year.

Thousands of Michigan's unemployed are still waiting for this week's check, due to a computer error. The State says a computer glitch delayed payments only for those people who contacted "Marvin" on Monday. Checks have now been mailed and benefits directly deposited into most accounts by Friday morning.

Michigan State Police say 18 troopers will be let go from several posts within Mid-Michigan. The heaviest hit is in the Flint post with 5 jobs lost. A total of 100 trooper jobs will be lost statewide, effective June 28.

11PM LOC/NEWS 5/8/09 1:31
The Auto Recovery Director travels to Mid-Michigan to hear from local leaders and auto workers about the impact of the industry's sharp downturn. He stops at a Flint engine plant, and then to a town hall meeting, where political, community and business leaders present what it's like to do business in an auto-reliant community and state.

NOON LOC/NEWS 5/21/09 :39
The Federal Government is making \$50 million available for green energy job training in communities hurt by lay-offs in the auto industry. The funds will be used to train workers for jobs in energy efficiency and renewable energy sectors.

5PM LOC/NEWS 6/3/09 1:40
Because of the slow economy, it is predicted only one out of three teens will have a job this summer. Some who've managed to secure a position have already seen the changes, with half of their co-workers being older adults. A local fun center had 40 openings and received 400 applications.

6PM LOC/NEWS 6/15/09 :17
The automotive industry decline has cut the number of manufacturing jobs in Michigan by nearly half, since the year 2000. The southeastern part of Michigan, a 7-county region, lost more than 446,000 hourly and salaried jobs.

530PM LOC/NEWS 6/16/09 1:25
Today, over 1,000 people turned out for a job fair for the Frankenmuth Brewery. Management plans to hire up to 100 people to tend bar, wait tables, greet guests, cook and manage. Qualified job seekers were granted two interviews and given a personality test.

5PM LOC/NEWS 6/26/09 :42
General Electric is planning a \$100 million project slated for Metro Detroit. This announcement came this morning, focusing on manufacturing high tech products like jet engines and wind turbines—the project will expand on the existing Visteon Village.

2. Economy/Business

630PM NAT/NEWS 4/5/09 :28
The Treasury Secretary says structured bankruptcy is an option for General Motors. He says General Motors has made progress putting together a restructuring plan. President Obama has given GM until June 1 to present him with a strategy.

530P NAT/NEWS 4/16/09 1:15

The Pontiac and GMC brands are added to the growing list General Motors plans to eliminate to streamline their organization to meet restructuring guidelines set by the Government.

11PM LOC/NEWS 4/23/09 1:25

The U of M Flint announced today plans to close their Public Television facility. They have been struggling to come up with operational funding for the past two years, and are battling a deficit. The University hopes another public television entity will take over the operations, and have no official off air date set.

11PM NAT/NEWS 4/30/09 1:13

General Motors still has another month to re-structure itself. It differs from Chrysler in that it has much more debt, and is held by a wider group of banks and investors. GM's bondholders turned down a buyout offer earlier this week and proposed a counter offer. Chrysler's bondholders turned down two government deals, and may now have to settle for less money in bankruptcy court.

NOON NAT/NEWS 5/5/09 1:30

The Federal Reserve Chairman warns weak labor markets and decline in equity and housing wealth will continue to affect consumer spending. Wall Street traders are waiting for results on how healthy national banks are, with 10 banks expected to need more money.

6P NAT/NEWS 5/11/09 1:34

The General Motors CEO says bankruptcy is probable. He also gave more deadlines of his own, as this week's car dealerships learn if they'll be shutting down. This is just one of the drastic moves the automaker is taking to regain profitability.

11PM LOC/NEWS 5/24/09 1:55

Corunna's City Council approved their 2009-2010 budget, with no money allotted to repair a local community center. It needs repairs estimated at \$100,000. The mayor remains hopeful that this decision will turn around with possible grant applications.

5PM NAT/NEWS 5/27/09 1:25

General Motors withdrew from their bondholders the offer of 10 percent of GM in exchange for \$27 billion in debt. Under this proposal, retirees would have only received 5 to 10 cents on their retirement dollar. This settlement appears to be the biggest roadblock GM faces, and makes them another step closer to bankruptcy.

11PM LOC/NEWS 6/1/09 1:20
Today General Motors announced it's bankruptcy status. However, local economist believes Mid-Michigan won't see any major effects of the GM bankruptcy for at least two years, if at all, due to its resiliency.

11PM LOC/NEWS 6/5/09 :18
The Standish Maximum Security Prison, in Arenac County is one of eight prison facilities that will be closing. Governor Granholm issued the order today, as part of an effort to save the state \$120 million. This facility employs 280 people.

11PM LOC/NEWS 6/7/09 1:27
Area dealers are receiving the news that, after years of selling cars for General Motors, their franchise will not be renewed. While some dealers have other options available to them and remain profitable, not all have as optimistic a future.

11PM LOC/NEWS 6/22/09 1:44
The trend for the bankrupt General Motors has been to cut back. The magazine, "Golf Week", reports the Buick Open could be next. It claims GM needs a bankruptcy judge's approval before paying to sponsor the event, causing area businesses concern.

3. Crime

11PM LOC/NEWS 4/9/09 1:23
The K-9 unity from Grand Blanc Township, Flint Police, and the Michigan State Police Crime Lab are trying to recreate a chain of events that led to the murder of a local man at a market in Flint. Residents say this is the second homicide within the year, and that the area needs more police protection.

6PM LOC/NEWS 4/14/09 :29
A man who brutalized two woman at a spa in 2003, then attempted to burn the building with them in it, was sentenced today to 18 to 53 years behind bars. The man pled no contest to attempted murder in an attack that lasted almost 24 hours.

6PM LOC/NEWS 4/25/09 1:30
One man is dead tonight after a confrontation with a police officer in Burton. The man was reported to be walking into traffic at an intersection. Neighbors tell a different story from police, saying he had no weapon, no shirt and no shoes and appeared hallucinatory.

11PM LOC/NEWS 4/30/09 :24
A Flint man remains jailed tonight, accused of abusing his own mother. Mother was found living in a state of filth and being charged \$450 a month to live there. Her son has been charged with embezzlement and abuse.

6PM LOC/NEWS 5/4/09 1:30
Tonight, after 3 shootings in less than 24 hours, Bay City residents are on edge. Police are still searching for a motive behind the gunfire, which erupted Sunday afternoon.

11PM LOC/NEWS 5/13/09 1:25
Two rival gangs appeared to have a shoot out during the day in front of a local grocery store. No one was hurt, but surveillance video shows the incident and the suspects. The owner was behind bullet proof glass when this all unfolded.

WAKEUP LOC/NEWS 5/22/09 :37
A shooting occurred in front of a local club early this morning. Police arrived only to Shell casings, and nothing else. Later, a man came to an area hospital with a single gunshot wound to the chest.

5PM LOC/NEWS 6/10/09 1:30
Police and a K-9 unit investigate a robbery at a local bank. No one was hurt, but the bank closed temporarily and resurrected bad memories for a few businesses nearby. Police have yet to identify the bank robber.

6PM LOC/NEWS 6/10/09 1:15
A 20-year-old male is tasered when Bay City Police bust an underage drinking party, with nearly two dozen young adults in attendance. A teen was tasered as police broke up the party, which is the second incident in just months involving teens and Bay City police. In March a young man died after being tasered by police.

11PM LOC/NEWS 6/10/09 1:35
U of M Flint students received an e-mail alert after two students were robbed on campus last night. The students were approached in a lot and robbers took a cell phone, \$100, a debit card, and a student ID.

4. Politics

4PM NAT/NEWS 4/9/09 :52
President Obama urges Americans to take advantage of record breaking low interest rates in the housing market. While he backs low interest rate deals for new buyers, and re-financers, he's also warning Americans to watch for scams. The government is also offering money-saving advice for homeowners on line.

NOON NAT/NEWS 4/14/09 1:20
President Obama says that while there are early signs of economic recovery, there are still some big challenges ahead. The president has to show Americans his strategy is beginning to work, in order to get support for future plans.

NOON NAT/NEWS 4/20/09 1:30
President Obama is asking each of his departments to submit specific proposals, 90 days from now, outlining ways to trim spending. Some agencies have already started cutting costs, which include delaying or cancelling conferences, or combining employees under one roof.

4PM NAT/NEWS 5/7/09 1:30
President Obama defended recent budget cuts, which some claimed were too small. Half the items on the chopping block come from defense spending production. The White House wants to show it can tighten purse string, in order to win over lawmakers uneasy about spending billions on healthcare reform.

5PM NAT/NEWS 5/14/09 1:39
President Obama asks Congress to move quickly on a bill aimed to make credit card terms more transparent. Right now senators are addressing their version of the bill, known as the “Credit Card Holders Bill of Rights.”

5PM NAT/NEWS 5/26/09 1:30
President Obama chose a Hispanic woman from the Bronx for the Supreme Court. The 54-year-old judge would become the first Hispanic and the third woman in the Supreme Court, but the president says he chose her because she was the most qualified candidate.

NOON LOC/NEWS 6/1/09 :44
Today, Governor Granholm appeared on “The CBS Early Show”. She says this is a new day for the auto industry and the state’s economy. She went on to say the initial days of bankruptcy will be hard for people statewide, but promises a brighter future filled with more jobs.

530PM LOC/NEWS 6/15/09 1:35
President Obama addressed a tough crowd at the American Medical Association, trying to sell the nation’s doctors on his prescription for health care reform. His proposal includes a controversial government-sponsored insurance option.

NOON LOC/NEWS 6/24/09 :19
Governor Granholm is joining President Obama in Washington, DC, as part of a bi-partisan governors’ forum. The meeting will give state leaders a chance to discuss specific concerns for their region.

11PM LOC/NEWS 6/30/09 1:25
The Standish Maximum Security Prison could soon be the future home for inmates in California. Governor Granholm suggests keeping a few prisons open, specifically Standish, and fill them with prisoners from California. Standish residents think the idea is a good one, as long as it keeps jobs in the community.

5. Wars in Middle East

4PM NAT/NEWS 4/9/09 1:30
An anti-American cleric called for a march of millions to protest against American forces in Iraq; but only about 30,000 showed up. Iraqi police say U.S. troops promised to improve security in Iraq but have done nothing. President Obama made a surprise visit to U.S. forces in Baghdad this week saying he plans to pull all combat troops out of Iraq by the end of next year.

6PM LOC/NEWS 4/9/09 1:50
The war memorial erected in Mt. Pleasant was vandalized earlier this week. Mt. Pleasant police and those who helped raise money for it are looking for help on who may have done it. An area radio station is also asking for the public's help and has raised almost \$1,800 as a reward to get the missing pieces of the monument back.

6PM LOC/NEWS 4/12/09 :37
Around 90 men and women from the 237th Brigade Support Battalion are honored with a "Freedom Salute", in recognition of their recent deployment to Iraq in support of Operation Iraqi Freedom. Each soldier received an encased American flag.

NOON NAT/NEWS 4/20/09 2:30
A 31-year-old American journalist was convicted of spying for the U.S. and sentenced to Eight years in jail. Her lawyers are appealing, with the Iranian president ordering courts to make sure she's treated fairly. President Obama says he's "gravely concerned" about the journalist's safety.

NOON NAT/NEWS 4/30/09 :22
The British Prime Minister says the United Kingdom ended its combat operations in Iraq. The final withdrawal of more than 3,700 servicemen and women will speed up in the coming weeks. In the last six years, 179 British soldiers have died in Iraq.

11PM NAT/NEWS 5/11/09 1:19
Military officials say a U.S. soldier opened fire on comrades at a Baghdad base, and left at least five dead. The shooter entered the base clinic suffering from combat-related stress, and apparently began to fire. The Camp Liberty shooting is one of the deadliest incidents of non-combat casualties since American forces entered Iraq in 2003.

11PM NAT/NEWS 5/16/09 :48
Three soldiers make the front page of the New York Times, but it's what one soldier is wearing that catches national attention. Army Specialist Zachary Boyd was caught by the camera fighting the Taliban in his pink boxers. Boyd says he was resting when his unit came under fire, and grabbed his helmet, body armor and gun—not his pants. These were pink boxers that say "I Love New York City."

WAKEUP NAT/NEWS 5/22/09 1:13
The Senate passed a \$91 billion military spending bill, with President Obama hoping to have the bill ready for his signature by early next month. The Senate's vote came as U.S. soldiers dealt with another deadly day in Iraq where a suicide bomber attacked an outdoor market in Baghdad. At least 22 people were killed, including 3 U.S. soldiers.

11PM LOC/NEWS 6/7/09 1:35
The principal of Goodrich High School was deployed to Iraq for a one year tour of duty earlier this year. Thanks to technology he was able to bid this graduating class adieu all the way from Baghdad. It's the first time the principal had served in a combat zone—his message to the students was the importance of freedom.

4PM NAT/NEWS 6/25/09 1:30
The U.S. Military says 9 troops were wounded in 2 roadside bomb attacks against a convoy in Eastern Baghdad. Violence is surging in Iraq, with less than a week to go before American soldiers pull out of major cities. At least 7 people died and dozens were injured in an explosion at a bus terminal southwest of the capital.

WAKEUP NAT/NEWS 6/30/09 1:30
Iraqi forces are now completely in charge of security in Baghdad and surrounding cities. American troops officially handed over the reins at midnight. The Prime Minister has declared today a public holiday with fireworks lighting up the skyline as thousands celebrated in the park. Withdrawal marks the first major step toward removing all American forces from Iraq by December 31, 2011.

5PM LOC/NEWS 6/30/09 1:26
The Department of Defense says an IED exploded near a local Gladwin soldier's vehicle while he was in Sadr City. He died from those injuries as U.S. troops were pulling out of Iraqi cities. The celebration of American forces leaving Iraq has been dimmed for the community and his family in Gladwin.

6. DTV Conversion

4PM LOC/NEWS 5/27/09 :25
Live look at a part of WNEM TV5's website dedicated to the digital television transition. The deadline is 15 days away. Our meteorologist will walk you through the steps you need to take in preparation for this transition.

530PM LOC/NEWS 6/9/09 :27
As part of the nationwide mandate, on June 12, WNEM TV5 will switch from our analog signal to the more efficient digital signal. If you have any questions on the DTV switch, you can call into our DTV phone bank this Friday.

6PM NAT/NEWS 6/11/09 1:30
On Friday, June 12, television is going digital, and the U.S. government says there will be no more delays. Some 30 million viewers have applied for a government voucher, and used it to buy a converter box. Some 40 percent of TV stations across the country are already broadcasting in digital, and people who have cable, satellite, or a television with a digital tuner aren't affected by the transition.

5PM LOC/NEWS 6/11/09 1:33
Here are five things viewers need to know in preparation for the transition of analog to digital television tomorrow. (1) Converter box, (2) Coupon, (3) Eliminate antenna, (4) No need to worry if you have cable or satellite, and (5) Make sure you re-scan your converter box.

NOON NAT/NEWS 6/12/09 1:28
Stations across the country are pulling the plug on analog television today, marking the biggest transition in television since the advent of color. Viewers who make the high tech switch won't just see a cleaner picture, they'll also get more channels, at no extra charge.

7. Weather

11PM LOC/NEWS 4/5/09 1:15
By tomorrow morning much of mid-Michigan will be covered in up to 9 inches of snow. Today, the snow packed roadways, coupled with hundreds, if not thousands of drivers, headed down to Detroit for the Final Four, made driving dangerous.

530PM LOC/NEWS 4/7/09 :21
Across Michigan, the spring snow storm is being blamed for 4 deaths around the state. Also, more than 120,000 customers were left without power late Sunday.

630PM LOC/NEWS 4/26/09 :34
Some mid-Michigan farmers are dealing with flooded fields today. Farmers say they were hit with over 3 inches of rain Saturday. High water in one area is complicated by a too-small culvert, according to one resident with a very flooded yard.

530PM LOC/NEWS 4/28/09 1:38
When there's standing water out on 28th Street in Buena Vista Township, chances are there are wet basements or sewers backed up in the homes on these streets. One man had four pumps running at one point to get excess water out of his mother's home. The township supervisor was unavailable for comment.

530PM LOC/NEWS 4/30/09 1:15

This is how Robert Young commutes to his house since the Tittabawassee River overflowed its banks. Three days of hassle, he says, for 362 days of heaven, living by the river. Six inches of rain fell the past 3 days leaving washed out roads, parks under water, basements flooded, and some homes surrounded with water.

5PM LOC/NEWS 5/1/09 1:40

We have caught up with Robert Young 24 hours after we first interviewed him, with his home surrounded by the Tittabawasee River. The waters have dropped, but the road still remains impassable. Clean-up for this kind of flooding deals with river sediment, dirt, debris, and, in the worst case, the danger of dioxins.

530PM LOC/NEWS 5/4/09 1:07

Some fields still resemble lakes rather than farmland, after mother nature dumped a large amount of water in the area. Farmers all across the region are encountering extremely saturated soil, which will cool down the soil, making growing conditions less than ideal. So far, the rain has pushed back the growing season by at least two weeks.

530PM NAT/NEWS 5/14/09 1:15

A storm chaser captures images of a twister, tearing through Kirksville, Missouri. In Bismark, Missouri, the fierce storms toppled trees and ripped the roof off a school. Also, a possible twister cut into a motel in southwest Oklahoma.

11PM LOC/NEWS 6/17/09 1:20

In the Flint Township business district, shortly after 1 p.m., the Flint River, broke the banks, and flooded this parking lot. Some people only experienced wet clothing, while others had their vehicles flooded. Nearby homes found water in their basements.

5PM LOC/NEWS 6/24/09 1:20

Many folks were cooling off at a local man-made lake, but others were dealing with today's heat and humidity. Doctor's suggest drinking water every 15 to 20 minutes, seniors are recommended to stay inside, turn off electric lights, take cool baths, keep the blinds slightly closed are some suggestion to live through the current heatwave.

530PM LOC/NEWS 6/24/09 1:30

Besides giving them plenty of water, the Humane Society says to treat your pets like another person, and they'll be fine. Animals are prone to heat stroke, especially dogs with squishy faces, like boxers and pugs. Besides water, make sure they have shelter or shade, keep them out of direct sunlight, and use a wet towel around their neck or feed them ice cubes.

8. Alternative Energy

530PM LOC/NEWS 4/1/09 2:08It

takes more than a green thumb to create a green farm, say the Findlay family, in Caro, who own and operate a 2,000-acre organic farm. Organic farming is farming without the use of chemicals or fertilizer which is manufactured. Anything that is natural or naturally occurring can be used.

530PM LOC/NEWS 4/3/09 1:26

Consumers Energy says it's time for a new and improved plant in Bay City, after providing the area with electrical power for many years. Opponents of the new coal plant say it's just not necessary and won't really create that many jobs. Public hearings are set giving residents an opportunity to hear and be heard on the topic.

530PM LOC/NEWS 4/21/09 1:44

It's a common misconception that to clean green it costs a lot of money. There are many household items that are environmentally friendly and can get the job done inexpensively. Salt, hydrogen peroxide, lemon juice, vinegar are some items used as substitutes replacing less natural products.

530PM LOC/NEWS 4/29/09 1:37

A local roofing company recycles old, used shingles into asphalt. The shingles are dropped off, sorted out, bulldozed, shredded into powder, and turned into asphalt, used on roadways and in parking lots across mid-Michigan.

530PM LOC/NEWS 5/6/09 1:43

Much of green technology starts below ground as seen in this newly built "green" home. Heat is gathered from the sun and used in an exchange box to preheat water going into the water tank. There's also a device that takes the heat used while showering to preheat the cold water re-filling the tank. Gathering rain water becomes more efficient using a device which takes it while it's running off the driveway, puts it into a grate pointed toward the garden.

530PM LOC/NEWS 5/8/09 1:15

The president's climate commitment has resulted in Delta College making sure their University is a green campus. Every Friday the halls are empty, classrooms dark, and the library bare. Delta students travel an average of 15 miles to and from class each day, so eliminating Friday classes means less emissions and conserving electricity at the campus.

NOON NAT/NEWS 5/21/09 :39

The Federal government is making \$50 million available for green energy job training in communities hurt by lay-offs in the auto industries. Monies will be used to train workers for jobs in energy efficiency and renewable energy sectors. It will also provide counseling and placement services for laid-off autoworkers.

WAKEUP NAT/NEWS 5/26/09 :18

President Obama's housing secretary will announce today that some \$4 billion from the \$787 billion economic stimulus plan will be used to hire people to green up America's public house.

4PM LOC/NEWS 6/2/09 :21

Mid-Michigan is named one of the best regions in the state to harvest wind energy. Saginaw, Bay, Tuscola, Sanilac, and Huron Counties are all identified as wind energy hot spots. This is according to the state's wind energy resource zone board.

530PM LOC/NEWS 6/3/09 1:27

The general manager of the Flint Mass Transit Authority is talking about hybrid green buses. They run about \$100,000 and last about 7 years. The diesel engine charges the battery which runs the bus. The engine is quieter, and gets 20 mile per gallon. The present hybrids are 12 percent efficient, with the goal being 40 to 50 percent efficiency.

NOON LOC/NEWS 6/17/09 :21

As day three of the national summit in Detroit continues, Governor Granholm is using the platform to sell Michigan as a green energy leader. Right now, the state is expected to lose more than one million jobs this decade—a trend that can be reversed by becoming a so-called "pilot state" for alternative energy and green technology.

11PM LOC/NEWS 6/29/09 :20

A Saginaw family is Florida-bound, after winning HGTV's second annual green home giveaway. It's worth \$750,000 and is a Spanish-style home down south which includes solar panels, a hard wood ceiling made with recycled planks, and a garden.

9. Sex Offenders/Predators

WAKEUP LOC/NEWS 4/16/09 :25

Prosecutors have charged a 69-year-old Vassar man with more than 30 counts of possessing sexually explicit material, including using a computer to commit a crime. If convicted, he could face up to 7 years in prison.

NOON LOC/NEWS 4/21/09 :32

Police say a girl was walking with a friend on the Bay City riverwalk, when a man on a mountain bike knocked her down. Police say the girl started screaming and the man took off. Police need help tracking down the suspect.

A man who knocked down a girl on Bay City's riverwalk yesterday has been apprehended and is now being charged with attempted assault. He is one of at least three registered sex offenders to live on McCormick Street in Bay City. Many residents of that street are learning this information for the first time.

A former Holly High School teacher, accused of having sex with two students, will spend nine months behind bars. The teacher pled guilty to second degree criminal sexual conduct. The woman began working at Holly High as a music teacher in 2004. She resigned last June.

A Thomas Township Board of Trustee member has been charged with first degree criminal sexual conduct. He was arraigned today in an Iosco County Court.

State troopers have looked at several wooded locations, looking for remains, connected to an Owen-Gage high school sophomore and a then-22-year-old softball coach. The two were never charged with anything related to the remains, but the coach is now in court for criminal sexual conduct charges.

11PM LOC/NEWS 4/15/09 1:25
Wednesday's Flint Schools budget meeting was full of numbers, graphs and statistics, but no final answers on which schools will close next year. The school has a \$20 million

budget deficit, and also expects to lose 1,000 students this next year. A decision is expected by the end of April.

6PM LOC/NEWS 4/20/09 1:35

For some districts the efforts have increased dramatically when it comes to keeping weapons out of schools, namely metal detectors. Other schools, like Midland's, use awareness and relationships with students as the best prevention, besides policies in place to keep students safe.

5PM LOC/NEWS 4/23/09 1:29

Two schools who were previously slated to close, will be staying open. The Saginaw City Schools say adjustments and opting not to refill some positions, cut down their \$2 million deficit, allowing two schools to remain open. Teachers are sometimes allowed to restrain students in emergencies, but a new federal investigation found hundreds of cases of alleged abuse and death, from overzealous teachers. Parents say state laws aren't working, and lawmakers agree. They want a national registry for teachers who physically harm students.

Moments after a special Saginaw School Board meeting began, the Superintendent announced 51 teachers, and 11 administrators accepted the district's buyout. This action will save Saginaw Public Schools close to \$4 million, if none of the teachers have to be

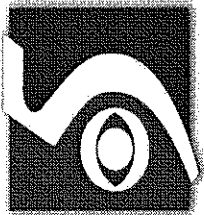
replaced. The buyout package will cost the district \$1.1 million and will be received in installments by teachers and administrators.

It includes \$4 million in cuts, 54 staffers being laid off, and 50 percent of extracurricular secondary activities being eliminated, including 5 freshman sports activities. 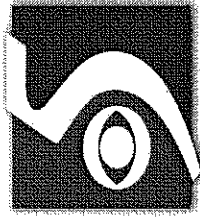
WAKEUP LOC/NEWS 6/30/09 :26

Amanda Knox, a 21-year-old American exchange student in Perugia, Italy, has now been on trial there for three months, charged -- along with her Italian boyfriend, Raffaele Sollecito -- with the November 2007 murder of Amanda's British roommate, Meredith Kercher. Although a local thief, Rudy Guede, was tried and found guilty of the murder, he implicated Knox and Sollecito in the crime. Knox and Sollecito say they are innocent. The prosecutor, Giuliano Mignini, maintains that all were part of a drug-fueled sex party that turned into a ritualistic satanic murder. Author Doug Preston recounts how, in 2006, prosecutor Mignini accused him of being an accessory to the same type of murder, after he co-authored (with Mario Spezi) "The Monster of Florence," a non-fiction account of a series of murders between 1974 and 1985. Preston and Spezi suspected a lone serial killer. This contradicted Mignini's theory that a satanic sect was responsible for the murders. The authors were accused of falsifying evidence and of being part of the satanic cult. After an intense interrogation, Preston was released without charge; Spezi, after spending three weeks in prison, was also released. Mignini -- who follows the satanic conspiracy theories of Italian blogger Gabriella Carlizzi, a woman who claims to speak to a deceased priest -- continues as prosecutor in the Amanda Knox trial, although he himself is currently under indictment for a series of crimes, including abuse of office, obstruction of justice, and illegal wiretapping of journalists. Amanda Knox faces a maximum sentence of life imprisonment; if she's convicted of murder there will be an automatic appeal. 48 HOURS MYSTERY: "The Curious Case of Colonel Shue" (10:00 - 11:00pm) - In April 2003, Air Force Colonel Philip Shue died in a violent car crash when his vehicle struck some trees alongside a Texas interstate highway. When his body was first pulled from the car, investigators found that there was a six-inch vertical gash in his chest, both his nipples had been removed, and duct tape was wrapped around both his wrists and his boots. After a year of investigation, all the agencies involved -- the Air Force, and both local and state police -- agreed that Col. Shue, a psychiatrist, had suffered a psychological breakdown and committed suicide. A grand jury, convened at the request of the district attorney, found no evidence of any crime and believed the ruling of suicide should stand. However, Tracy Shue, his widow, is adamant in her insistence that her husband had been abducted and tortured, and had then somehow broken free. Tracy thinks that Philip's first wife, Nancy, who still held insurance policies on his life worth one million dollars, should be investigated. Nancy had refused to cancel these policies, even after Philip claimed that he had received an anonymous letter warning him of a plot against his life by Nancy and her current husband, Donald Timpson. Nancy was also a board-certified sex therapist who had studied the practice of sadomasochism. Two months after Philip's death, Tracy filed a civil lawsuit seeking to prevent Nancy from collecting the million dollar death benefit, and seeking damages from the insurance companies for not previously canceling the policies. As part of the lawsuit, Tracy's lawyers demanded that Nancy answer their questions, but she took the Fifth Amendment more than twenty times, refusing to answer any questions about murder or motives or torture. In 2008, the civil lawsuit went to trial. Nancy had been dropped as a defendant, as had one of the insurance companies. Both Nancy and Tracy received million dollar death settlements of Philip Shue's policies. With regard to damages, the presiding judge ruled in favor of the insurance company. But he also ruled that the evidence considered by the Court substantiated a finding that the death of Philip Shue was indeed a homicide. Nancy Shue declined repeated requests from 48 HOURS to be interviewed. No law enforcement agency has ever named her or her husband as suspects or persons of interest in the case. However, no physical evidence linked Renee to the crime. Then, nearly a year later, it was discovered that Ron Santiago, the murdered couple's mortgage broker, had once owned a 9-millimeter Ruger handgun, the same type of gun that had killed the Ohlemachers. Police searched his home and found a 9-millimeter shell casing in a bag in his garage. Santiago was arrested, charged and jailed for the murder, but was later released on bail because of a judge's ruling that the search of Santiago's house was illegal. This decision is being appealed by the District Attorney. Meanwhile, Ohlemacher family members still believe that Renee carried out a plan to murder her parents, and that the true killer is still at large. When police were called to White's lakeside mansion, they found his body, which had been brutally beaten, with an extension cord wrapped around his neck several times. By first impression, White was a very likeable person, but as police investigated his murder, a darker image of White emerged -- one of a cruel man with a dangerous mean streak sharpened by arrogance, alcohol, and women. With an unbridled passion for the fairer sex, White bedded and rated the sexual prowess of over a thousand women, including strippers, prostitutes, and even the girlfriends of his own son Darin, who Charlie used to pick up women to fulfill his needs. As the murder investigation unfolded, police focused on the troubled relationship between father and son and soon settled on Darin as the main suspect. When Darin voluntarily came in for questioning, he admitted to being with Charlie the night he died. Darin claimed that after a trip to Wal-Mart, they returned home, where he and his father got into an argument that turned dangerously violent -- Darin believed that his father was going to kill him. After Darin beat and choked his father, he went upstairs to bed and the next morning, drove to his mother's house in New Mexico. But the Texas Rangers didn't buy Darin's story and found no evidence to show that 73-year-old Charlie put up a fight at all. Arrested for his father's murder, prosecutors maintained that it was a case of premeditated murder. But Darin's attorney, Eddie Shell, maintained that it was a misdemeanor murder and a crime of sudden passion, which carries a much lighter sentence. Shell believed that Darin exploded and killed his father in a fit of rage -- one that was brought on by years of torment and physical abuse. In the end, the jury sentenced Darin White to twenty years confinement in the Texas Department of Criminal Justice Institutional Division for the murder of his father, Charlie White. Then, in 2008, Klee's van was discovered in a Coral Springs canal which was being dredged for stolen vehicles. It contained Klee's skeletal remains and some personal possessions. Just two weeks prior to this discovery, Danna Holmes, a Coral Springs resident, told police that, in the year 2000, an inebriated man in a Coral Springs bar told her that he had accidentally killed his best friend. When she was shown a photo lineup to identify that man, she picked out David Cusanelli. Police interrogation of Cusanelli and his brother Carl eventually elicited the admission that David Cusanelli had gotten into a fight with Klee over Ginny Healy Spence, and that Klee had sustained an accidental injury to his head and died -- after which the Cusanellis pushed the van, containing Klee's body, into the canal. Because there is no evidence to suggest homicide, no charges were made against the Cusanellis. Also, according to 1977 Florida law, there was then a three year statute of limitations for manslaughter charges. The Klees cannot even sue in civil court for wrongful death -- the statute of limitations has also run out on that. The Florida legislature recently defeated a proposal to eliminate the statute of limitations in wrongful death cases. - 06/06/09 **48 HOURS MYSTERY: "Lady In The Harbor"** - A report on the September 2006 murder of aspiring actress Barbara Mullenix, whose body was discovered in the water at the Newport Harbor Yacht Club in California. She had been stabbed fifty-two times. An initial suspect was her ex-husband, Bruce Mullenix. Despite their divorce, Bruce had agreed to let Barbara and their 17-year-old daughter Rachael move into his small Huntington Beach apartment, a situation that worsened when Barbara would drink and become verbally abusive. But Bruce was soon ruled out as a suspect because he had been out of town on a business trip. Investigators' attention then turned to Rachael and her 21-year-old boyfriend, Ian Allen, who were nowhere to be found after the murder. When they were finally apprehended and questioned, Ian admitted to killing Barbara, and Rachael was also accused of the murder. Both Ian and Rachael were tried separately. Each was found guilty of first degree murder, and each was sentenced to 25 years to life. - 06/09/09 **48 HOURS MYSTERY: "The Preacher's Wife"** - In April 2006, Matt Baker, a pastor from Waco, Texas, returned home to find his wife Kari unconscious, with an empty bottle of Unisom and a suicide note beside her. Paramedics arrived within minutes, but it was too late. Based on the note, the empty bottle of sleeping pills, and the fact that Kari was described as still struggling with the loss of her daughter Cassidy seven years ago, police ruled it a suicide. In a county with no medical examiner, police described the case over the phone to a justice of the peace, who determined that no autopsy was needed. Kari's parents, Jim and Linda Dulin, had no choice but to believe Matt. However, Linda's sisters, Nancy, Kay, and Jennifer, and niece Lindsey believed otherwise. Dubbed "Charlie's Angels", they began their own investigation. After uncovering a possible motive, Linda hired Bill Johnston, a dogged former federal prosecutor, had her daughter's body exhumed and autopsied, and filed a wrongful death suit against Matt. Five months after Kari's death, the justice of the peace declared that her death was no longer classified as a suicide and police subsequently arrested and charged Matt with murder. Believing Matt would be tried in criminal court, Linda dropped her wrongful death suit. After six months, the district attorney still hadn't taken Matt's case to a grand jury -- a requirement under Texas law. Linda eventually refiled the wrongful death suit, shortly before attorney Guy James Gray filed a successful motion to dismiss Matt's criminal case, as a grand jury indictment had not been returned within 180 days. Matt Baker is no longer charged with any crime, though the district attorney continues to investigate and could refile criminal charges. There is no statute of limitations for murder. (C: Erin Moriarty - P: Lisa Freed, Gail Abbott Zimmerman) (OAD: 05/10/08). **Update for this rebroadcast:** On March 25, 2009, a grand jury indicted Baker for the murder of his wife, after a surprise witness -- Vanessa Bulls, a girlfriend of his -- came forward and testified. He will go on trial in September. **Graphic postscript:** Baker was released from jail on \$250,000 bond, pending trial. He's again living in Kerrville, Texas, with his parents and daughters.

48 HOURS MYSTERY: "Did the Doctor Kill the Doctor?" - a report on the October 1993 murder of Dr. Linda (Lin) Goudey in Stoneham, Massachusetts. At the time she was dating Dr. Timothy Stryker, who depending on whom you believe, is either a calculating murderer or an innocent man. Goudey and Stryker had been dating but friends believed they were ready to break up, even though they had planned to vacation together. Less than two weeks before the trip, witnesses say they heard the couple arguing; and it was the last night Goudey was seen alive. Four days after she was last seen at the hospital, Goudey was found face down, wrapped in a blanket in the back of her car, in a remote corner of the hospital parking lot. The medical examiner determined it was murder and Stryker became the number one suspect. Nothing police found at the scene pointed directly to Stryker, but it was what they didn't find at the scene that did: her tote bag, the jacket she was wearing and her briefcase were in Stryker's possession. Soon after, Stryker got himself an attorney and the investigation stalled. Goudey's family eventually filed a wrongful death suit. Finally, in 2006, after many delays, the suit finally went to a civil court trial where a jury believed Dr. Stryker killed Dr. Lin Goudey and ordered him to pay Lin's family \$15 million. Nobody was surprised that Stryker said he would appeal, but everyone was surprised when he and his lawyer announced they had found a brand new witness. After being questioned by the police, the witness, Craig Pizzano, admitted that Stryker had put him up to it. Stryker was arrested for perjury. This trial hasn't begun yet, but Goudey's family hopes that eventually Stryker will be charged with murder. (C: Richard Schlesinger - P: Deborah Grau) (OAD: 10/25/08). **Update for this rebroadcast:** On April 16, 2009, Timothy Stryker pleaded guilty to multiple counts of perjury and was sentenced to four years in prison. His wife Micael has filed for divorce. The homicide investigation continues. Stryker's medical license was immediately revoked after he pled guilty to perjury.

48 HOURS MYSTERY: "Kidnapped: Shawn Hornbeck's Incredible Story" - On October 6, 2002, eleven-year-old Shawn Hornbeck was kidnapped while riding his bicycle in his home town of Richwoods, Missouri. Over the course of the next four and a half years, he was held captive and sexually abused by his abductor, Michael Devlin. Threatened with death and the death of his parents, he took on the life Devlin dictated, posing as his son and even making friends with neighbors. Devlin wielded such terror that Shawn never revealed his real identity to anyone, despite numerous opportunities to ask for help. Then, in January 2007, Devlin abducted another youth, Ben Ownby. With the help of a witness to that abduction, the FBI was able to trace Devlin's car and confront him. When they went to Devlin's apartment, they found both Ben Ownby and Shawn Hornbeck. At his hearing, Devlin pleaded guilty. He was sentenced on multiple counts to 72 life terms and an additional 170 years in prison. Among those interviewed are: Shawn Hornbeck; his parents, Pam and Craig Akers; FBI agent Lynn Willett; and Dr. Marylene Cloitre, New York University psychologist and trauma specialist. 48 HOURS MYSTERY: "Into Thin Air" - a report on the disappearance of Jeanette Louise Zapata, who mysteriously vanished without a trace from her home in Madison, Wisconsin on October 11, 1976 -- leaving behind her daughter Linda, and two other children. In the midst of a divorce at the time of her disappearance, she had been married for seventeen years to an engineer, Eugene Zapata. Their marriage had been troubled -- Jeanette discovered that Eugene had sent nude photographs of her to a swingers magazine and oftentimes his behavior towards her around their children was sexual and provocative. Due to his stalking-like behavior, she also had a restraining order against Zapata. Though Officer Greg Martin found Zapata's behavior strange, the results of his lie detector test were inconclusive. With no physical evidence, the case stalled. Eugene Zapata moved back into the house he had once occupied with Jeanette and acted as though nothing had happened. He explained to the children that Jeanette had simply taken off because she was stressed. In November 2004, Jeanette's best friend, Peggy Weekly -- who never believed that Jeanette would abandon her three children -- contacted police in Madison to reopen the case. Assigned to the case was Detective Marianne Flynn Statz, who after a preliminary investigation, was convinced that Jeanette had been killed and that the right suspect was Eugene. She contacted Linda Zapata, who expressed her own doubts regarding her father's innocence and agreed to help police with their case. After a thorough investigation, Eugene Zapata was arrested for the murder of Jeanette. His trial began in September 2007, but ended in a hung jury. Prosecutor Bob Kaiser was ready to go back to court and try Zapata again, when Zapata surprised everyone and agreed to answer questions regarding Jeanette's disappearance, but only if prosecutors would reduce the charge from murder to reckless homicide. His daughter Linda agreed. According to Eugene, he had argued with Jeanette the morning of October 11, 1976 and when her back was turned, hit her on the head with a paperweight and then strangled her twice. Then he began a grisly thirty year odyssey with her body: burying it, exhuming it, reburying it, and eventually he cut her body into pieces and took it to a land fill. Eugene Zapata was sentenced to five years for reckless homicide. Linda Zapata has been cut off from her immediate family: despite Eugene's plea, her brother and sister no longer speak to her. 48 HOURS MYSTERY: "Picture Perfect" - On June 9, 2008, 30-year-old Travis Alexander, a successful businessman and devout Mormon, was found murdered in his Mesa, Arizona home. He had been shot and then repeatedly stabbed. For a little more than a year, he had been involved with Jodi Arias, an aspiring photographer whom he had met at a business conference. She adopted his Mormon beliefs, which forbid premarital sex -- but they did become sexually involved. Although they supposedly ended their relationship when Jodi found out that Travis was interested in some other girls, Jodi then moved to Mesa. Police investigation of the murder scene recovered a digital camera with electronically dated, sexually explicit photos Travis and Jodi had taken of themselves -- and photos of Travis during the time he was being killed or soon after. When confronted by police, Jodi claimed that two masked intruders had broken in to Travis' home and murderously assaulted him -- but that she was able to escape. She did not call anyone for help, and told no one of the assault. Five days later, Travis was found dead by his roommates. Further police investigation resulted in the arrest of Jodi Arias on charges of first-degree murder. Her trial will take place sometime in 2010. Includes interviews with Jodi Arias; Chris and Sky Hughes, friends of Travis Alexander; Samantha and Steve Alexander, Travis' sister and brother; Travis' friends Taylor Searle, Brint Hiatt, and Aaron Mortenson; Esteban Flores, detective, Mesa Police Department. 48 HOURS MYSTERY: "An Invisible Enemy" - a follow-up to "An Invisible Enemy" (OAD: 12/08/07). In January 2007, Cynthia Sommer was convicted of murdering her Marine Sgt. husband Todd in February 2002 with a lethal dose of arsenic. But ten months after her conviction, she was granted a new trial because of questions about the validity of the lab tests that found arsenic in some of Todd Sommer's tissue samples but not in others. His tissue samples were now sent to another lab to be tested for arsenic -- and none was found. Because of this, the prosecution concluded that there was a reasonable doubt; murder charges against Cynthia Sommer were dropped, and the case was dismissed. However, Todd Sommer's death is still officially listed as a homicide, and the court left open the possibility that Cynthia Sommer could be charged again. However, it seems that Jackson spent much more money than he actually made. Following child molestation charges, million dollar settlements and trial fees, he moved to the Middle East and stopped touring. He planned to rejuvenate his career and his finances with the fifty concerts scheduled to begin next month in London. Includes excerpts from a 48 HOURS interview with Paul McCartney (OAD: 01/25/90); forensic accountant J. Duross O'Bryan; Matthew Miller of Forbes Magazine; Bill Werde of Billboard magazine, who compares Jackson to Elvis Presley; (5) Tim Kash (MTV News) reports how Michael Jackson influenced a new generation of musicians who grew up long after his rise to superstardom - from Chris Brown to Beyonce to Ne-You, to Usher to Justin Timberlake. Madonna, Britney Spears and Janet Jackson have all danced on video with synchronized dancers, but Jackson did it first: he turned the music video from a promotional tool to an art form. Includes interviews with musicians Usher, Justin Timberlake, J.C. Chaisez, Patrick Stimp, David Cook. (6) Correspondent/Anchor Katie Couric concludes with Michael Jackson's legacy - how his music defined the era from 1969, on through the decades of his superstardom, to 1993 -- when his life began to unravel. With his death, the darker side of his life is being pushed aside and his successes in life are being remembered. Includes additional excerpts of Couric's interview with director Spike Lee. Founder Brook Martinez was inspired by the late Qawwali singer from Pakistan, Nusrat Fateh Ali Khan -- and the resulting music is the sound of Qawwali with a funky jazz sensibility.
