

The station shall reserve the right to pre-empt any broadcast, or promotion thereof, covered by this contract in order to broadcast any program, which in its absolute discreion it deems to be of public interest, convenience or

necessity. The station will attempt to reschedule such preempted announcements or mograms of sponsor the same broadcast day, or if that is not possible, as soon as possible

In the event a program or announcement cannot be rescheduled, the station will notify the sponsor and the broadcast will be cancelled without affecting rate, discounts or rights provided under this contract, except that the advertiser (sponsor) shall not be required to pay the cancelled broadcast.

If legal proceedings are brought to collect on this contract, KMEM shall be entitled to collect all reasonable costs and expenses of suit, including but not limited to reasonable attorney's fees. Further, the parties agree that venue for any suit on this contract shall be in Scotland County Missouri.




