Good morning, Andrew! Nice to hear from you!

We have no funds for promotion - - - I developed this symposium on the premise that everyone have access, whether it be the service provider or the attendee - I wanted to ensure there were no barriers to anyone - so I have not collected any funds from anyone to build up a 'bank'. I realize this is a barrier - but it was the only way I knew of to get information out to parents, students, elderly, everyone. I design, print, fold, staple all the programs and booklets, I make posters, I make all contacts and track registrations, Brocton school donates breakfast and building, the service

providers donate time, the speakers donate time - - it is 'free for all', except me - - I drop for a few days after the symposium !!!

This is my 4th symposium – it started out with just a simple 'in the cafeteria' type gathering and everyone just walking around visiting, then just grew on its own into lectures on requested topics, time to visit with service providers and learn about what they are able to do to assist families and schools to dealing with human trafficking, illicit drugs usage, abuse, exploitation, trauma, ptsd – it has taken on a life of its own, as they say!

And I must apologize, as one of my co-workers had told me about Dennis and he had thought that he covered things without charge – I do apologize for that, I truly do!

Please let me know if there is anything we can do to 'get the word out', and I do understand that you may not be able to cover the event, BUT I do also thank you so very much for responding!

Oh – I did find out this morning that The Chautauqua Center is going to be bringing their new Mobile Medical Unit to the symposium so that those who live in the more rural areas can come and see what the medical van has to offer those who lack transportation / insurance to go to a physician in an actual brick and mortar office – so exciting!
