I.D.E.A. Coalition Announces Initial Public Engagements, Community Engagement Liaisons, New Members

The Chautauqua County I.D.E.A. Coalition has announced four public community meetings to take place in January, February and March. A cross-sector and collective initiative committed to pursuing Inclusion, Diversity, Equity and Accessibility (I.D.E.A.) strategies in the community, the I.D.E.A. Coalition was founded in 2022 with the goal of making Chautauqua County a place where everyone belongs and has opportunities to thrive, especially those who have been historically marginalized.

“We are pleased to host these initial opportunities to engage directly with members of Chautauqua County’s marginalized populations to understand the barriers that keep them from feeling fully part of our community,” said Bishop Leecroft Clarke, the I.D.E.A. Project Director, who also serves in the community as lead pastor of Healing Word Ministries Church of God. “We hope that this direct engagement is a signal to our neighbors that this I.D.E.A. Coalition is different from past efforts to address these populations’ concerns and needs. By hearing straight from our neighbors — in addition a variety of other sophisticated data- and fact-gathering efforts — the I.D.E.A. Coalition and its members will be better informed and ultimately positioned to deliver positive solutions to problems that have plagued our community for decades.”

The Coalition has chosen to focus its attention initially on issues specific to the Black/African American and Latino/Hispanic communities. The initial four community meetings are intended to engage those communities in open conversation to hear from them directly regarding their concerns and needs. Refreshments will be provided. Learnings from the community meetings will help determine and prioritize next steps toward the I.D.E.A. Coalition membership’s ultimate goal of providing solutions to address identified barriers and concerns. Dates and locations are:

- **Black/African American Community Meeting, North County**
6 p.m. Wednesday, January 18, at Dunkirk High School Cafeteria
- **Black/African American Community Meeting, South County**
6 p.m. Thursday, January 26, at Samuel G. Love Elementary School
- **Latino/Hispanic Community Meeting, North County**
6 p.m. Tuesday, February 28, at Dunkirk High School Cafeteria
- **Latino/Hispanic Community Meeting, South County**
6 p.m. Thursday, March 2, at Samuel G. Love Elementary School

The four community meetings will be led by Project Director Clarke and the I.D.E.A. Coalition’s Community Engagement Liaisons, who serve as trust brokers and accountability partners with the communities directly impacted by the work of the Coalition. The Community Engagement Liaisons were identified and hired as part of the establishment of the Coalition’s Implementation Team, which serves as the primary operational bridge between impacted populations and the various organizations that provide services within Chautauqua County.

Sandra Lewis serves as the Community Engagement Liaison for the Black/African American community of northern Chautauqua County. Lewis has spent more than 35 years working in and for the Dunkirk-Fredonia community. Now retired after 33 years at SUNY Fredonia, she is continuing her passion for unionism, social justice and community service.

Patricia Graves serves as the Community Engagement Liaison for the Black/African American community of southern Chautauqua County. Graves currently works at Project Management Institute in the Global Talent Department. She serves on several boards and committees, including the New York City Bar Pro Bono and Legal Services Committee Meeting.

Shiloh Rivera Martinez serves as the Community Engagement Liaison for the Latino/Hispanic community of northern Chautauqua County. Martinez works within the county as a Bilingual Case Manager and Latino Outreach Specialist at Chautauqua Adult Day Services, a proud United Way Community Partner. She is a recent graduate of SUNY Fredonia with a BFA in graphic design.

The I.D.E.A. Coalition Implementation Team is seeking a Community Engagement Liaison to work with and among the Latino/Hispanic community of southern Chautauqua County. Anyone interested should contact Project Director Clarke at idea-director@uwayscc.org.

Other members of the I.D.E.A. Coalition Implementation Team, representing Coalition members, are: Sylvester Cleary, representing Erie-2 Chautauqua-Cattaraugus BOCES; Ilka Figueroa, representing the Child Advocacy Program; Lindsey Goold, representing the United Way of Southern Chautauqua County; Liz Jones, representing the Chautauqua Region Community Foundation; Michelle McDowell, representing Jamestown Public Schools; Indo Quiñones, representing YWCA Jamestown; and Jordan Steves, representing Chautauqua Institution.

The Implementation Team and Project Director Clarke are overseen by the I.D.E.A. Coalition Steering Committee, consisting of Alicia Eckstrom of The Chautauqua Center, Amanda Gesing of YWCA Jamestown, Diane Hannum of the Northern Chautauqua Community Foundation, Carey Lee of the Child Advocacy Program, Kristan McMahon of the Robert H. Jackson Center, Jacqueline Phelps of The Resource Center, Amy Rohler of the United Way of Southern Chautauqua County, Jaci Spoon of UPMC Chautauqua, Amit Taneja of Chautauqua Institution, and Kevin Whitaker of Jamestown Public Schools.

Finally, the I.D.E.A. Coalition has welcomed 12 new members to its ranks since the announcement of the initiative in June: Chautauqua Adult Day Services, Chautauqua County Office for the Aging, Child Advocacy Program of Chautauqua County, Church Apostolic House of Prayer, CREATE Project, Jamestown Police Department, Kids at Promise, Prevention Works, Ralph C. Sheldon Foundation, Rotary Club of Jamestown, Southern Chautauqua Federal Credit Union, and The Resource Center.

Previously announced I.D.E.A. Coalition members are the Chautauqua Center, Chautauqua Institution, Chautauqua Opportunities Inc, Chautauqua Region Community Foundation, the City of Dunkirk, the City of Jamestown, Dunkirk Public Schools, Jamestown Community College, Jamestown Public Schools, M&T Bank, Northern Chautauqua Community Foundation, Robert H. Jackson Center, United Way of Northern Chautauqua, United Way of Southern Chautauqua County, UPMC Chautauqua, and YWCA Jamestown.

Participants in the yearlong process leading to the June 2022 launch of the I.D.E.A. Coalition included individuals from law enforcement, business, banking, grassroots organizations, both Dunkirk and Jamestown city governments, and Chautauqua County Health and Human Services and Economic Development departments. Membership is open to any organization interested in supporting the I.D.E.A. Coalition's initiatives and signing the membership agreement, which can be found at uwayscc.org/ideacoalition.

The United Way of Southern Chautauqua County serves as the lead organizational sponsor of the I.D.E.A. Coalition, including serving as the home base of Project Director Clarke and the Implementation Team. The Coalition has received initial grants to fund its work through the Northern Chautauqua Community Foundation, Chautauqua Region Community Foundation, and the Cummins Foundation, and recently received generous additional funding through a grant from the Western New York Foundation.
