RENEWAL ANNOUNCEMENT REQUIREMENTS**

WCAU(TV)	<p>Prior to the filing of the station's license renewal application, the station must air an announcement in the form following Form A-1 below, between the hours of 6 p.m. and 11 p.m., on February 1 and February 16, 2007, and March 1 and March 16, 2007.</p> <p>The announcement should be communicated both aurally and visually.</p>	<p>After the filing of the station's license renewal application, the station must air an announcement in a form following Form A-2 below on April 1 and April 16, 2007; May 1 and May 16, 2007; and June 1 and June 16, 2007. The announcement should be communicated both aurally and visually.</p> <p>At least three of these announcements must air between 6 p.m. and 11 p.m. Eastern Time, at least one between 9 a.m. and 1 p.m. local time, at least one between 1 p.m. and 5 p.m. local time, and at least one between 5 p.m. and 7 p.m. local time.</p>
