The Maricopa Community College District two years ago began charging in-state tuition to undocumented students who qualify for Obama's Deferred Action for Childhood Arrivals Program, contending that DACA approval affords them "lawful presence."

The measure had already won bipartisan support in the House Armed Services Committee when several Republicans joined Democrats to add it to a big defense spending package. But despite several years of outreach, the effort has run into limitations. Congress, in particular, has stumbled as Republicans repeatedly voted against immigrant-friendly measures that many Latino and minority voters support. Passage would have meant a sizable shift in Republican thinking on immigration-related matters.

Teach for America is a program that brings people of diverse backgrounds into the classroom to enhance learning. Members of the Walton family, the family that founded Wal-Mart, made a large private donation to help pay for illegal aliens with DACA status to enroll in the Teach for America program. DACA instructors are not licensed teachers but they are issued an alternative license6 from the State of Colorado to teach. These "teachers" are enrolled in classes to attain their traditional teaching license after one year. Under Deferred Action for Childhood Arrival, illegal aliens are offered two years of amnesty, are given a social security number, and are allowed to apply for a work permit. The two-year DACA stay of deportation may be renewed on a case-by-case basis, but it does not confer lawful immigration status, provide a path to citizenship, or alter an illegal alien's existing immigration status.

In its decision, the court said it found "no legal impediment or rational basis for withholding the privilege of practicing law in the state of New York from undocumented immigrants who have been granted DACA relief."

U.S. District Judge Andrew Hanen in Brownsville refused late Tuesday night to lift the preliminary injunction he granted on Feb. 16 at the request of 26 states that oppose Obama's action. Hanen's latest ruling upholds the status quo -- that the Obama administration is temporarily barred from implementing the policies that would allow as many as 5 million people in the U.S. illegally to remain. The Justice Department had already appealed to a higher court, the 5th U.S. Circuit Court of Appeals in New Orleans, to lift Hanen's injunction. The appeals court was scheduled to hear arguments on whether the injunction should be lifted on April 17. In his order Tuesday denying the government's request, Hanen said the government hasn't "shown any credible reason for why this Directive necessitates immediate implementation.
Despierta America	27-May	6am	3:05	President Barack Obama's plan to shield as many as 5 million immigrants living in the U.S. from deportation remained on hold Tuesday after a federal appeals court panel refused to allow it to take effect immediately. Obama announced an executive action in November seeking to expand a program that protects young immigrants from deportation if they were brought to the U.S. illegally as children. The order also would extend deportation protections to some parents of U.S. citizens and permanent residents. Although Obama argued lack of action by Congress forced him to make sweeping changes on his own, Republicans blasted the plan as an executive overreach. Twenty-six states have sued to stop it, and a federal judge based in Texas issued a preliminary injunction against it in February. The administration is appealing that injunction and had asked a three-judge panel of the 5th U.S. Circuit Court of Appeals to let the program proceed pending an argument on the merits, tentatively set for July. But, in refusing to stay the Texas judge's injunction, 5th Circuit judges Jerry Smith and Jennifer Walker Elrod said that the federal government lawyers are unlikely to succeed on the merits of the appeal. Judge Stephen Higginson disagreed in a lengthy dissent. Immigrant advocates decried the continued roadblock. And, White House spokeswoman Brandi Hoffine said the two-judge majority in Tuesday's ruling "chose to misinterpret the facts and the law."
Noticiero Univision	8-Jun	5:30pm	2:00	A series of legal setbacks have halted the government's intensive preparations to move forward with President Obama's executive actions shielding millions of illegal immigrants from deportation, even as community organizations continue a rapid push to get ready for the programs, according to U.S. officials and immigrant advocacy groups. Since a federal judge first blocked the new programs in February, the Department of Homeland Security has suspended plans to hire up to 3,100 new employees, most of who would be housed in an 11-story building the government has leased for \$7.8 million a year in Arlington, Va. That building, in the Crystal City area, is now sitting mostly unused, DHS employees say. Yet inside and outside the Beltway, community groups are mobilizing, educating immigrants and training volunteers to help them apply for relief, even though it remains unclear whether the program will ever begin.

Although earlier studies have shown that Latino children are raised with emotional warmth and develop social skills on par with others when they enter kindergarten, the new research found they are not receiving sufficient language and literacy skills at home, said Bruce Fuller, a UC Berkeley professor of education and public policy and co-author of the study. Mothers of toddlers who fell behind were more likely to be foreign-born, low-income and less educated. They were also less likely to read to their children daily or give them as much praise and encouragement as those whose children kept pace with white peers. The study found, for instance, that only 18% of Mexican American mothers who spoke Spanish at home read to their children daily, compared with 59% of white mothers. Among Mexican American mothers who spoke English at home, 28% read daily. In addition, other research has found that parents with more education limit television, ask their children more questions, give them more opportunities to articulate their feelings and have them show off their skills -- counting to 10 for grandma, for instance. Latino mothers also have been found to issue more commands -- set the table, turn off the TV -- which may stem from the need to maintain order in larger families, Fuller said. And Latino mothers tend to believe that children should wait for kindergarten to learn to read, compared with white mothers who see age 2 as the appropriate age for such learning, according to a UCLA study. Fuller said that difference may stem from the traditional Mexican respect for teachers.

The study by the London school of economics found a link between banning smart phones in schools and increased test scores. Researchers looked at how cell phone policies at 91 schools in England have changed since 2001. They compared the information with results of national exams taken by students at the age of 16. Researchers found that school test scores improved by six-percent following a ban on phone use. For underachieving students the Average test scores went up 14-percent following a ban.

A new study published in PLOS One found that fetuses move and respond more when their mothers touch their own stomachs than when they talk to the babies from outside the womb. Specifically, researchers found that when mothers touched their stomachs fetuses showed "more arm, head, and mouth movements than when the women did nothing or when they spoke to the baby." To find this, researchers brought 23 healthy pregnant women into a dark room and had them all practice three different behaviors. One behavior had the mothers rub their abdomen, another had the mothers talk to their babies and the last had mothers keep their arms at their side. The researchers tracked the fetuses' movements with sonography. The first behavior had the most responses from the fetuses.

Those whose mothers developed gestational diabetes by the 26th week of pregnancy were 40 percent more likely to be diagnosed with autism than those whose moms didn't have diabetes. Of about 3,400 autistic children, 130 were exposed to diabetes early in pregnancy. Autism affects about 1 in 68 U.S. children. In the study, youngsters whose mothers had pre-existing diabetes or developed it later in pregnancy faced no extra autism risk.

The faulty inflators are responsible for six deaths and more than 100 injuries worldwide. The agreement adds more than 18 million air bags to existing recalls, covering both the passenger and driver's side. The recalls of passenger-side air bags, previously limited to high-humidity states along the Gulf Coast, are now expanded nationwide by 10.2 million vehicles. A nationwide recall of driver's side air bags was expanded to include an additional 7.9 million vehicles. "We know that owners are worried about their safety and the safety of their families," said Mark Rosekind, head of the National Highway Traffic Safety Administration, as he announced the agreement. "This is probably the most complex consumer safety recall in U.S. history." Safety regulators sparred with Takata for the past year over the size of the recalls and the cause of the problem. For the most part, the air bag maker refused to declare the inflators defective and even questioned the agency's authority to order it to conduct a recall.
