**RF RADIATION COMPLIANCE CERTIFICATION**

**ENTERCOM KANSAS CITY LICENSE, LLC**

Entercom Kansas City License, LLC is the licensee of KUDL (FM), Channel 251C0, Facility ID # 2449 is licensed to Kansas City, Kansas.

I have examined the Commission's environmental requirements in 47 CFR 1.1307. Based upon my computation using the FCC FM Model, Version 2.10 beta, power density computer program, I have determined that the licensed FM antenna system does not have a significant environmental impact as defined by section 1.1307, which includes consideration of the exposure of workers or the general public to levels of radio frequency radiation exceeding identified guidelines issued by the American national standards institute (ANSI/IEEE c95.1-1992, 'Standard for Safety Levels with Respect to Human Exposure to Radio Frequency Electromagnetic Fields, 3kHz to 300GHz'). Access to the transmitter site is restricted and there is no general public exposure above the FCC RF radiation limit. The area surrounding the tower base is adequately secured by a locked gate and fence with appropriate warning signs posted.


Operating parameters for the main facility are 100 kW effective radiated power, using an Electronic Research Inc. model COG-1083-10CP, 10 bays, 0.76 wavelength spaced, circularly polarized antenna system. This antenna tower bears Antenna Structure Registration Number 1064715. The antenna center of radiation is 341 meters above the ground level. The calculated maximum 'percentage of FCC RF radiation limit', general population or uncontrolled exposure at ground level is <1.0% at any distance away from the antenna support structure base. Within the fenced secure area surrounding the tower, the maximum predicted exposure level is <1% of the controlled exposure guideline.

With respect to 'on tower' or other exposure to workers at the site, appropriate power reduction or cessation of transmitter operation will be undertaken by the licensee.

This certification of RF radiation compliance was prepared by me or under my direct supervision. All information is true and correct to the best of my knowledge. My experience is a matter of record with the Commission.
