On May 31, 2005, stations WMAB-TV, WMAE-TV, WMAH-TV, WMAO-TV, WMAU-TV, WMAV-TV, WMAW-TV and WMPN-TV were granted licenses by the Federal Communications Commission to serve the public interest as a public trustee until **June 1, 2013**.

Our licenses will expire on **June 1, 2013**. We have filed an application for renewal with the FCC.
