Good afternoon. The NAB has asked that we extend their PerformanceTax spots through the end of November. So please extend your current orders - which were set to expire on 9/30 to expire on 11/30. This applies to ALL CUMULUS STATIONS. As a reminder, these are considered political orders, but do not impact LUR. You will need to upload all relevant info as a revision onto your station FCC sites. As before, you can follow the external link below to the NAB site for the NAB form and spot creative, and you can take a screen shot of that external NAB page for your audit records as a proxy for an insertion order (it shows the new extension to 11/30). As a reminder, these spots are pre-emptible.
