Extension of NAB Performance Tax Issue Spots

Good morning. The NAB has asked that we extend their Performance Tax spots through the end of September because despite hitting the milestone of a majority of support in the House of Representatives opposing new performance taxes, it's still possible that the Judiciary Committee could hold a markup on the American Music Fairness Act and the Senate could introduce a companion bill. So please **extend your current orders - which were set to expire on 9/6 - through 9/30. This applies to ALL CUMULUS STATIONS.** As a reminder, these are considered **political orders**, but do not impact LUR. You will need to **upload all relevant info as a revision onto your station FCC sites.** See original link below to a post from earlier in the year that has full instructions and details. As before, you can follow the external link in the earlier post to the NAB site for the NAB form and spot creative, and you can take a screen shot of that external NAB page for your audit records as a proxy for an insertion order. These spots are pre-emptible.
