RE: Petition for Eligible Entity Status, L4 Media Group, LLC, Station KBXS-CA, Shreveport, LA,
Facility ID No. 70420, FCC File No. BLTTA-20030718ADM

Dear Counsel:

This is with respect to the Petition for Eligible Entity Status ("Petition") filed on July 9, 2015, by L4 Media Group, LLC ("Licensee"), licensee of Station KBXS-CA, Shreveport, Louisiana.¹ The Petition requests that the Station be deemed an "eligible facility" for purposes of the incentive auction. Pursuant to the *Incentive Auction R&O*, Class A stations that were licensed as of February 22, 2012 are entitled to mandatory protection.² An examination of the Commission's database reveals that KBXS-CA has been a licensed Class A station since August 4, 2003.³ It is therefore entitled to protection.

Accordingly, the Petition for Eligible Entity Status filed by L4 Media Group, LLC **IS GRANTED**. For purposes of the incentive auction, Station KBXS-CA, Shreveport, Louisiana, FCC File No. BLTTA-20030718ADM, will be deemed an "eligible facility" and is therefore eligible for protection in the repacking process and relinquishment in the reverse auction.⁴ Furthermore, the Licensee **MUST FILE** its Pre-Auction Technical Certification Form (FCC Form 2100, Schedule 381) for its eligible facility by **July 24, 2015**.⁵
