

("Licensee"), licensee of television station KUBD, Ketchikan, AK (the "Station"), located in the Juneau, AK DMA, hereby gives notice to Dish Network LLC that pursuant to Section 325(b)(3)(B) of the Communications Act and Sections 76.64(f)(2) and 76.66(d) of the FCC's rules, Licensee elects retransmission consent status for the Station. Accordingly, pursuant to Section 325(b)(1)(A) of the Communications Act and Section 76.64(a) of the FCC's rules, the Station's broadcast signal may not be carried on your satellite system or other distribution systems that you own, operate, or manage without Licensee's express written consent pursuant to a retransmission consent agreement. This election of retransmission consent is for the period January 1, 2018 through December 31, 2020.
