Dear Mr. Appleton:

This is in reference to the request filed on February 6, 2018. SBH requests a further extension of the STA granted on August 14, 2017, to continue to operate ND at night to allow time to complete repairs and file the required FCC Form 302 application.¹ In support of the request, we noted that SBH was not yet able to file the application to update all operating parameters.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and SBH may continue to operate ND at night using the daytime tower with a maximum of 0.25 kW, with no change to the licensed daytime 10 kW facility. SBH must further reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. SBH must file the 302 application or submit an e-mail to my

attention to certify the date the station resumed licensed operations per BMML-20120604AGM with negligible changes to all operating parameters.
