Quarterly Issues Programs List for Station- KCSU

Section I. Issues

The station has identified the following issues as significant issues facing our community this quarter:

- **A. Housing:** Housing is an issue that affects all of Fort Collins. Students Are constantly on the look for housing and Fort Collins as a whole is involved in housing issues like U+2.
- **B. Government:** Impact local, state, and national governments have on the students and governmental events impacting the nation.
- **C. Campus construction and improvements**: Construction on campus affects Fort Collins as a whole. Not only does construction cause delays in commuting, but the delays affect things like traffic, and what the community has access to at the university.
- **D. Education**: Education is an important topic to cover because Fort Collins has a large amount of schools.
- E. Community- Status of events happening within Fort Collins and the community abroad.

Section II. Responsive Programs

A. Housing:

"U+2 With ASCSU" –Broadcast on Oct. 7- Duration 15 minutes: An in-studio interview with the Community Affairs director of ASCSU, CSU's Student Government, discussing an issue that is directly affecting students. The U+2 is a law that has inconvenienced students as the student population increases, and has made the process of finding housing more difficult.

"U+2 With ASCSU Update"- Broadcast on November 2015- Duration 5 minutes: An update on U+2 action taken by the city as they announce that they will start actively enforcing the U+2 law in the Avery Park neighborhood.

B.Government:

"Foreign Affairs and Syria Update"- Broadcast Oct. 7. Discussed the foreign affairs of the United States in the Middle East as well as the Syrian refugee crisis. This broadcast talked about the United States and foreign allies dealing with ISIS and politics with the Middle East region.

"Boulder GOP Debate Rundown"- Broadcast on November 1, 2015. Given access to the GOP debate in Boulder, Colorado our reporter gave a rundown of what happened and interviewed people about what issues were most important to them.

C. Campus Instruction and Improvements:

"Construction State"- Broadcast on October 7. A round table discussion of reporters about the continuing construction on campus with the new stadium, and other projects breaking ground on campus, such as the Pitkin Street Parking Garage.

"New Food Court Vendor Announced"- Broadcast on November 15, 2015. A round table discussion of reporters about Garbanzos, the new food court vendor in the LSC, and the process that lead up to this moment.

D. Education:

"No Child Left Behind Rewritten"- Broadcast on December 2, 2015. Duration- 4 minutes: A quick overview of what the No Child Left Behind Act did and how that differs from the Every Student Succeeds Act. The results of this will affect the way Fort Collins high schools run and administer testing.

E. Community:

"Tour de Corgi"- Broadcast on October 7. Reported and discussed a first-time parade in the community of Fort Collins, where a parade of Corgis walked through Old Town. This was the first time the community put on this parade, and discussed why it was started and brought to Fort Collins.

"Fort Collins Pow Wow" - Broadcast on November 18.-Duration 4:30. Reported on Fort Collins Pow Wow that brought Native Americans from all over the United States. The report included several interviews of people who were there.

The preceding programs are examples for responsive programming from the "Quite Honestly News Show" which aired Wednesday from 5-7pm on 10/7, 10/14, 10/21, 10/28, 11/4, 11/11, 11/18, 12/2, and for a total duration of approximately 16-hours.
