6	Participation in programs sponsored by educational institutions relating to career opportunities in broadcasting	On April 13, 2023, the EU's Chief Engineer participated in career day at the Putnam Elementary School. The Chief Engineer gave a 15-minute demonstration of what he does as a radio engineer with a special focus on how Science, Technology, Engineering, and Math (STEM) plays a role in his day-to-day operations. He discussed what type of education his role requires and the different certifications he takes to advance his career. He shared with the students a typical day, including the best and the worst of his job.
