

**Required Broadcast Channel Change PSA and Crawl  
Regarding Implementation of Channel Sharing Operations  
WGTW-TV, Burlington, NJ**

The FCC recently held a Spectrum Auction to help improve and expand wireless services across the country to allow faster, higher capacity mobile broadband services. Pursuant to this Spectrum Auction, at midnight on November 5, 2017, TBN's WGTW-TV, Burlington, NJ will be moving from over-the-air channel 27, and change to over-the-air channel 36. WGTW-TV will be digitally multicasting on channel 36 with WMGM(TV), Wildwood, NJ. This change in broadcast channels will only affect you if you obtain TV service over-the-air using an antenna; if you subscribe to a cable TV or satellite provider, they will make any necessary changes for you to continue receiving WGTW-TV. If you have over-the-air TV, there are steps you may need to take to continue your reception of WGTW-TV when it moves to channel 36. This includes re-scanning your TVs tuner to find the new channel.
