The following three pages contain instructions for the broadcast of the pre-filing and post-filing renewal announcements for WPCB-TV. Included with these instructions are the texts of the two types of announcements and a Statement Certifying Compliance that needs to be completed, dated, executed and **placed in the station's online public inspection file within seven (7) days** after the last post-filing renewal announcement has been aired or by **June 23, 2015**. If for any reason the station did not air the required announcement on the specified days and during the specified time periods, please contact the company's communications counsel before the Statement Certifying Compliance is finalized, dated and executed.

Pre-filing Renewal Announcements for WPCB-TV, Greensburg, PA, FAC ID 13924

The following pre-filing renewal announcement must be read over the air on each of the following days: February 1, February 16, March 1 and March 16, 2015. Of the four airings, at least two of these announcements must be broadcast between 6:00 P.M. and 11:00 P.M.
