

I agree that all purchases of advertising time on **KSEL AM/FM, KRMQ-FM & KSMX FM** that I make by or on behalf of legally qualified political candidates will be made subject to this Acknowledgement and the Political Policy.

I certify that I have been fully informed concerning all classes of time which are available to advertisers, including every level of preemptibility, the availability of discount packages and rotations including the station's willingness to negotiate combinations of time suitable to the needs of particular candidates, and the station's policy with respect to make goods.

I recognize the exclusive jurisdiction of the Federal Communications Commission ("FCC") under the Communications Act of 1934, as amended (the "Act"), with respect to all disputes concerning purchases of advertising time by or on behalf of legally qualified political candidates, specifically including all disputes will therefore be governed exclusively before the FCC, subject to such judicial review as is provided for by the Act. In order to ensure that material necessary to resolution of such disputes is maintained, any such complaint should be filed with the FCC within ninety (90) days after the date of the election for which advertising has been purchased.

If I am an agent acting on behalf of a candidate, I certify that I have made full disclosure to the candidate of the information provided to me by **KSEL AM/FM, KRMQ-FM & KSMX FM** concerning its political broadcasting policies, and, if not, that I have been specifically authorized by the candidate to purchase advertising time on the Stations on his or her behalf without the need to make such full disclosure. I further represent that I am authorized by all candidates on whose behalf I purchase time to agree to the terms and conditions set forth herein.
