#### CARRIAGE SELECTION FORM PTV DEADLINE AUGUST 21, 2008

Following discussions concerning the relationship between the 2005 Agreement among APTS, NCTA and PBS and the analog carriage rules of the FCC's *Viewability Order* (FCC 07-170), the three organizations have reached a mutual understanding that would result in the following during the period February 18, 2009 through February 18, 2012:

- for each HDTV Cable System that supplies an analog tier, one PTV Station entitled to digital and analog carriage rights under the 2005 Agreement under the pre-transition carriage regime would receive such digital and analog carriage until Feb. 18, 2012;
- for each HDTV Cable System that supplies an analog tier, additional PTV stations would continue to receive analog-only carriage until Feb. 18, 2012; such additional PTV Stations entitled to Post-Transition digital-only carriage rights under the 2005 Agreement, which currently are set to begin on Feb. 18, 2009, would agree to postpone the commencement of such digital carriage rights until Feb. 18, 2012;
- alternatively, an additional PTV Station can choose to cause early relinquishment of analog-only carriage in favor of digital-only carriage pursuant to the 2005 Agreement;
- all PTV Stations would acknowledge and affirm that during the term of the 2005 Agreement, such rights granted under the 2005 Agreement and this understanding would replace and supplant any carriage rights applicable to public television stations arising out of the FCC's *Viewability Order*; and
- each cable MSO that has ratified the 2005 Agreement will countersign the carriage selection form of each station qualified for carriage on its HDTV Cable System.

All forms will be processed through APTS and NCTA. Accordingly, attached is a form that each public television station must complete for <u>each</u> cable MSO's HDTV Cable System covered by the 2005 Agreement on which the station is carried.
