In satisfaction of the FCC Enforcement Bureau EEO audit public notice released March 22, 2024, Christian Television Network, Inc. ("CTNI") hereby uploads this response to the Online Public Inspection File ("OPIF") for station WHTN, Murfreesboro, TN, Fac. Id. 11117. This response will follow the outline in the audit request which begins with the number 2.

2. Audit Data Requested.

2(b)(i). WHTN is the only station in the station employment unit ("SEU"). The SEU employs five or more full-time employees. Therefore, copies of the SEU's two most recent EEO Public File Reports described in 47 CFR § 73.2080(c)(6) are attached hereto as Exhibit A. WHTN is a religious broadcaster as described in 47 CFR § 73.2080(a) and will limit the remainder of its response accordingly.

Licensee has had no complaints, pending or resolved, involving the SEU filed during the SEU's current license term(s) before any body having competent jurisdiction under federal, state, territorial or local law, alleging unlawful discrimination in the employment practices of the Unit on the basis of race, color, religion, national origin, or gender.

2(b)(vii). In accordance with section 73.2080(b), during WHTN's current license term, the following describes the responsibilities of each level of SEU management responsible for implementing SEU EEO policies and how the SEU has informed employees and job applicants of its EEO policies and program: WHTN management meticulously reviews each job posting to ensure that the knowledge, skills and abilities outlined in the job description are based on merit and ability alone so that all applicants, regardless of race, gender, color, age, disability or national origin can be confident in applying. Once employed, and for current employees, the on-boarding process includes review of the Employee Manual which in Section 1, page 5, has an entire portion dedicated to Equal Employment Opportunity. Included in this section is a reminder to all staff, including managers, that "Violation of this policy may result in disciplinary action, up to and including possible termination."

2(b)(viii). In accordance with section 73.2080(c)(3), during WHTN's current license term, the following is a description of the SEU's efforts to analyze its EEO recruitment program to ensure that it is effective and to address any problems found as a result of such analysis: At least annually, the hiring manager reviews the various outreach sources used to widely disseminate full time vacancies and evaluates whether those sources are producing candidates that meet the SEU's employment needs and position qualifications. As a religious broadcaster whose full-time vacancies include religious belief or affiliation as a requirement, the hiring manager also analyzes current and potentially new outreach sources likely to provide candidates with all qualifications.

Efforts include ongoing evaluation of ways to broaden the reach and scope of SEU recruitment for current and future positions, particularly through local colleges/universities where positions are posted and also boosting the area/scope of online job postings for open positions. These processes are designed to address any problems that may arise.

2(b)(ix). As required by section 73.2080(c)(4), during the SEU's current license term(s) (or since acquisition of the Unit (if during that period)), the following is a description of the Unit's efforts to analyze periodically its measures taken to examine pay, benefits, seniority practices, promotions, and selection techniques and tests to ensure that they provide equal opportunity and do not have a discriminatory effect: The SEU is evaluated by the manager annually as well as at any time there is a job opening or transition of employment. The manager also plans several community events throughout the year to stay in touch with the community and ensure that the SEU considers the diversity of the community and how to do a better job of recruiting and hiring when future opportunities become available. The Unit has no union agreements.

2(b)(x). WHTN is a religious broadcaster with five or more full-time employees, all subject to a religious qualification as described in section 73.2080(a) of the rules. Therefore, the SEU is not required to produce records for such hires or complete the initiatives required under section 73.2080(c)(2).
