Re: Must Carry Election

Dear Mr. Nissenblatt:

Reference is hereby made to the terms of the Retransmission Consent Agreement ("Agreement") dated November 15, 2010 between WTVE License Company, LLC ("WTVE") and Comcast Cable Communications, LLC ("Comcast") for the carriage of WTVE's primary and digital sub-channel signals on all Comcast cable headends in the Philadelphia Designated Market Area ("DMA"). Even though we already have the Agreement in place, the FCC requires that we make an official "election" for carriage of said station in writing, and send you the election notice. This election in no way affects or alters our Agreement; it is simply in order to fulfill our responsibility to the FCC.

Therefore, pursuant to Section 76.64(f) of the rules and regulations of the Federal Communications Commission ("FCC"), this letter shall serve as written notification that WTVE, licensee of television station WTVE-TV, channel 25 serving the Philadelphia, PA DMA is electing must carry for our station's signal. This election shall apply to all communities where Comcast operates in the station's television market (as defined in Section 76.55(e) of the FCC's rules) for the period beginning January 1, 2012 and ending on December 31, 2014.
