POLITICAL BROADCAST DISCLOSURE STATEMENT

I. Political Broadcast Rates in "Pre-Election Periods"

During "Pre-Election Periods", which are the periods 45 days prior to preliminary elections and 60 days prior to general elections, all commercials sold for uses by legally qualified candidates for public office will be sold at the lowest rates charged to any other advertiser for commercials of the same length that are ordered to run in the same day part or rotation in the same week. If we determine after the fact that the candidate commercials were sold at higher rates, we will provide prompt refunds or credits.

In the event a candidate's spot is preempted, a make-good or make-goods of equivalent total value (although not necessarily in the time period originally ordered) will be provided prior to the election unless the candidate requests a refund or credit instead.

The attached rate card shows the lowest priced spots that are currently being scheduled to run in our most commonly purchased day parts. These rates may be subject to change in subsequent weeks and should there be an increase in the rate for the lowest priced spot purchased to run in any day part in any week, or in the event any advertiser is sold lower priced spots for a specific day part or rotation in a specific week.

KRKT, KLOO AM/FM & KEJO and KTHH may also offer other classes of spots to commercial advertisers, but no other class of spots will be less expensive for a spot ordered to run in the same day part or rotation than the spots described in this disclosure statement.

The rates shown in the attached rate card apply to all commercials. KRKT Fm, KLOO Am/Fm & KEJO Am and KTHH Am may occasionally sell spots in rotations other than those listed in the attachment. Rates for any such other rotations will be provided upon request.

II. Political Broadcast Rates Outside "Pre-Election Periods"

The portion of the year outside the 45 day pre-preliminary and 60 day pre-general election periods is the "Comparable Rate Period". During the comparable rate period, KRKT Fm, KLOO Am/Fm & KEJO Am and KTHH Am will present rate quotations to candidate advertisers in the same manner as to commercial advertisers.

Most commercial advertising sold by KRKT Fm, KLOO Am/Fm & KEJO Am and KTHH Am is sold on a negotiated basis, with the exact rate varying according to factors such as, but not limited to (a) the number of spots in a particular order and the total volume of advertising ordered by a particular advertiser, (b) the degree of flexibility our station is afforded in moving an advertiser's commercials in heavy demand periods, (c) the percentage of an advertiser's budget for the market allocated to our station and (d) the projected demand for all spots by all advertisers and our station's available spot inventory at the time of the projected demand.

POLITICAL BROADCAST DISCLOSURE STATEMENT

The rates charged to candidate advertisers during the comparable rate period may not be the lowest rates charged for similar spots, but will be rates comparable to the charged to other advertisers buying time under comparable circumstances.

During the comparable rate period, KRKT Fm, KLOO Am/Fm & KEJO Am and KTHH Am will use its best efforts to provide make-goods for any preempted spots at times acceptable for the advertiser involved. To the extent inventory constrains prevent us from offering make-goods acceptable to an advertiser, we shall provide refunds or credits with respect to any advance payments made for preempted spots.

III. General Policies

- 1) The rate policies set forth above apply to political advertisements that are “uses”, as defined by the rules and policies of the Federal Communications Commission. In general, a spot will be considered a “use” only if it is purchased by, or on behalf of, a candidate or the candidate’s authorized campaign committee and if the commercial includes some identifiable voice appearance by the candidate.
- 2) All candidate commercials must contain appropriate sponsorship identification, which means that the commercial must include a statement that is “paid for” or “sponsored by” a candidate or the candidate’s campaign committee – as required by the rules and policies of the Federal Communications Commission.
- 3) The Bipartisan Campaign Reform Act of 2002 (the BCRA) states; All Federal Candidates must provide a written certification to broadcast stations stating that the candidate will not refer directly to any opponent without, including an audio identification of the candidate and office sought and the statement of approval from the candidate on whose behalf the ad is run for.
- 4) All political orders require net cash payment at least 24 hours in advance of the air dates, unless payment is guaranteed in writing by an agency with established credit.
- 5) Reasonable access to advertising on KRKT, KLOO Am/Fm & KEJO and KTHH, will be provided to all federal candidates. KRKT, KLOO Am/Fm, KEJO and KTHH, reserve the right to limit the amount of advertising that can be sold to federal candidates on a week by week basis, based on the needs of candidates and by commercial advertisers, and based on station inventory.
- 6) KRKT, KLOO Am/Fm, KEJO and KTHH may further limit or deny advertising to state and local candidates. Please inquire as to any limitations that may apply to elections for each state and local office.

POLITICAL BROADCAST DISCLOSURE STATEMENT

- 7) KRKT Fm, KLOO Am/Fm & KEJO Am and KTHH Am will not accept political advertising to run on Election Day, except as required by law to meet equal opportunities or reasonable access obligations.
