

**CERTIFICATE OF COMPLIANCE WITH
PRE AND POST-FILING RENEWAL ANNOUNCEMENTS**

Salem Communications Holding Corporation, licensee of radio station **WHKW(AM)**, licensed to Cleveland, Ohio, Facility ID No. 14772 certifies that it has broadcast pre-filing and post-filing broadcast announcements, on the dates and times set forth below.

***FCC Waiver** – Effective April 9, 2020, the Federal Communications Commission (“FCC”) issued **Order DA 20-398** waiving the requirement for pre-filing announcements for broadcasters whose licenses are scheduled to expire on October 1, 2020 and must file renewal applications on June 1, 2020. The FCC determined that it is in the public interest to waive the pre-filing announcement requirement due to the disruptions caused by the coronavirus (COVID-19) pandemic, including the loss of revenue experienced by broadcast stations and the need to cover breaking news and air public service announcements. In this *April Waiver Order*, the FCC stated they would continue to monitor the status of the COVID-19 outbreak to determine if further relief is warranted.

Subsequently, effective May 13, 2020, the FCC’s Media Bureau issued and adopted **Order DA 20-511** waiving the compliance for pre-filing broadcast announcements for broadcast stations scheduled to file an application for renewal of license for the remainder of the 2019 – 2023 renewal cycle. This waiver shall be in effect for all broadcast licensees whose station licenses expire on December 1, 2020, and thereafter, with license renewal applications to be filed on August 3, 2020, and thereafter, and continuing until new rules eliminating pre-filing announcements take effect. This Order does not apply to required post-filing announcements.

required **Noon to 4:00 p.m.** time slot on both August 12th and August 13th, 2020, as listed per above.
