

WNYE-TV On-Air Pre-Filing Announcements

Beginning on December 1, 2014 WNYE-TV must broadcast one announcement each day on December 1 and December 16, 2014 and January 1 and January 16, 2015 regarding the upcoming filing of its FCC license renewal application. The announcement should be broadcast on each of the station's programming streams.

The FCC's rules require that at least two of the announcements on each stream be broadcast between 6:00 p.m. and 11:00 p.m. (the announcements do not need to be broadcast on each program stream simultaneously). The other pre-filing announcements may be broadcast at any time on the scheduled days.

If the announcement is made audibly, you must visually display the addresses of the station and FCC. Many stations choose to scroll the text while it is read by a voiceover.

The text of the pre-filing announcement is as follows:

On May 31, 2007, WNYE-TV was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until June 1, 2015.

Our license will expire on June 1, 2015. We must file an application for renewal with the FCC by February 1, 2015. When filed, a copy of this application will be available for public inspection at www.fcc.gov. It contains information concerning this station's performance since the licensee acquired control of the station.

Individuals who wish to advise the FCC of facts relating to our renewal application and to whether this station has operated in the public interest should file comments and petitions with the FCC by May 1, 2015.

WNYE-TV On-Air Post-Filing Announcements

From February 1, 2015 through April 16, 2015, WNYE-TV must broadcast one announcement each day on February 1, February 16, March 1, March 16, April 1, and April 16, 2015 regarding the filing of its FCC license renewal application. The announcement should be broadcast on each of the station's programming streams.

The FCC's rules require that at least three announcements on each stream be broadcast between 6:00 p.m. and 11:00 p.m., at least one announcement on each stream between 9:00 a.m. and 1:00 p.m., at least one announcement on each stream between 1:00 p.m. and 5:00 p.m., and at least one on each stream between 5:00 p.m. and 7:00 p.m. (the announcements do not need to be broadcast on each program stream simultaneously).

If this announcement is made audibly, you must visually display the station's and the FCC's addresses. Many stations choose to scroll the text while it is read by a voiceover.

Once all pre-filing announcements and all post-filing announcements are completed, the station must certify compliance with the pre-filing and post-filing broadcast announcement requirements and upload a certification to the station's online public inspection file by April 23, 2015. A blank certificate of compliance is included.

The text of the post-filing announcement is as follows:

On May 31, 2007, WNYE-TV was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until June 1, 2015.

Our license will expire on June 1, 2015. We have filed an application for renewal with the FCC. A copy of this application is available for public inspection at www.fcc.gov. It contains information concerning this station's performance since the licensee acquired control of the station.

Individuals who wish to advise the FCC of facts relating to our renewal application and to whether this station has operated in the public interest should file comments and petitions with the FCC by May 1, 2015.
