**NRA CALLS FOR TRAINED, ARMED SCHOOL STAFF

As Democrats struggle to shepherd a slew of embattled gun laws through Congress, a group associated with and funded by the National Rifle Association (NRA) is pushing its own proposal for reducing mass shootings in schools, unveiling Tuesday a 225-page "school safety" report that recommends sending a trained, armed officer to every school in America, as well as various "layered security" measures it says will make schools safer. Led by former Rep. Asa Hutchinson, R-Ark., who announced the plan in a press conference Tuesday morning, the so-called "NRA National School Shield Initiative" outlines eight recommendations it says would boost school security nationwide. Hutchinson stressed that the "initiative" is fully independent from the NRA -- which he said budgeted \$1 million for the effort -- and that the pro-gun lobby was under no obligation to enforce any of its recommendations.

**IMMIGRATION REFORM LATEST

In the shadow of a bipartisan Senate group preparing to roll out broad immigration legislation next week, shortly after Congress returns from its holiday break, a bipartisan group of eight House members is readying its own bill. In contrast to the Senate plan - which would provide one clear, if difficult, path to citizenship for the 11 million illegal immigrants already in the country - the House legislation will most likely offer three distinct paths to legal status. Young immigrants in the country without legal papers, who often call themselves "Dreamers," and low-skilled agricultural workers would qualify for an expedited road to legal status, people familiar with the negotiations said. The Dreamers should not be punished for being brought illegally to the country by their parents, House aides said, and the members agreed that the agricultural workers perform crucial work for the economy.

Connecticut Governor Dannel Malloy today signed a tough new gun law that, among several key provisions, restricts sales of the sort of high-capacity ammunition clips that a gunman used to massacre 26 people in minutes in a December attack on a school. Lawmakers in the state's Democratic-controlled

House approved the measure, which supporters described as one of the toughest such laws in the United States, early on Thursday morning. The Senate approved the measure hours earlier.

#### **HISTORICAL INDEMNIZATION**

Twenty-two Latino victims of unlawful warrantless home raids by Immigration and Customs Enforcement (ICE) obtained a settlement today requiring new national policies for ICE agents conducting warrantless home operations and \$1 million in damages and fees. In addition, eight men and women who were arrested during the raids have received either deferred action or termination of their immigration cases. "Immigrants across the country can stand up and cheer for what has been accomplished by this settlement. No longer will ICE agents have free rein to invade the homes of immigrants, especially Latino immigrants, and be as abusive as they want without any worry that they might be reprimanded," said **Juan Cartagena**, President of LatinoJustice PRLDEF, who, along with the Center for Constitutional Rights and Winston & Strawn, represented the plaintiffs. "The message today is loud and clear. ICE agents have to follow the law."

#### **IMMIGRATION REFORM COSTS**

Senate Republican staffers estimated Thursday that the annual cost to taxpayers of legalizing illegal immigrants could be in the billions, if they use their status to apply for federal benefits from Medicaid and ObamaCare. The claim, though, was challenged by Florida Sen. Marco Rubio, a key Republican engaged in immigration bill talks. Republicans on the Senate Budget Committee -- responding to an emerging immigration proposal that includes a path to citizenship for millions of illegal immigrants -- had estimated that the cost could total up to \$40 billion in 2022, "just for Medicaid and ObamaCare."

#### **NY JUDGE RULES ON MORNING AFTER PILL**

A federal judge has ruled that the United States government must make the most common morning-after pill available over the counter for all ages, instead of requiring a prescription for girls 16 and under. The decision, on a fraught and politically controversial subject, comes after a decade-long fight over who should have access to the pill and under what circumstances, and it counteracts an unprecedented move by the Obama administration's Health and Human Services secretary who in 2011 overruled a recommendation by the Food and Drug Administration to make the pill available for all ages without a prescription.

## **IMMIGRATION VISAS**

A popular U.S. visa program for skilled workers has hit its quota just days into the application period, the U.S. Citizenship and Immigration Service said, triggering a lottery and signaling that companies feel confident enough about the economy to hire more foreign workers. The H-1B program has not reached its base cap of 65,000 so quickly since early 2008, before the economic crisis hit.

## **NJ RALLY IMMIGRATION REFORM**

Thousands of people gathered in the shadow of the Statue of Liberty today to support comprehensive immigration reform as a debate over the issue wends its way through the highest levels of U.S. government. ## **USCIS NEW CHANGES**

Starting next month, the U.S. Citizen and Immigration Services (USCIS) will introduce biometric customer identity verification in its field offices. Under the new system, people will be required to submit fingerprints and photographs when appearing at USCIS offices for interviews or to receive evidence of an immigration benefit. As it stands, the USCIS requires applicants and petitioner requesting immigration or naturalization benefits to submit biometrics. According to the USCIS, this data help to determine eligibility for requested

benefits. Those coming to USCIS for other purposes, such as an Infopass appointment or as the guest of an applicant or petitioner, will not submit biometrics. Under the new system, two fingerprints and a photograph will be taken, and this information will be fed into the US-VISIT Secondary Inspections Tool.

#### **IMMIGRATION REFORM LATEST**

The American Action Forum, a conservative think tank, will release an analysis on Tuesday that projects that an overhaul of immigration laws could boost gross domestic product growth by a percentage point each year over the next decade. That growth would produce tax revenue that would reduce federal deficits by a combined \$2.5 trillion, according to the group's president, the economist Douglas Holtz-Eakin.

#### **GUN CONTROL LATEST**

The Senate's top Democrat says there will be a showdown vote on Thursday on his party's effort to enact new gun restrictions. Senate Majority Leader Harry Reid says he does not know if Democrats will get the 60 votes needed to break an effort by conservatives to block debate on the legislation. At least five Republicans have indicated an openness to support the Democratic effort to at least begin debate. That would give Democrats the votes they would need -- assuming no moderate Democrats defect, which is possible. One Republican who wants to see the gun restrictions go to an up-or-down vote, Sen. Tom Coburn of Oklahoma, says, "The American people ought to see where everybody stands on this." A Senate vote to begin debating the legislation would be a temporary victory for President Barack Obama's gun-control drive. It remains unclear, though, whether there are enough votes for final approval of the legislation.

#### **US MORTGAGE BANKS**

The nation's largest banks will begin sending payments this week to millions of Americans who may have been wrongfully foreclosed on during the housing crisis. A total of \$3.6 billion in cash will be distributed to 4.2 million borrowers who lost their homes or were at risk of foreclosure, the Federal Reserve and the U.S. Comptroller of the Currency said Tuesday. Payments will range from \$300 to \$125,000. About 90 percent of borrowers whose mortgages were serviced by 11 of the banks will receive payments by the end of April, the agencies said. The last group of payments is expected in mid-July. A large share of those receiving payments, about 3 million borrowers, will each get only \$300 or \$400, according to data issued by the two agencies. Around 80 percent of them will receive \$1,000 or less.

Tens of thousands of immigrants and activists rallied nationwide Wednesday in a coordinated set of protests aimed at pressing Congress to approve immigration measures that would grant 11 million immigrants living here illegally a path toward citizenship. Organizers said demonstrations were taking place in at least 18 states and in Washington, D.C., where a large, festive crowd gathered on the west lawn of the U.S. Capitol Wednesday afternoon. Many carried hand-lettered signs and chanted "Si, se

puede," Spanish for "Yes, we can." In Atlanta, more than 1,000 people marched around the Georgia Capitol Wednesday midday, calling for comprehensive changes to immigration policy and an end to deportation. Supporters massed in several rallies in New York City, including in the Washington Heights section, as well as in Queens, Manhattan and The Bronx.

## **GUN CONTROL**

### **BLANCA ROSA VILCHEZ. NEW YORK**

A bipartisan gun control compromise has emerged from the Senate. It was announced by Democrat Joe Manchin of West Virginia and Republican Patrick Toomey of Pennsylvania. The proposal expands background checks to all for-profit gun transactions. Noncommercial transactions between individuals would be exempted. The bill would also toughen laws against illicit firearms sales and provide a small increase in school security aid.

## **OBAMA-BOEHNER-BUDGET**

The White House on Wednesday (April 10) proposed a federal budget that would sharply trim the U.S. deficit over three years by forcing millionaires to pay more in taxes and enacting spending cuts that replace the "sequester" reductions that went into place last month. U.S. President Barack Obama told reporters: "If we want to keep rebuilding our economy on a stronger, more stable foundation, then we've got to get smarter about our priorities as a nation. And that's what the budget I'm sending to Congress today represents - a fiscally responsible blueprint for middle-class jobs and growth." The President's fiscal 2014 budget blueprint ensures that those making \$1 million a year or more would have to pay at least 30 percent of their income in taxes, after gifts to charity, officials said.

## **SENATORS WRAP UP WORK ON IMMIGRATION BILL**

## **USA TODAY DROPS 'ILLEGAL IMMIGRANT'**

## **GUN CONTROL DEBATE**

Gun control supporters in the U.S. Senate on Thursday won the first showdown over how to respond to the December school shootings in Connecticut, defeating an effort by conservatives to derail firearms restrictions before debate could even start. The 68-31 roll call gave an early burst of momentum to efforts by President Barack Obama and lawmakers to push fresh but modest gun curbs through Congress.

## IMMIGRATION REFORM

A bipartisan immigration bill soon to be introduced in the Senate could exclude hundreds of thousands of immigrants here illegally from ever becoming U.S. citizens, according to a Senate aide with knowledge of the proposals. The bill would bar anyone who arrived in the U.S. after Dec. 31, 2011, from applying for legal status and ultimately citizenship, according to the aide, who was not authorized to discuss the proposals before they were made public and spoke on condition of anonymity. It also would require applicants to document that they were in the country before Dec. 31, 2011, have a clean criminal record and show enough employment or financial stability that they're likely to stay off welfare.

## IMMIGRATION REFORM STEPS TO APPLY

Once the legislation is introduced, it will be considered by the Senate Judiciary Committee, which has scheduled a hearing for Wednesday and likely will begin to amend and vote on the bill the week of May 6. From there, the bill would move to the Senate floor. Both in committee and on the floor, the bill could change in unpredictable ways as senators try to amend it from the left and the right. The Gang of Eight -- Schumer, Durbin, and Sens. John McCain and Jeff Flake, R-Ariz., Marco Rubio, R-Fla., Lindsey Graham, R-S.C., Robert Menendez, D-N.J., and Michael Bennet, D-Colo. -- have discussed banding together to defeat amendments that could significantly alter the legislation.
