The most significant needs, problems and interests involving the best ascertainment of the public trust as outlined by the Federal Communications Commission were ascertained, addressed, and are documented in this report for the period indicated. The ascertainment process includes an extensive effort, including pre-ascertainment period discussions with staff, community surveying and general consensus building with the community of license. The overall effort is assisted by way of support for the news department, which is not wholly responsible for all station programming. Records regarding community and public affairs programming, as it pertains to ascertainment, is kept in the station public file.

All efforts involve the station management and programming staff, with the programming directors retaining ultimate responsibility for on-air materials, less newscasts, regarding materials deemed to be in the public trust. The key areas and issues addressed during the recording period are verified and certified by attached documentation. The list is not inclusive but does represent primary focal issues.

This document was placed in the official station file on Jan. 10, 2015 as the official ascertainment report for the period ending Dec. 31, 2014.

Statement of Scheduled Community Service and Public Affairs Broadcasting

WCSI-AM

WCSI-AM provides a broad spectrum of regularly scheduled public affairs and community service support in a diverse array of broadcast ventures. Newscasts provide a key resource in public affairs and information dissemination. Included in the regularly scheduled news broadcasts are:

Monday through Friday: Two regularly scheduled 5-minute broadcasts each hour, from 6 a.m. to 8:30 a.m. plus 60-second news updates at 6:20 a.m., 6:40 a.m., 6:50 a.m., 7:20 a.m., 7:40 a.m., 7:50 a.m. and 8:20 a.m. There is a regularly scheduled 2-minute newscast and a 90-second newscast each hour from 9 a.m. until 6 p.m. Each newscast includes national, state and regional information with heavy emphasis on ascertained community based issues determined to be supportive of the public trust.

Non-scheduled news bulletins, including weather and other breaking news information are aired as incidents occur, and in collaboration with the station's Program Director and the full-time news staff.

In addition to newscasts and breaking news bulletins, WCSI-AM also maintains a deep commitment to community service through its public service announcement programming, emphasizing events and activities in the community of license, and providing wider information distribution as time allows. Examples of the diversity of public service programming are attached in this quarterly report.

Every opportunity to allow for public input is encouraged and supported to ensure meeting the station community of license public trust obligations.

Station personnel provide critical support, above and beyond the mandates of public service, by involving themselves in key community projects, and as members of boards and commissions of not for profit organizations within the community.
