### <u>Political Advertising Disclosure Statement</u> September 2022

### 01. Introduction:

WQKT and WKVX thank you for your inquiry regarding political advertising on our stations. It is our intention at all times to furnish you with accurate rates, including the lowest unit rate within meaning of the FCC laws, and to inform you of sales promotions and packages. The person responsible for giving you accurate and complete information is:

- 02. The general statement of the law as we understand it is:
  - A. Reasonable access.
  - B. Equal Opportunity.
  - C. Lowest unit rate within meaning of the FCC laws.
- O3. Lowest unit rate: We sell time to advertisers by different classes, different amounts time, and by different periods. We will make available to qualified candidates the lowest unit rate per category. It is the station's policy and practice to extend the lowest unit charge to a use of the station's facilities by any qualified candidate during the 45-day period prior to a primary election and 60-day period prior to a general election. It is also the station's policy and practice to extend any use of the station's facilities by a legally qualified candidate outside the lowest unit charge period rates which are comparable to the rates extended to the stations commercial advertisers.

The lowest unit and comparable charges reflected in this statement and on the political rate card constitute the station's best good faith estimate of the lowest unit and comparable charges for the various classes of time offered. Often, it is impossible to determine the lowest unit and

comparable charge until after the ad has been broadcast and, in those cases, the station will, upon request, provide all appropriate additional information.

Note: In order to qualify for the lowest unit rate the candidate advertising must include their own voice in any and all advertisements. If the candidate's voice is not included in the advertisement, it does not qualify for the lowest unit rate. A Bipartisan Campaign Reform Act of 2002 certification will be required of all federal candidates for such candidates to be entitled to the lowest unit charge.

### A. Class of time:

Availabilities in general on WQKT and WKVX are sold on a first come basis. This time is sold according to our unsold inventory. Political time is sold in the same fashion we sell to any advertiser but at the lowest unit rate. Availabilities are very seldom pre-empted and are sold on a negotiated basis.

B. Amount of time:

WQKT and WKVX sell commercials (and programs) by different amounts of time and they are as follows:

Commercials:

- 1. 30 sec. and 60 sec. etc.
- C. Period of time:

WQKT and WKVX sell various periods of time: See political rate card for more specific details.

- 04. Any candidate for President, Vice-President, Senate and House of Representatives has reasonable access to the airways of WQKT and WKVX. This is a right afforded legally qualified federal candidates.
- 05. State and local candidates do not have the right to reasonable access, and we are not required to sell them time. However, we will attempt to make reasonable time when our inventory allows.
- 06. If we should have technical problems, human error by our traffic department, or for any other reason it becomes necessary to pre-empt your commercial, we offer make-goods in the same amount and period of time. If an agreement cannot be reached between the station and candidate on the make-good, we will give credit for the ad or if necessary a refund.
- 07. In this same file, or attached, you will find our rate sheets covering Political Rate Card showing the lowest unit rate. The lowest unit rate applies to all

legal candidates. We will update the rates as necessary and if need be on a weekly basis during election periods. We will discuss any package plan we have and our lowest unit rate with any candidate or their agency.

08. WQKT and WKVX do not guarantee the size of our audience.

- 09. Production facilities in our studio are limited. (We produce only spots used on our stations.) If our studio is used by a candidate and it takes a considerable amount of time, a charge may be made in addition to the commercial time used. If station representative is involved in writing or producing the commercial, candidate will be required to sign before the commercial airs. Signature signifies candidate has approved the produced commercial and releases station from liability.
- 10. We give as much separation between commercials as we can justify, however, we don't guarantee separation from competitive commercials or pod exclusivity.
- 11. Political advertisements must include sponsorship identification as required by law. If the announcement does not include the requisite sponsorship identification, this station will insert it in the spot even if the inserted identification blocks or obscures the message.
- 12. The deadline for placing and clearing orders is 48 hours before airtime of the program or commercial. The station's regular ordering deadline may be waived, where appropriate, to provide equal opportunity to political advertisers or to assure federal candidate's reasonable access.
- 13. Script must be on C.D. or sent to the station in an mp3 format in order for us to use and it must be air quality.
- 14. The address for sending us a C.D. is: WQKT/WKVX 186 S. Hillcrest Dr. Wooster, OH 44691. Email address for sending an mp3 is: traffic@wqkt.com
- 15. Payment in full must be received before airing the commercial.
- 16. This political disclosure statement is not a contract. We have standard contracts for political advertising.
- 17. All political advertising will be audited by the Station Manager to make certain the lowest unit rate is offered to the candidate. If we find an error,

we will make the necessary correction. If a credit or refund is due, it will be made at that time.

- 18. Should you have a question, please call us at 330-264-5122. We will be pleased to give you further information about our rates and our radio stations.
- 19. It is our policy to afford you the best service within our jurisdiction.
- 20. All candidates must sign and/or acknowledge receipt of required documents per NAB Forms PB-18. Federal candidates need not acknowledge receipt of this <u>Political Disclosure Statement</u>, State and Local candidates must acknowledge receipt, except in the case of "equal opportunities" demand.
- 21. We reserve the right to cancel or modify any sale of item made or contract entered into for the sale of time on the station, pursuant to the Communications Act of 1934, to satisfy the "equal opportunity" requirements of all legally qualified political candidates and the "reasonable access" requirements of all legally qualified federal candidates. Where such cancellations or modifications are necessary, advertisers will be advised and rebates, schedule changes, or other adjustments will be made as may be appropriate.
- 22. This document does not constitute an offer to sell time, nor is it a contract; rather, it is a statement of the policies which this station, in good faith, attempts to follow in connection with the sale contracts and none of the matters contained in this disclosure statement are incorporated by reference in the sale contract.
- 23. We are not required, and will not offer to issue advertisers and third party advertisers, the lowest unit rate. Further, if the issue ad involves a matter of "National Importance" the appropriate form <u>PB-18 Issues</u> must be filled out completely and a copy retained in this station's political file.
- 24. Invoices with exact air time of commercials will be generated at the end of each month. If you require notification of exact air time before an invoice is generated, please contact our Traffic Department at 330-264-5122.
