

**INSTRUCTIONS FOR  
THE BROADCAST AND ONLINE POSTING OF  
THE 73.3580 NOTICE OF FILING**

1. To satisfy the 73.3580 requirements, arrangements must be made to *broadcast* and *post online* a "Notice of Filing." The text is attached to these instructions. Review the text carefully, and should there be any questions, contact us before proceeding.
2. A Notice must be *broadcast* over both KFCO(FM) and KJHM(FM) six times, at least once per week for four consecutive weeks, with no more than two broadcasts in the same week and none on the same day. Broadcasts of the Notice must start on a date between the date the FCC releases its Public Notice accepting the application for filing and the fifth business day after the FCC releases its Public Notice. Starting the first announcement on Tuesday, January 2, 2024, will fall in that timeframe. All broadcasts of the Notice must air between the hours of 7 a.m. and 11 p.m. local time, Monday through Friday.
3. An online Notice also must be posted on the existing separate webpages that can already be accessed from the existing "FCC Applications" links in the footers of KFCO(FM)'s website (<https://flodenver.com/fcc-applications/>) and KJHM(FM)'s website (<https://jammin1015.com/fcc-applications/>). The online Notice must also be posted starting on a date between the date the FCC releases its Public Notice accepting the application for filing and the fifth business day after the FCC releases its Public Notice. Again, uploading the announcement to the "FCC Applications" pages on Tuesday, January 2, 2024, is within that timeframe. The online Notice must remain posted for a minimum of 30 consecutive days.

At the end of the 30-day online posting period, the FCC Applications page must be updated to instead indicate "There are no pending applications subject to the posting requirement. This page was last updated on [date]." That statement must remain until the next application is filed that requires online notice of filing.

4. Immediately following the last day of the broadcast announcements, we recommend you complete the *Certificates* as evidence of compliance with 73.3580 of the Commission's Rules. A copy of the Certificates should also be returned to Foster Garvey for our files. The Certificate should not be filed with the FCC or posted online.
