

**LOCAL COMMERCIAL LIMITS CERTIFICATION FOR ALL

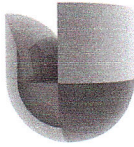

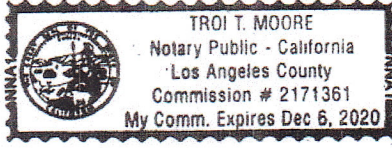
