

Post-Filing Renewal Announcements
[FCC Rule 73.3580(d)(4)]
WMIZ & WVLT

Begin broadcasting your post-filing renewal announcements within five business days of when the FCC's Public Notice of acceptance will be released. We believe starting the announcements on Monday, January 31, 2022, is within that timeframe.

A total of six announcements must be made over the four-week period starting January 31, 2022. Stations must broadcast at least one per week, with no more than two announcements in the same week and none on the same day. The announcements must be made at any time between 7 a.m. and 11 p.m. local time Monday through Friday.

Certification of Post-Filing Renewal Announcements

The attached Certifications of the broadcast of the post-filing renewal announcements should be completed within 7 days of the last date the announcement is aired. The Certification should be uploaded to each station's FCC-hosted online public inspection file. The Certification belongs in the folder titled "Local Public Notice Announcements" in the station's online public file. Please also send a copy of the completed Certifications to Foster Garvey.
