Dear Mr. Hannan and Ms. Spainhour:

The Enforcement Bureau is investigating whether Gulf-California Broadcast Company (Gulf-California), violated the sponsorship identification requirements of Sections 317 and 507 of the Communications Act of 1934, as amended (Act), and Section 73.1212 of the Commission's rules (Rules) by failing to provide sponsorship announcements for program material promoting individuals and businesses that provided payments or other valuable Consideration, as defined herein, to Station employees in exchange for such on-air promotion. We have reviewed Gulf-California's response to our July 25, 2016, Letter of Inquiry (LOI), and have additional requests for information and documents.

In addition, Gulf-California's failure to completely respond to the LOI constitutes a violation of our rules and may result in enforcement action.⁴ You failed to provide, in response to Document Request

32, federal tax returns for the most recent three years or other information that reflects the Licensee's current financial status.⁵ The LOI and this follow-up letter constitute Orders of the Commission to produce the documents and information requested.⁶ In addition, to knowingly and willfully make any false statement or conceal any material fact in reply to our inquiry is punishable by fine or imprisonment.⁷ Accordingly, we direct Gulf-California pursuant to Sections 4(i), 4(j), 308(b), and 403 of the Act,⁸ to provide the information and documents requested herein within **thirty (30) calendar days** after the date of this letter of inquiry (LOI).

 - (c) Provide a full description of the Broadcast during which the Programming aired, including the content of the Broadcast and whether each such Broadcast of the Programming was live or recorded.
 - (d) State whether each Broadcast of the Programming followed a script and if so, Identify all Persons responsible for drafting, editing, and approving each script.
 - (e) Identify all Programming Personnel involved in each Broadcast of the Programming and fully describe each Person's respective role in the Broadcast process.
 - (f) Identify, with respect to the usernames listed in the social media postings in Attachment B hereto, each and every employee, representative, or agent of Licensee, excepting Bianca Rae Goutos and Alexandra Pawelski.
- 2. Identify all Persons listed in the response to Document Request 5(f) and 5(g) below.
- 3. Identify each and every Person referenced in footnote 1 of the LOI Response, excepting Bianca Rae Goutos and Alexandra Pawelski, and, with respect to the "former employee[s]" of Gulf-California, describe their terms of employment with Licensee, including dates of hiring and firing, immediate supervisor, job duties and description, and reason(s) for termination.

Dear Mr. Hannan:

The Enforcement Bureau is investigating potential violations of Sections 317 and 507 of the Communications Act of 1934, as amended (Act), and Section 73.1212 of the Commission's rules (Rules) related to required sponsorship identification announcements and disclosure of certain payments.¹ Accordingly, we direct Gulf-California Broadcast Company (Gulf-California), pursuant to Sections 4(i), 4(j), 308(b), and 403 of the Act,² to provide the information and documents requested herein within thirty (30) calendar days after the date of this letter of inquiry (LOI).

We are investigating whether Gulf-California violated the sponsorship identification requirements of the Act and the Rules by failing to provide sponsorship announcements for program material promoting individuals and businesses that provided payments or other valuable Consideration, as defined herein, to Station employees in exchange for such on-air promotion. Specifically, we have received complaints alleging that Bianca Rae, a morning news anchor at Station KESQ-TV, and Alexandra Pierce, a news reporter at Station KESQ-TV, accepted or agreed to accept Consideration including, but not limited to, clothing, shoes, spa and aesthetic services, and stylist services from individuals and businesses in exchange for promoting those individuals and businesses during programming aired on the Station, but that no required sponsorship announcements were aired even though Station managers were aware of these on-air employees' promotional agreements.³

Section 317(a)(1) of the Act and Section 73.1212(a) of the Rules require a television station to broadcast an announcement whenever money or other valuable consideration is directly or indirectly paid or promised to, or charged or accepted by, the station for the broadcast of program material.⁴ The

disclosure must be aired at the time that the material is broadcast, inform the viewer that the program is sponsored, paid for, or furnished, either in whole or in part, and identify by whom or on whose behalf the consideration was paid to the station in exchange for airing such material.⁵

Section 507 of the Act (codified at 47 U.S.C. § 508) mandates that when an entity or individual pays to have program material broadcast, both the person making the payment and the person receiving it make a disclosure to the licensee in advance of the broadcast. This disclosure permits the licensee to air a sponsorship identification announcement at the time of the broadcast to inform viewers or listeners that a third party paid for the broadcast. The duty to disclose rests with any person involved in the production or preparation of broadcast matter who receives or agrees to receive, or provides or promises to provide, money or other consideration in exchange for the inclusion of program material in a broadcast.

In addition, Section 317(c) of the Act and Section 73.1212(b) of the Rules require each licensee to "exercise reasonable diligence" to obtain information from its employees and other individuals concerning whether particular program material is sponsored in order to enable the licensee to make the required announcement.⁸

This LOI constitutes an order of the Commission to produce the documents and information requested herein. To knowingly and willfully make any false statement or conceal any material fact in reply to this inquiry is punishable by fine or imprisonment. Failure to respond appropriately to this LOI constitutes a violation of the Act and our Rules.

Attachment A to this letter includes filing requirements and instructions for your response and definitions for certain terms in this LOI. Requests for confidential treatment or claims of attorney-client privilege or attorney work product must strictly meet the requirements stated in the attached instructions.

If the Enforcement Bureau determines that Gulf-California has acted in violation of the Act and/or Rules, the continued violation of the disclosure requirements of Section 317 of the Act and Section 73.1212 of the Rules after the receipt of this LOI may subject Gulf-California to additional penalties.

confidential treatment is sought; explaining the degree to which the information is commercial or financial, or contains a trade secret or is privileged; and explaining how disclosure of the information could result in substantial competitive harm.²² Accordingly, a "blanket" request for confidentiality or a casual request, including simply stamping pages "confidential," will not be considered a proper request for confidentiality, and those materials will not be treated as confidential.²³

Claims of Privilege. If the Licensee withholds any information or documents under claim of privilege, it shall submit, together with any claim of privilege, a schedule of the items withheld that states, individually as to each such item: the numbered Inquiry to which each item responds and the type, title, specific subject matter and date of the item; the names, addresses, positions, and organizations of all authors and recipients of the item; and the specific grounds for claiming that the item is privileged.

Format of Responses. The response must be organized in the same manner as the questions asked, i.e., the response to Inquiry 1 should be labeled as responsive to Inquiry 1.

Method of Producing Documents. The Licensee shall submit each requested document in its entirety, even if only a portion of that document is responsive to an inquiry made herein, including all appendices, tables, or other attachments, and all other documents referred to in the document or attachments. The Licensee shall not edit, cut, expunge, or otherwise take any action to modify any document submitted in response to this LOI. In addition to any document the Licensee submits in response to any inquiry, the Licensee shall also submit all written materials necessary to understand any document responsive to these inquiries.

Identification of Documents. The Licensee shall identify all documents provided in response to these inquiries in accordance with this paragraph. The Licensee shall include a reference label on each document that identifies each document in sequential and consecutive numerical order and "Bates" stamp all documents (e.g., Company 01-000001, where "Company" is the responding entity, "01" signifying that the document is response to Question 1 of this LOI, and "000001" indicating that the document is the first page in a consecutively numbered range potentially reaching one hundred thousand). Elements such as these should be separated by dashes, as indicated. For each document submitted in response to this LOI, the Licensee shall provide an index indicating: the title of the document; the date of the document; the custodian from whose files the document was retrieved; the author and recipient of the document; and the corresponding reference label number assigned to the document. Retention of Original Documents. With respect only to documents responsive to the specific Inquiries made herein and any other documents relevant to those Inquiries, the Licensee is directed to retain the originals of those documents for sixty months from the date of this letter unless (a) the Licensee is directed or informed by the Enforcement Bureau in writing to retain such documents for some shorter or longer period of time, or (b) the Enforcement Bureau or the Commission releases an item on the subject of this investigation, including, but not limited to, a Notice of Apparent Liability for Forfeiture or an order disposing of the issues in the investigation, in which case, the Licensee must retain all such documents until the matter has been finally concluded by payment of any monetary penalty, satisfaction of all conditions, expiration of all possible appeals, conclusion of any enforcement action brought by the United States Department of Justice, or execution and implementation of a final settlement with the Commission or the Enforcement Bureau.

In accordance with Standardized and Enhanced Disclosure Requirements for Television Broadcast Licensee Public Interest Obligations, Second Report and Order, 27 FCC Rcd 4535, 4570-71, para. 74 (2012), unless and until otherwise instructed by the Commission, the Enforcement Bureau or their representatives, we hereby direct that the Licensee shall not place in its public file or upload to its online public file this letter, any supplements thereto, or any other correspondence from the Commission concerning this investigation, materials related to such inquiries, Licensee responses to these Commission inquiries, or any Documents in connection with such responses not otherwise required to be placed in the public file or uploaded to the online public file.

Continuing Nature of Inquiries. The specific Inquiries made herein are continuing in nature. The Licensee is required to produce in the future any and all documents and information that are responsive to the Inquiries made herein but not initially produced at the time, date, and place specified herein. In this regard, the Licensee must supplement its responses (a) if the Licensee learns that, in some material respect, the documents and information initially disclosed were incomplete or incorrect or (b) if additional responsive documents or information are acquired by or become known to the Licensee after the initial production. The requirement to update the record will continue for sixty months from the date of this letter unless (a) the Licensee is directed or informed by the Enforcement Bureau in writing that the Licensee's obligation to update the record will continue for some shorter or longer period of time, or (b) the Enforcement Bureau or the Commission releases an item on the subject of this investigation, including, but not limited to, a Notice of Apparent Liability for Forfeiture or an order disposing of the issues in the investigation, in which case the obligation to update the record will continue until the matter has been finally concluded by payment of any such monetary penalty, satisfaction of all conditions, expiration of all possible appeals, conclusion of any enforcement action brought by the United States Department of Justice, or execution and implementation of a final settlement with the Commission or the Enforcement Bureau.

Construction. The terms "any" and "all," "and" and "or," and "each" and "every" shall be construed inclusively to bring within the scope of the requests for information and documents all information and documents that might otherwise arguably be construed as outside the scope of the requests. Likewise, the singular of any word or defined term shall include the plural and the plural of any such word or defined term shall include the singular. The words "relating to" or "relate to" shall be construed to mean, whether directly or indirectly, in whole or in part constituting, containing, concerning, discussing, describing, analyzing, identifying, supporting, qualifying, confirming, contradicting, or stating.

Definitions

For purposes of this LOI, the following definitions apply. The definitions in this section apply regardless of whether the first letter of the defined term appears in upper or lower case.

"Broadcast," when used as noun, shall mean images or sounds or language transmitted or disseminated over a station during the course of a radio or television broadcast.

"Broadcast," when used as a verb, shall mean the transmission or dissemination of radio or television communications intended to be received by the public. The verb "broadcast" may be used interchangeably with the verb "air."

"Consideration" shall mean anything of value, including but not limited to, cash, checks, salary, fees, commissions, loans, management fees, consulting fees, honoraria, per diem allowance, payment of third-party invoices, travel and/or hotel expenses, clothing, shoes, jewelry, aesthetic services including hair and make-up, meals, gifts, bonuses, stylists' services, other services, the purchase of, or promise to purchase, advertising time, and/or any other thing of value, from any source, or given by third parties, to another.

"Document" shall mean the complete original (or in lieu thereof, exact copies of the original) and any non-identical copy (whether different from the original because of notations on the copy or otherwise), regardless of origin or location, of any taped, recorded, transcribed, written, typed, printed, filmed, punched, computer-stored, electronically-stored, or graphic matter of every type and description, however and by whomever prepared, produced, disseminated, or made.

"Identify," when used with reference to a person, shall mean to state his or her full legal name, job title (if any), current business address, business phone number, and e-mail address. If business address or telephone number are not available, state the person's home address and telephone number.

"Identify," when used with reference to a Document, shall mean to state the date, author, addressee, type of document (e.g., the types of document, as described above), a brief description of the subject matter, its present or last known location, and its custodian.

"Identify," when used with reference to an entity other than a person, shall mean to state its name, current or last known business address, current or last known business telephone number, and e-mail address.

"Gulf-California" shall mean Gulf-California Broadcast Company, the Person which is the licensee of the Stations and any predecessor-in-interest, or wholly or partially owned subsidiary.

"Licensee" shall mean Gulf-California Broadcast Company, and any predecessor-in-interest, affiliate, parent, wholly or partially owned subsidiary, other affiliated company or business, and all owners, including but not limited to, partners or principals, and all directors, officers, employees, or agents, including consultants and any other persons working for or on behalf of the foregoing at any time during the period covered by this LOI. Although this LOI refers to Licensee to collectively include each person or entity listed in this definition, any responses must specifically detail and distinguish between the actions or responsibilities of each entity.

"Person" shall mean any individual, entity, business, company, association, or organization.

"Programming" shall mean audio/video content of any type or format, including, but not limited to interviews, news-style coverage, entertainment programs, documentaries, and informational programs but shall exclude commercial spot advertisements of 60 seconds or less in duration that are displayed during program breaks in accordance with standard industry practice.

"Programming Personnel" shall mean employees who are on-air talent and/or materially participate in the on-air broadcast of program material or in programming decisions including management, direction, creation, planning, production, approval, and their supervisory employees.
