Re: Election of Retransmission Consent Status

To Whom It May Concern:

LIN License Company, LLC (“Licensee”), licensee of television station WYFX-TV, Youngstown, Ohio (the “Station”), located in the Youngstown, Ohio DMA, hereby gives notice to Time Warner Cable Inc. that pursuant to Section 325(b)(3)(B) of the Communications Act and Section 76.64(f)(2) of the FCC’s Rules, Licensee elects to assert its right, under Section 325(b)(1)(A) of the 1992 Act and Section 76.64(a) of the FCC’s rules, to have the broadcast signal of the Station carried on cable systems only if we have provided our express written consent. This election applies to the cable system(s) identified above as well as any other cable system(s) or other video distribution system(s) that you own, operate, or manage. Accordingly, none of the system(s) identified above, nor any other system(s) owned or controlled by you, in our television market or elsewhere, may retransmit the broadcast signal of the Station, or any portion(s) thereof, without obtaining Licensee’s express written consent. This election of retransmission consent is for the period January 1, 2015 through December 31, 2017.

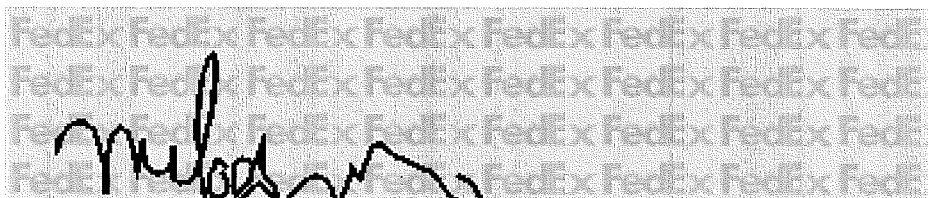

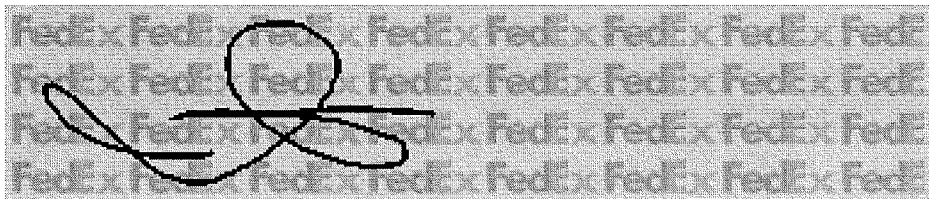

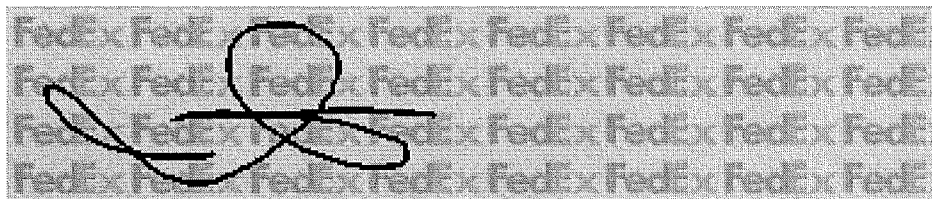
