LIN License Company, LLC ("Licensee"), licensee of television station WYFX-TV, Youngstown, Ohio (the "Station"), located in the Youngstown, Ohio DMA, hereby gives notice to Cequel III Programming, LLC d/b/a Suddenlink that pursuant to Section 325(b)(3)(B) of the Communications Act and Section 76.64(f)(2) of the FCC's Rules, Licensee elects to assert its right, under Section 325(b)(1)(A) of the 1992 Act and Section 76.64(a) of the FCC's rules, to have the broadcast signal of the Station carried on cable systems only if we have provided our express written consent. This election applies to the cable system(s) identified above as well as any other cable system(s) or other video distribution system(s) that you own, operate, or manage.
