

Text of Post-Filing Announcement for W30CV-D

On June 21, 2013, W30CV-D was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until December 1, 2020.

Our license will expire on December 1, 2020. We have filed an application for renewal with the FCC.
