Here's the Community Spotlight first-quarter issues report for January through March!

Community Spotlight -- First Qtr Report for 2022...

The Community Spotlight Local Public Affairs Program airs on all six of the Media One Radio Group radio stations. The Chautauqua County Executive appears the first week of each month and City of Jamestown Mayor appears the second week of each month. The other weeks of the month feature a variety of community leaders and special guests. The program airs on the following stations at the following times: WJTN - Saturday at 8:05 A.M. | WWSE - Sunday at 7 A.M. | WHUG & WKSN at 8 AM Sunday, WHUG at 6:30 A.M. Sunday. WQFX - Sunday at 5:30 A.M... and, WKZA - Sunday at 6 A.M..

January of 2022...

Jan. 9 -- Chautauqua County Executive P.J. Wendel joins our Terry Frank for the first program of 2022 to discuss topics, including the announcement about COVID-19 protocol changes by the county's Dept. of Health and Human Services. Wendel says the department will not be able to contact some people individually about them testing positive for COVID. Wendel says that's for two reasons: one is with the omicron variant, the virus has been much more prevalent, and the other is because of their work to allow "test to stay" in local schools. We also discuss his recent comments that the county will not enforce the state's mask mandate. He says that's pretty much impossible to do, and adds the county could only really "educate" businesses that weren't enforcing the mandate to begin with. He defended the handling of the December County Legislature meeting where some residents refused to wear masks, even though they were asked to. He says people were able to socially distance in the legislature chambers. We also discuss local Congressman Tom Reed's visit to the county to announce funding approved through the \$1.2-trillion federal Infrastructure bill. Finally, the executive gives his impressions of Gov. Kathy Hochul's first State of the State Address.

- Jan. 16 - This week, our Terry Frank speaks with Jamestown Mayor Eddie Sundquist on a number of topics to begin the new year... including the explosion of COVID-19 cases due to the omicron variant. Of the 1,855 cases for the previous week, 449 of those were in the Jamestown 14701 zip code, and it's hit most departments of city hall. Sundquist was among those handing out 500 rapid home-test kits to local residents last Wednesday. He says all 300 distributed that day went within 10 minutes or so at each of the three locations. Another 200 were handed out at two locations the following day. Sundquist also discussed a number of complaints over garbage that was not picked up at the start of 2022. The Board of Public Utilities started enforcing the city code that states that all trash needs to be placed into the large BPU container, and the lid must be shut. He says stickers were to be put on the trash -- if it wasn't properly placed curbside -- to explain what happened, and a number to call if there was an issue. We also discuss some controversy that's come up over his appointments to the BPU for the new year. He elected not to reappoint past resident members Greg Rabb, and Jim Olson.

- Jan. 23 - Chautauqua County's representative in the U.S. House of Representatives this past week restarted his weekly telephone conference calls after they ended abruptly early last year. Corning Republican Tom Reed, who announced he was not seeking re-election after revelations of sexual misconduct during an ice fishing junket to Minnesota in 2017, spoke with Southern Tier Media about a number of issues. In the beginning, he discusses the recently approved \$1.2-trillion infrastructure bill that he voted for. Media One's Terry Frank then asks about the future of the "Build Back Better" legislation, which Reed agrees is dead in the water. He says parts of it may come back in "stand-alone" form, but, will need bi-partisan backing. He also discusses fellow New York Republican Congressman John Katco's decision to also not run again. Reed also looked back on President Joe Biden's first-year in office, and says his biggest disappointment that Biden has not followed through on his promise to unify the country, and work in a more bi-partisan manner with the House and Senate. He says he decided to do the calls again because many members of the media in the district had urged him to resume them.

- Jan. 30 - New York State Senator George Borrello joins our Terry Frank in studio this week to discuss a number of issues as the state legislative session is underway in Albany. Borrello predicts that Gov. Kathy Hochul will extend the

indoor COVID-19 mask mandate because her administration is fighting a State Supreme Court ruling on Long Island against the mandate. Hochul early this weekend extended that mandate to Feb. 10. We also discuss the Farm Labor Overtime Mandate change from 60 hours to 40 hours a week. That was approved after a year of debate and hearings by a state agriculture commission... and, now goes to the state Labor Commissioner for final approval. Borrello says it will hurt farmers, and farm workers. We also further discuss Gov. Hochul's budget proposal. He is encouraged because she is calling for a new tax credit for farmers that would have difficulty with the new labor mandate. We also discuss his being reappointed as the Ranking Republican member of the Senate Agriculture Committee, and other assignments for 2022.

February 2022....

- Feb. 6 -- Our Terry Frank discusses a number of issues with Chautauqua County Executive P.J. Wendel, including preparations and snow plow safety through the major storm the area received late last week. We also discuss the latest with the number of new COVID-19 cases falling for a third-straight week. There were still just over 1,000 new cases. However... Wendel points out the county distributed some 18,000 testing kits with two tests in each. He says it's hard to tell what the real numbers are like because those testing negative don't necessarily report it to the county or state. We also discuss the governor's new budget proposal, and what may be included for the county, along with redistricting in New York state. Wendel says he testified twice (once on-line) to keep the 23rd Southern Tier District intact.

- Feb. 13 - Our Terry Frank speaks with Jamestown Mayor Eddie Sundquist this week on a number of topics... including Gov. Kathy Hochul lifting the mask mandate for public, indoor places. Sundquist says some entities -- including the courts -- still require masks in the city. However, he says people are still welcome to wear masks if they are more comfortable wearing one right now. We also discuss the city council's recent rejection of a new, four-year contract with the Jamestown Professional Firefighters Local #137. He says they hope to continue talks with the department... but, adds arbitration is also a possibility. We also discuss council's recent look at doing a full revaluation of property in the city at a cost of \$285,000 in American Rescue Plan Act funding. That's among a number of potential projects, mainly for economic development projects in the city. It would be Jamestown's first revaluation in 15 years. We also preview Sundquist's attending the annual New York State Conference of Mayor's Winter Session in Albany this weekend.

- Feb. 22 - This week... Terry Frank spoke with Jamestown Board of Public Utilities General Manager Dave Leathers on a number of topics, including getting an update on the garbage collection situation with the Solid Waste Division. After a rough start to new procedures in picking up trash, Leathers says things seem to have smoothed out. We also discuss all five divisions, and the fact only Wastewater is looking at a fee or rate increase in 2022. We also discuss New York state's new climate initiatives, and what kind of impacts will, or could be put in place for the BPU. Leathers says customers will pay for the state's initiatives through their local billing. He adds that the BPU will also host a Clean Energy-related summit this coming October.

- Feb. 28 - The multi-year effort to build the new Star Hospice House in the village of Lakewood is high-lighted on this week's program. Our Terry Frank spoke with Chautauqua Hospice and Palliative Care Director of Development, Zach Agatt, about the origins of the decision to construct the house just off the campus of their Lakewood headquarters. The ribbon was recently cut on the Star Hospice House, which will be able to care for up to 200 people. Agatt says they're pleased to have construction completed on the \$2.8-million dollar effort, which took longer than projected due to the COVID-19 Pandemic, and supply chain issues. Agatt says the hospice house will not be open until at least early April, though, because it must pass a New York state inspection first. He thanked their many contractors for the project, along with donors, and Co-Chairpersons Dr. Bert and Mary Rappole.

March of 2022...

- Mar. 6 -- Our Terry Frank discusses a number of topics with Chautauqua Co. Executive P.J. Wendel this week, including the fact we may be reaching the point of the COVID-19 pandemic entering the "endemic" phase. Case numbers for the past week were down to 139 new cases, and only 8 people were hospitalized with the virus, or COVID-related illness. Wendel says that's very good news, but, adds now is the time for local, state and national leaders to take a hard look at our battered health care systems after two years of the pandemic. We also talk about the need to move ahead in dealing with some of the aftermath, including the opioid epidemic, which got worse during the pandemic. We discuss the opening of a new drug addiction treatment facility in the city of Dunkirk that will use prescribed therapies to help people get off addictive narcotics. We also discuss highlights from Wendel's recent State of the County Address, delivered late last month, to the county legislature and general public.

- Mar. 13 - This week, our Terry Frank hosts the program's monthly visit with Jamestown Mayor Eddie Sundquist to discuss a number of topics, namely a community meeting on the westside Monday night (3/14). It's to review preliminary plans for the redesign of West Third St. from Hall Avenue to Hallock St. Sundquist says the project will involve replacing about three dozen oak trees that had to be taken down after being found to be old, and in some cases, diseased. He says they're looking to replace the sidewalks there, bury some utility lines, and put in a couple of varieties of trees to replace the oaks. We also discuss the start of a New York state DOT project to reconfigure the four-lane portion of Washington St. from downtown to Fluvanna Avenue. The project will involve reducing traffic to two-lanes with a middle turning lane, as well as bike lanes. Sundquist says the project also includes some water main replacements by the Board

of Public Utilities. That project begins today (3/14), and will last through the Summer. We also discuss the latest use of American Rescue Plan Act funding, which council will vote on later this month.

- Mar. 20 - This week we air a large portion of an interview our Dennis Webster and Russ Diethrick had on Media One station WJTN this past week with Robert H. Jackson Center Founder, Greg Peterson, who had just returned from a conference in Minnesota about World War II and it's aftermath. There was also a lot of discussion about the current situation with Russia's month-old war and conflict in Ukraine. Peterson says there are a lot of parallels between what happened when late Justice Robert H. Jackson was named Chief Prosecutor for the Nuremburg War Crimes Trial following World War II. Many have decried current Russian President Vladimir Putin as a war criminal due to the attacks on civilians and other non-military places in Ukraine. Peterson also reveals a story about interviewing the former defense attorney for Rudolph Hess at Nuremburg. The attorney noted that he actually met Jackson at the U.S. Supreme Court in Washington in 1952, and he and Jackson spent the day visiting, and riding horses at Jackson's home in Virginia.

- Mar. 27 - A member of the Jamestown community who often speaks on energy issues, and is a former District Heat Manager for the Jamestown Board of Public Utilities, is our Terry Frank's guest this week. He talks with Doug Champ about the many changes that are coming to energy, and the way it's produced in New York state, as well as the U.S. in general. Champ believes the state is not going to be ready for initial changes to renewables by 2030, or thereafter. He says renewables definately have their positives, but, also have negatives. He says solar takes advantage of "free energy" from the sun. However, he says it's only able to draw power during day-light hours. In addition, he says solar requires huge arrays to be able to power any more than a few hundred homes. Champ also says wind has it's drawbacks, but, the state is pushing ahead. Electric storage from both is also an issue right now. He adds there are now three charges showing up on resident's electric bill that are going towards paying for the conversion. They are REC (renewable energy costs), ZEC (zero emission charges), and ORIC for wind energy. We also talk about the fact that hydropower is not part of the state's future plans.
