

New Age Media of Gainesville License, LLC hereby responds to the FCC's February 8, 2017, EEO Audit letter directed to the above-referenced television station. The station's employment unit currently has only 2 (two) permanent full-time employees. Accordingly, the station is not required by the FCC's rules to have an EEO recruitment program. The employment unit's full-time employees are an IT Engineer, who is regularly scheduled to work 40 hours per week and a Programming & Promotions Coordinator, who is regularly scheduled to work 40 hours per week.

The employment unit is not aware of any pending or resolved complaints filed during the current license term before any body having competent jurisdiction under federal, state, or local law alleging unlawful discrimination in the employment practices of the employment unit on the basis of race, color, religion, national origin, or sex. WGFL is not subject to a time brokerage agreement.
