# Ascertainment Issues 2nd Quarter 2008

The following is a description of what KSTW Television has determined to be the most significant issues facing our local communities. This list reflects ongoing topics, as well as a brief list of other issues presented by citizens and community leaders:

## Violence and Crime

Teen violence, gun violence, juvenile crime and domestic violence are areas of increasing concern. There is a need to establish safer communities through education, advocacy and youth leadership programs. Policy makers need to identify a long-term, dedicated funding source for human services programs. Communities need to improve access to information and services for teens and provide safe places for children and youth during out-of-school hours. Media needs to promote programs designed to train children how to handle violence.

## **Child Abuse and Neglect**

Child abuse and child neglect are areas of increasing concern. Social isolation is the number one factor of child abuse. Parental support and group parent interaction are key issues. Communities need to provide programs that enable parents of infants and young children to meet the challenges of parenting through mutual support and shared information. New moms need access to parenting resources and tools. Teen pregnancy is a growing concern. 66% of teen parents in Washington have been sexually abused and 60% of homeless youth have experienced physical or sexual abuse. Programs that help abused, neglected or poverty-stricken children attain self-esteem and confidence (i.e. Treehouse) need media attention and awareness.

## **Homelessness and Housing**

There is a critical need for emergency, transitional and low-income housing in our community. Every family needs a safe, stable home base to achieve success; it is especially important for children. Homeless and runaway youth need tools for self-sufficiency, access to basic survival skills, HIV education, referrals to shelters and access to public transportation and health clinics. Programs helping families move from temporary housing to permanent housing need media attention. Due to illness, aging, inflation, or any number of uncontrollable causes, many older homeowners are not able to provide repair work, resulting in unsafe living conditions. Volunteers and media sponsors are needed to staff housing project campaigns such as Habitat for Humanity.

## **Education**

Quality education, early education and after-school tutoring programs are areas of growing concerns. There is a need for parent involvement in schools. Media needs to promote the academic success of children and youth through mentoring and tutoring programs. Media needs to promote the academic success of at-risk and low-achieving

students, particularly in the area of literacy. After-school community programs that help kids succeed in school and prepare for life need community awareness. There is a critical need for one-to-one mentors for students in elementary and middle schools. Schools need to develop new resources and community leadership programs to help children achieve at a higher level and assure the achievement of every child.

## **Health Care**

Issues surrounding quality and affordable health care are an increasing concern. Seniors (over 65 years of age) need reasonable, reliable and affordable health care services. Persons with disabilities need assistance with medical limitations, restrictions and boundaries. Funding long-term health care problems need media attention. Non-profit agencies providing basic health care need fundraising and community support. Long-term care resources need to be made accessible to persons with limitations and disabilities.

## <u>Traffic</u>

There is a need for better traffic flow, timed lights in the city and improved general efficiency on highways. Ongoing construction projects need media support. Traffic is the number one delay factor in emergency response times. Media need to educate drivers to move to the right for emergency vehicles, sirens and lights. Cell phone laws and regulations need to be enacted.

Hosted by KOMO-TV, the following speakers participated in the meeting: **Brian Wilson, Chief of Police, Federal Way Police Department.** Brian reported that identify theft and fraud have become a rapidly increasing problem and that out of area residents cause/create crime due to transit centers. Jail capacity in So. King County has become an issue as well as language issues with foreign students infiltrating the area.

Elaine Jones, Chief Operations Officer, Allen Institute for Brain Science. The Seattle-based institute was founded in 2003 with \$100 million in seed money from philanthropist Paul G. Allen. The institute takes on projects at the leading edge of science at the intersection of biology and technology. The goals of the institute are to create projects that have a high-impact in the fields of neuroscience and genomics, provide free databases and tools for researchers worldwide and continue to pursue public/private partnerships for funding projects.

Fianna Dickson, PR Director, Hope Heart Institute. Founded in 1959 by world-renowned cardiac surgeon Lester Sauvage and named for legendary entertainer and benefactor Bob Hope, the institute is committed to serving humanity through cardiovascular research and education.

Daniel Perez, Outreach/Intake Legal Advocate, NW Immigrants Rights Project (NWIRP). NWIRP is the only organization in Washington

state dedicated solely to strengthening the rights and well being of low-income immigrants and refugees. Through its legal services, NWIRP helps promote basic human rights, preserve family unity, prevent persecution, protect children and provide hope for justice.

<u>Sandy Jeghers, SightLife.</u> Founded from humble beginnings, SightLife has grown into one of the leading eye banks in the world, ending blindness for nearly 3,000 people around the world each year.

Edith Elion, Atlantic Street Center. Originally founded in 1910 as a Settlement House for the large number of Italian immigrants relocating to Seattle's Rainier Valley. In the mid 1950s the Settlement changed its name to Seattle Atlantic Street Center and hired staff with experience in social services and began providing educational, recreational and counseling services to people of color. Edith expressed concern that the media portrays people of color in a negative light and should attempt to highlight achievements for a more balanced perception.

Ken West, Metropolitan Seattle Sickle Cell Task Force/Northwest Sickle Cell Collaborative. Making life better for families with sickle cell disease and trait, the Northwest Sickle Cell Collaborative is a statewide network of care providers and community organizations who are working together to offer comprehensive, up-to-date resources through access to Washington state's most dedicated sickle cell specialists — physicians, nurses, social workers, genetic counselors and more; opportunities to learn about new ways to prevent and manage pain, to work with teachers and schools and to otherwise support your child's health, growth and development; social activities and the chance to meet and learn from other families who are living with sickle cell disease and regular updates on the latest research, community activities and other resources.

Michelle Majors, Development Coordinator, Dress For Success. Celebrating its 10<sup>th</sup> anniversary in 2008, Dress For Success continues to provide business attire and career development services to local women in need. Dress For Success has helped thousands of Seattle women overcome obstacles to find employment and advance their careers.

Jone Bosworth, Director, Washington State Department of Early Learning (DEL). The DEL was created in 2006 to strengthen our state's focus on early learning. DEL's mission is to create a statewide early learning system that prepares all children for kindergarten by working with Washington's 5,400 licensed family home providers and 2,000 licensed child care centers to ensure health and safety standards are met; funding the state preschool program for low-income families; setting policy for the Working Connections child care subsidy program and giving parents an unprecedented voice in statewide policy, funding and hiring decisions.

Betsy McFeely, PR Director, Goodwill. Goodwill provides quality, effective employment training and basic education to low-income individuals with significant barriers to economic opportunity. With 16 retail stores, 9 job centers for training and 1,200 employees, Goodwill relies on the re-sale of donated items as a source of revenue as well as financial contributions.

Lummi Tribal member Chenoa Egawa hosts the program from the Yakama Nation in south central Washington. Spanning over 1.4 million acres and with nearly 10,000 tribal members, Yakama Nation has the largest reservation and is the most populous Tribe in the northwestern United States. In segment one, the tiny reservation of the Quileute Tribe located on the shores of Washington's Pacific coastline, is taking bold measures to protect Tribal members and the community of La Push against the threat of Tsunamis. Segment two features the Pendleton Woolen Mills which for more than 100 years has been making premium quality wool blankets with Native artwork and designs as well as wool clothing and other products. The "Around Indian Country" segment contained brief summary reports on the following topics: The Tulalip Hibulb Museum Groundbreaking; Cowlitz Casino Public Meeting; Squaxin Museum Exhibit: Wood, Paper, Glass and Sequim Elk Herds. The program close featured two Yakama Elders who talked about their youth in their native Yakama language.

Segment three covers the preparation for the Canoe Journey 2006 as a group of Native youth are carving a seagoing canoe so that they will be able to participate in the event this year on nearby Lake Washington. The program close features the Muckleshoot Canoe Family as they practice their Tribal songs and dances in preparation for hosting the upcoming Canoe Journey 2006.
