**PKG: 1:55** United States president, George Bush went over his \$7.1 billion plan today to battle the possible pandemic of the bird flu in the U.S. Part of Bush's plan is to have sufficient vaccine for 20 million Americans against the disease, stockpile medication to lessen the symptoms and assist state and local governments with preparation against this possible tragedy.

There is no telling when and even if the U.S. will be faced with the bird flu which began in Asia and has already spread through Europe. Preparation is the key in this situation especially because time is relatively available. The strategy Bush has created is to better access the technologies to quickly create a vaccine against the bird flu and immunize every American against the disease.

It was a case believed only by one juror. Merck has beat back a lawsuit filed by a New Jersey man who claimed the Vioxx painkiller was responsible for his heart attack. A jury found that Merck properly warned consumers about Vioxx's

risks and isn't liable for Mike Humeston's heart attack in 2001. Just one juror said Merck didn't give enough warnings to doctors about Vioxx's link to increased heart problems. But another juror said stress and Humeston's other medical problems were to blame -- saying his medical records "were

riddled" with other medications. It's the first win for Merck in a case involving Vioxx, after it lost one in Texas. The drugmaker faces thousands of similar suits.

## STEROIDS GAO

According to a congressional report, the Internet is making it easy for teens to get steroids. The Government Accountability Office says anybody with a computer and an e-mail address can get anabolic steroids. Investigators found hundreds of Web sites offering anabolic steroids, and received shipments from outside the U.S after placing several online orders. Rep. Tom Davis released the findings of the report today on Capitol Hill. It was Davis' committee that called athletes to testify about steroid use in professional sports.

## ILLEGAL IMMIGRANTS CONFERENCE

The Southwest Conference on Illegal Immigration, Border Security and Crime will be held at the Scottsdale Resort and Conference Center in Scottsdale from November 4 through November 5. The conference, Thomas said, will be "perhaps the nation's most comprehensive public-policy forum to date devoted to America's illegal immigration crisis.", this event will be open to the public and the press, and will feature

## LOWEST POLL NUMBERS FOR BUSH

President Bush's public support has eroded to its lowest level yet, with the Iraq war dragging on, a top White House aide facing felony charges and the White House rushing to replace a failed Supreme Court nominee. Concerned that the president has lost his footing, some Republicans have suggested Bush should shake up his staff. A new AP-Ipsos poll found the president's approval rating was at 37 percent, compared with 39 percent a month ago. About 59 percent of those surveyed said they disapproved. the intensity of disapproval is the strongest to date, with 42

percent now saying they "strongly disapprove" of how Bush is handling his job -- twice as many as the 20 percent who said they "strongly approve."

## CUTS MEDICARE & MEDICAID

A battle over cuts to popular federal programs like Medicaid and food stamps promises to intensify next week in the House despite relatively smooth sailing in the Senate. A measure the Senate passed Thursday calls for mild cuts in the health care programs for the elderly, poor and disabled, while leaving the food stamp program untouched. A House plan approved by a key committee Thursday cuts more deeply across a broader range of social programs. Republican moderates who don't like the cuts say it makes even less sense to vote on them if it's clear the Senate won't go along. To ease passage next week, House GOP leaders may drop a provision that would allow drilling in Alaska's Arctic National Wildlife Refuge, with the intention of revisiting it in final compromise talks with the Senate.

employees when he walked out of the Harris County Jail on Thursday. Thompson was condemned in 1999 for the shooting deaths a year

earlier of Hayslip, 39, and Darren Keith Cain, 30. The Texas Court of Criminal Appeals ordered he be resentenced and on Oct. 28 a new

jury again recommended the death penalty. Thompson was being held in the county jail pending his transfer back to prison. On Thursday, Thompson claimed he had an appointment with his lawyer and was taken to a meeting room. However, the visitor was not Thompson's attorney. Martin said investigators were questioning the visitor but wouldn't give details.

## KATRINA POWER

The bankrupt utility that supplies power and gas to New Orleans has not set a timetable for restoring service to the city's storm-ravaged eastern

neighborhoods and the Lower Ninth Ward, the company's chief executive told an angry crowd of residents Saturday. Entergy New Orleans, a subsidiary of Entergy Corp., needs a \$450 million federal bailout to replace equipment destroyed by Hurricane Katrina and finance operations over the next year, Chief Executive Dan Packer said. Entergy has restored electric service to only about 24 percent of its pre-storm levels in New Orleans and is having to repair and replace more than half of its substations after they were swamped with flood water, he said.

## MIDWEST KILLING TORNADOES

Steps lead to nowhere. Concrete foundations stand bare. Stop signs bend parallel to the ground. But right next to obliterated houses stands a home barely touched. Such is the tangled aftermath of a tornado that killed at least 22 people early Sunday as it followed an erratic path across the countryside of western Kentucky and southwestern Indiana. With winds of at least 150 mph, the storm inflicted its worst damage on the Eastbrook Mobile Home Park in Evansville, where splintered trees were filled with a tangled mess of insulation and aluminum siding.

## PLANE CRASH HOUSTON

For the second time in two days, a plane has crashed near a Houston airport. A plane has reportedly crashed, hitting a car on Spring Stuebner near Highway 290. The accident is close to Hooks Airport in northwest Harris County. Witnesses say the plane clipped some power lines, and then skipped off the top of a vehicle. The small plane then ended up in some woods next to Hooks Airport. Both the plane and the car are reportedly on fire.

Sheriff's deputies have closed the roads to traffic. Two people have reportedly been killed. Officials are saying the victims were a male adult and a child. One female from inside the car was transported to Woodlands Memorial with minor injuries.

## HONDURAN MURDER

The Supreme Court agreed Monday to consider the appeal of a Honduran national convicted of killing a Virginia teen with a baseball bat. The man was never told of his right to seek legal help from the Honduran consulate, and his new lawyers are trying to win another trial. The court is jumping back into the issue of the rights of foreigners who face criminal charges. Justices considered another case involving a Mexican national on death row in Texas, but dismissed the case without a ruling in May after President Bush ordered a new state court hearing for the man.

Under the Vienna Convention, foreigners arrested in the United States are to be told they have a right to get help from their home country. Americans are entitled to the same rights in other countries that signed the treaty. In the Virginia case, Mario Bustillo is serving a 30-year prison

sentence in the 1997 slaying of 18-year-old James Merry outside a Popeyes Restaurant in Springfield, Va.

## SCOTUS-GUANTANAMO

The Supreme Court is giving no free passes to the commander in chief. Pressed by the Bush administration to stay out of a wartime powers case, the court jumped in anyway. The justices will decide if the president overstepped his authority by ordering military tribunals for terror suspects held at Guantanamo Bay, Cuba, resurrecting a type of trial last used during World War II. The case the justices will hear next spring involves Osama bin Laden's former driver.

## CUBAN MIGRANT DEATH

A speedboat carrying 37 suspected migrants capsized off Key West, killing two Cuban women whose bodies were found trapped under the boat, the U.S. Coast Guard said Sunday. After the boat was spotted Saturday, a Coast Guard rescue boat was sent out and took about 15 people off the speedboat, leaving life jackets for the rest. It was returning for the others when the speedboat capsized, Petty Officer Dana Warr said. Twenty-two people were dumped in the water. All but the two women found under the boat with lifejackets on were rescued and taken to a Coast Guard cutter. One suspected smuggler was among the group, Warr said. The Bureau of Immigration and Customs Enforcement was investigating.

## CYBER-SUICIDE

A bubbly 19-year-old with loving parents and good friends, she was also a strong student and earned a science scholarship for college.

But everything changed one spring day two years ago. Alone in a Florida hotel room, just miles from her college apartment, Suzanne methodically prepared and swallowed a 4 In doing so, she joined the roughly 4,000 people between the ages of 15 and 24 who commit suicide each year, according to the Centers for Disease Control and Prevention. Suicide is now the third leading cause of death among young people, the CDC reports. But Suzanne's case has an unusual twist. She frequented an Internet newsgroup called called ASH, short for Alt.Suicide.Holiday. Members of this news group trade advice on how to commit suicide, using code words like 'transitioning' and 'exiting' and 'catching the bus.' Suzanne found this group nine weeks before she died, posting nearly one hundred messages detailing her plans. Suzanne's dad believes one of those messages taught her how to illegally obtain and use cyanide to end her life. And he was horrified to learn that an older ASH member who goes by the alias "River" may have helped her.

President Bush explains his decision to invade Iraq during a speech today in Pennsylvania. It comes as a new A-P-Ipsos poll indicates nearly six in ten Americans don't think he's honest. The same number also don't think his administration has high ethical standards. President Bush charged Friday that Democratic critics of the Iraq war were trying to rewrite history by accusing the White House of manipulating intelligence to gain support for the war. Bush, in a Veterans Day speech at an Army depot, fired back at Democrats who have been escalating accusations that Bush misused intelligence to justify an increasingly unpopular war. Bush said he respected his opponents' right to disagree with him about the decision to go to war against Iraq and that as president he accepted responsibility for what has taken place there under his watch. But, he added, "It is deeply irresponsible to rewrite the history of how that war began." Bush also opened fire at one critic in particular,

Massachusetts Democratic Sen. John Kerry, whom Bush defeated in the presidential election a year ago.

## **WARNING ISSUED FOR BIRTH-CONTROL PATCH**

The makers of a popular birth-control patch warned millions of women Thursday that the patch exposes them to significantly higher doses of hormones and may put them at greater risk for blood clots and other serious side effects than previously disclosed. New studies show that women absorb about 50% more estrogen with the Ortho Evra patch than with the pill. AFP file photo The warning from Johnson and Johnson subsidiary Ortho McNeil, makers of Ortho Evra, says women using the patch will be exposed to about 60% more estrogen than those using typical birth-control pills because hormones from patches get into the bloodstream and are removed from the body differently than those from pills. Thursday's warning comes four months after The Associated Press reported that patch users die and suffer blood clots at a rate three times higher than women taking the pill.

#### **NEW YORK FLIGHT MEMORIAL**

Scores of families gathered in a seaside neighborhood Saturday to observe the fourth anniversary of one of the nation's deadliest airline disasters. The crash of American Airlines Flight 587 on a quiet residential block in the Belle Harbor section of Queens killed 265 people --

When Leptin stops working weight gain occurs. Experts conducted a study on rats using a compound called Vanadium. This compound increased the Leptin system to burn more calories

**NY SUBWAY ARREST****VO:**

Starting tomorrow, some New York subway riders won't just be getting their bags searched. They also might be getting them swabbed. The city is trotting out a new anti-terrorism tool designed to detect traces of explosives. Instead of searching inside a bag, officers will swab the outside.

A New York police spokesman says the method is fast and less intrusive. Results are ready in a few seconds.

**MIDWEST STORMS**

Nearly three dozen tornadoes ripped through the Midwest, part of a huge line of thunderstorms that destroyed homes and killed at least two people. Meteorologists said a cold front moving rapidly east collided with warm, unstable air from the south on Tuesday to produce the thunderstorms that stretched from the Gulf of Mexico to the Great Lakes, spawning funnel clouds and tornadoes in parts of Missouri, Kentucky, Indiana, Illinois and Tennessee.

**SENATE APPROVES PENSION OVERHAUL PLAN**

Hoping to reverse the deterioration of pension plans covering 44 million Americans, the Senate voted Wednesday to force companies to make up underfunding estimated at \$450 billion and live up to promises made to employees.

The action came a day after the federal agency that insures such plans reported massive liabilities and predicted a troubled future.

**SAN FRANCISCO REQUIRES PIT BULL STERILIZATION**

San Francisco's city legislature approved a measure Tuesday requiring all pit bulls to be sterilized.

The measure, passed 10-0 by the city's Board of Supervisors, sets fines of up to \$1,000 for owners who fail to spay or neuter their pit bulls, although some exceptions apply.
